# Introduction

A safe environment on college campuses for all students enhances opportunities to learn and grow. Despite ongoing efforts to curb sexual violence on college campuses, sexual violence remains a public health issue for college students. Students who experience sexual violence are at higher risk of mental health issues such as depression, anxiety, and non-suicidal self-injuries.

Minnesota's postsecondary institutions strive to provide students a safe environment to complete educational and employment goals. It is widely understood that people between the ages of 18 to 24 are more likely to experience sexual violence and sexual assault (College Student Health Survey Report, 2021); and individuals in specific underrepresented groups such as American Indian and LGBTQ+ are at even greater risk for perpetration (Krebs et al., 2016). Colleges, universities, and other postsecondary institutions are aware of the impact of sexual violence and sexual assault on a student's retention, credential attainment goals, and overall campus culture.

The Sexual Violence Prevention and Response program at the Minnesota Office of Higher Education currently supports 76 institutions across the state in sexual violence prevention and response initiatives at the campus level by providing training opportunities to meet state statute obligations under 135A.15. Moreover, the Office provides consistent communication on the current federal and state landscape on sexual violence prevention and response that impact institutions and builds relationships among postsecondary institutions, state agencies, and community-based institutions.

In 2022, the Office's Title IX Training Administrator surveyed the needs of institutions and reinvigorated key community partners such as the Minnesota Coalition Against Sexual Assault (MNCASA) and Violence Free Minnesota. The Title IX Training Administrator also collaborated with state agencies such as the Minnesota Department of Health, connected with the newly established Missing and Murdered Indigenous Relatives Office. Fifteen training opportunities to institutions were offered on topics such as the Title IX Notice of Proposed Rulemaking, restorative justice, intimate partner violence screening practices, identifying strangulation, and the intersection of state and federal laws. Networks for both new Title IX coordinators and deputies, and prevention specialists met regularly to support each other in their work and discussed best practices, and campus innovations to end sexual violence in campus communities.

The Office of Higher Education is required by the Minnesota Legislature to publish the Sexual Assault Data Report, which includes information regarding the outcomes of sexual assault incidents reported to postsecondary institutions. The Minnesota Legislature (Minn. Stat. 135A.15) mandated this report beginning in fiscal year 2016 (data for the calendar year 2015) which requires eligible postsecondary institutions to report sexual assault incidents and the outcomes of institutional investigations, if applicable. ### **Key Takeaways**

- Since calendar year 2015, postsecondary institutions have received a combined 2,947 reports pertaining to
  alleged sexual assault incidents. The number of sexual assault incident reports had steadily increased prior
  to 2020. However, the number of incidences reported decreased between 2020 and 2021, due to the
  COVID-19 pandemic and the shift to remote learning. As college campuses have reopened, incidence reports
  have increased compared to report year 2021.
- In calendar year 2022, a total of 316 incidents were reported to institutions. The number of incidents decreased slightly between calendar year 2021 and 2022. About 21.8% of total incidents were reported through an electronic reporting system. Institutions reported that 25% (79) of the 316 incidents reported were investigated in 2022. Since 2016, 38% of sexual assault incidents reported to postsecondary institutions have been investigated.
- In report year 2023 (calendar year 2022), 13.6% of sexual assault incidents reported to postsecondary institutions were also reported to law enforcement, according to the best information available to the institution; this rate is lower than the average from report years 2016 to 2023 (16.1%).
- The number one reason reported by institutions for an institutional investigation not being opened is that the complainant chose not to participate in the disciplinary process. This was the case for 41.2% (1,215 out of 2,947) of cumulative incidents from the report years 2017-2023. Complainants sometimes elect this route to receive supportive measures without undergoing a Title IX investigation (note: the outcome *Victim Did Not Participate Pre-Disciplinary Process* was added to the report in 2017, and therefore; 2016 data is unavailable for this calculation).

# **Required Data**

Postsecondary institutions are required to submit sexual assault data if they:

- Offer in-person courses on a campus located in Minnesota;
- Are eligible for state student financial aid, as defined in Minn. Stat. § 136A.103<sup>1</sup>; and,

Have enrollment of 100 students or greater in the prior academic year.

Data reported by institutions must include, but are not limited to, the number of incidents of sexual assault reported to the institution in the previous calendar year in which:

- Either the complainant or respondent was a member of the campus community (e.g., employee or student) at the time of the incident;
- The incident occurred on the institution's campus (or on property owned/rented by the institution) or the incident occurred at an institutionally sponsored event.

### **Data Privacy**

The Minnesota Office of Higher Education adheres to current federal and state data privacy laws and best practices to protect the privacy of individual students. Minn. Stat. § 135A.15, Subd. 6 requires that reports and data are prepared and published as summary data, as defined in Minn. Stat. § 13.02, Subd. 19 and are consistent with federal and state laws governing access to educational data and student privacy.

The Office's policy for complying with federal and state data privacy laws is to suppress student data in cells containing fewer than 10 students. In this report, cells with counts under 10 are suppressed, including zero values, where the number of incidents reported or the number of incidents investigated is greater than zero from which information could be inferred.

### **Sexual Assault Data**

For this report, the Office collected data on the cases of sexual assault that occurred between January 1, 2022 to December 31, 2022 (calendar year 2022, report year 2023), as well as institutional responses and actions taken through September 30, 2023. In 2022, a total of 316 sexual assault incidences were reported to institutions ( see table 1). Among these incidents, 79 (25%) were investigated and 43 cases (13.6%) were reported to law enforcement. About 21.8% of incidents were reported virtually. Among the investigated reports, 50.6% were referred for a disciplinary process at institutions. In 10 cases, a respondent(s) was or were found to be responsible for sexual assault. Less than 10 cases resulted in a disciplinary proceeding without resolution. Of those that closed without resolution, less than 10 cases were closed because the respondent withdrew from the institution. Moreover, less than 10 disciplinary processes were closed because the victim chose not to participate. In 49.4% of total incidents, a complainant chose not to participate in the institution's process prior to a disciplinary process beginning.

#### **Data Trends**

As shown in table 2, postsecondary institutions received a total of 2,947 reports of sexual assault incidents report years between 2016 and 2023. The number of reports of sexual assault incidents steadily increased until 2019. Between 2019 and 2022, the number decreased by 32.4%. In 2022, more incidents were reported as campuses reopened, but the number of incidents dropped slightly in 2023.

Between 2016-2023, 38% (1,120) of the 2,947 incidents of sexual assault reported to postsecondary institutions were investigated. Around 24.3% of total incidents were referred for a disciplinary process at an institution. In the report year 2023, and to the institutions' knowledge, 13.6% of sexual assault incidents reported to postsecondary institutions were also reported to law enforcement; this is in comparison to an average of 16.1% between the years 2016 and 2023.

The number one reason cited by institutions for an institutional investigation not being opened is that the complainant chose not to participate in the disciplinary process, as was the case for 41.2% (1,215) of the 2,947 incidents from report years 2017-2023. Complainants sometimes elect this route to receive supportive measures without undergoing a Title IX investigation. Note: the outcome *Victim Did Not Participate in Pre-Disciplinary Process* was added to the report in 2017, and therefore 2016 data is unavailable for this calculation.

As shown in Table 3, there were 418 cases out of a total of 2,947 incidents where a respondent(s) was found to be responsible for sexual violence between 2016-2023. Among cases that were referred for a disciplinary process, 80 cases were closed without resolution. Around 32.5% of those that closed without resolution were due to a respondent's withdrawal from the institution, and 71.3% of cases resulted in a closure because a victim chose not to participate in the process.

# Memorandum of Understanding with Law Enforcement

Each Sexual Assault Data Survey includes optional questions on notable topics. In 2023, the survey asked institutions about their collaboration with local law enforcement agencies and/or participation in a coordinated community response and protocol team, a provision in Minnesota Statute 135A.15 Subd.4(a). These questions allow OHE to understand strengths and challenges, as well as how to best assist institutions in fulfilling this statutory obligation. All institutions who completed the survey answered one or more of the optional questions:

- Does your institution have a Memorandum of Understanding (MOU) with the primary local law enforcement agency as per statute 135A.15 Subd. 4 (a)?
- When was the last update to the MOU (date needed)?
- Does your institution and primary local law enforcement participate in a Coordinated Community
   Response and Protocol team on campus or within the greater community?
- What barriers or challenges prevent you from entering into a Memorandum of Understanding with primary local law enforcement or participating in a coordinated community response team, on or off campus?

Of the 76 institutions, 59% reported establishing a MOU with primary local law enforcement. About 25% of the institutions were involved in a coordinated community response team. Nine institutions indicated involvement with neither law enforcement via the MOU nor a coordinated sexual assault community response protocol team.

# **Barriers to Pertaining to MOU**

Even though the majority of postsecondary institutions reported positive working relationships with local/primary law enforcement, two primary barriers or challenges were repeatedly reported in this section. Institutional or law enforcement transition or vacancies in positions that typically negotiated an MOU or participated in the protocol team was a primary challenge or barrier mentioned. Moreover, the lack of consistent staff in these important roles led institutions to report they were unaware of this requirement. Despite no formal MOU or organized response team, three institutions reported positive working relationships with local/primary law enforcement.

Institutions that participated in a sexual assault community response protocol team reported the value of such a team but noted that due to the lack of human and financial resources, along with the time-intensive nature of a strong response team makes institutional participation increasingly more difficult. Institutions in a county with a large number of postsecondary institutions or an active sexual assault protocol team, such as Ramsey or Winona County, appreciated the collaborative interagency approach.
