



A Report on the Stewardship and Enforcement Fund Performance Related to Environment and Natural Resources Trust Fund Appropriations

Fiscal Year 2024

Background

As required by M.L. 2011, First Special Session, Chapter 2, Article 3, Section 2, Subdivision 19 and subsequent appropriations, the Minnesota Land Trust must report annually on the performance of its Stewardship and Enforcement Fund to the Legislative-Citizen Commission on Minnesota Resources. Below is a summary of the Fund's finances and activity, including deposits and expenditures related to Environment and Natural Resources Trust Fund (ENRTF) projects. This report covers the Land Trust's Fiscal Year 2024, which is July 1, 2023-June 30, 2024.
