

## INTRODUCTION

The following pages of this annual report cover in considerable detail the operations of the Minnesota State Fair in 1973.



As part of the introduction to the report, I would like to reflect on the use of State Fair facilities at periods of time other than during the annual Fair itself. Many persons share the mistaken impression that the Fairgrounds stand idle and are not used the balance of the year. In recent years, the Board and management of the Fair have made a concerted effort to expand year-around use of the grounds and its buildings. As a result, the State Fair now hosts more visitors in the course of a year than any other facility in the Upper Midwest.

In 1963, just 10 years ago, a total of 23 off-season events were conducted on the Fairgrounds. These events, attended by approximately 150,000 persons, involved 51 usage days. (The "usage days" figure is arrived at by combining the duration of all events.) By contrast, in 1973, a total of 66 events were held on the grounds, attracting some 560,000 persons and involving 582 usage days. As a result, the Society realized additional gross income of nearly \$195,000 from off-season events this past year as compared to \$35,000 in 1963. In 10 years, we have been able to increase the number of events as well as the number of persons using the facilities by some 300 per cent, gross off-season income has increased by close to 600 per cent, and the number of usage days has risen by more than 1,000 per cent.

It is our intention to continue to increase off-season use of Fairgrounds facilities. Evidence of this is the fact that presently on the drawing board are plans for a heating plant which will make the Hippodrome available for year-around use. As with many aspects of life today, however, the complete development of these plans will be dependent to a large measure on the resolution of the current energy crisis. Additional information on the off-season use of the Fairgrounds and a complete list of 1973 events may be found on pages 22 and 23.

This report would not be complete if I did not acknowledge and give full credit and recognition to the many volunteer workers, the various department superintendents and their staffs, the loyal and hard-working permanent staff and the Board of Managers, all of whom worked together to stage and produce what is considered the finest state fair in America. No organization anywhere is blessed with a finer group of individuals and to these fine, dedicated people go my sincere thanks.

# 1973 Minnesota Get-Together

## WHERE MANY GREAT THINGS HAPPENED

Hot, humid weather failed to discourage the 1,265,121 persons who made the 1973 Minnesota State Fair one of the most successful in the 112-year history of the event. Final admission count of 1,440,330 includes 175,209 vehicles and is the third highest total ever. Rainfall totaled only .51 inches during the Fair but it came on seven of the 11 days and often at times probably discouraging additional people from attending.

Although high temperatures sometimes forced enthusiastic Fair-goers to maintain a leisurely pace, the exposition again lived up to its advance billing as the world's greatest state fair and the Upper Midwest's largest entertainment spectacle.

Preparation Day for the 1973 Fair was August 23; 50¢ admission was charged starting at 8 a.m. Officials, exhibitors, concessionaires and their employees labored to tie all loose ends together in anticipation of the official opening, Friday, August 24. This was the second year the Minnesota Fair has opened on Friday and continued 11 days through Labor Day. It proved a successful commencement as a daily high admission total was recorded.

Opening day was also Children Day (as was the second Friday, August 31) and close to 35,000 young persons attended the Fair on one of their final pre-school holidays. In all, 370,853 children attended the 1973 exposition. For admission purposes, the Fair classifies anyone under 16 years of age as a child.

Ordinarily, youngsters paid 50¢ at the outside gates if they were five to 15 years old, while there was no charge for those under five years of age. Adult admission was \$1.50 in 1973 as it has been since 1970. Vehicle parking was also \$1.50.

Exceptions to the outside gate admission schedule were made on Children Days and Senior Citizens Day. Persons under 16 years of age were not charged an admission fee before 6 p.m. on the two Children Days and anyone 65 years or older was admitted free of charge until 6 p.m. on Senior Citizens Day. Otherwise, everyone seeking entrance to the Fairgrounds was required to present an admission ticket. Employees, officials, exhibitors, entertainers, as well as visitors, were charged without discrimination.

A vast array of entertainment was found in every corner of the 300-acre Fairgrounds in 1973. Musical stage presentations, commercial exhibits, educational demonstrations, livestock competition, handwork displays, thrilling rides, typical State Fair food and all the other traditional attractions combined once again to make the Fair a completely unique experience.

Along with old favorites, the 1973 pageant offered much that was new and different. An amateur talent contest, two new exhibit buildings, a revamped racing program, new areas of public competition and several major first-time commercial exhibitors were part of the continuing process of upgrading the Fair's appeal.

Special entertainment at an additional charge was scheduled for those who were interested. Seven different shows were on the announced evening Grandstand schedule (although there was a cancellation) and competition involving six different types of racing machines was the afternoon attraction. In the Hippodrome, horse shows and rodeos were the special interest events while Young America was operated for those who came to the Fair to hear rock music.

Saturday and Sunday crowds typically were heavier than on weekdays.

Officials continue to encourage the public to take advantage of less congestion by attending the Fair on weekdays.

The 1973 State Fair might be characterized in terms such as "hot and humid," but it also should be described as clean, orderly and trouble-free. Its 1,265,121 visitors are to be commended for the effort they made to assist each other in enjoying the year's extravaganza.

On the final day of the '73 exposition, Labor Day, September 3, the Board of Managers of the State Fair, already looking forward to 1974, set August 23 through September 2 as the official dates for the next Minnesota State Fair.

## CONCESSIONS AND EXHIBITS

Leasing of commercial space is an important mainstay in the operation of the Minnesota State Fair. A large complement of exhibitors and concessionaires insures that Fairgoers will have a wide variety of products to examine and compare as well as making certain that their desires for food, drink, rides and souvenirs will be satisfied. In addition, fees paid by enterprises doing business at the Fair are an essential part of the income necessary for the exposition to keep admission charges at a low level while providing high quality entertainment, competition and attractions.

Income from Fair-period rental of space in 1973 was \$874,388. This figure is approximately 27 per cent of last year's total operating income.

The 1973 Fair licensed some 1,000 companies to conduct business on the grounds during the 11-day exposition. As in past years, between 75 and 80-per cent of these were lessees returning from the prior State Fair. While some enterprises, such as the Royal American Shows carnival, Space Needle and sale of beer, were charged based on a percentage of the business they did, most space was contracted for on a front-foot basis. Charges varied depending on location, amount of space used and whether space was situated inside a building or outdoors, but an approximate average was \$20 to \$25 per front-foot.

First step in securing a space contract at the Minnesota State Fair is to make application with the Space Rental Department. Generally, persons who held a contract for space at the last Fair are given the first option to renew their lease for the same space. New applicants are considered for remaining space and for newly established locations. An attempt is made each year to maintain a diversity of products and exhibits. For the benefit of the public, as well as for the protection of the Fair's interest in the concerns it licenses, the specific nature of business to be conducted is spelled out in each contract as is the exact location of the operation.

In 1973, new exhibitors included Anheuser-Busch, Inc., Foreman and Clark, Wausau Homes, Inc. and the Marlboro Chuckwagon. Two new exhibit facilities, the Merchandise Mart and Home Improvement Building, were opened for the '73 Fair. These two structures, along with the Modern Living Building (formerly Electri-City) were named in a public contest.

The 1973 exposition also marked the return of the world's largest farm, yard and recreational equipment show to 80-acre Machinery Hill. It also was the 39th time since 1933 that Royal American Shows has played the Minnesota State Fair.

## MEDIA AND THE STATE FAIR

The relationship between radio and television stations, newspapers and other publications, and the Minnesota State Fair has several significant aspects. Of primary importance, the Fair, which brings into common involvement well over one million persons, is a source of news, feature and program material for the media.

Available material includes news of scheduled events, attendance figures, interviews and other stories generated because of the concentration of so many people. Because this material is quickly and comprehensively disseminated by media throughout the Upper Midwest, most potential visitors are well informed about happenings at the Fairgrounds.

A test of the speed with which news from the State Fair is spread occurred in 1973, when illness caused Engelbert Humperdinck to cancel his scheduled State Fair concerts with approximately 24 hours notice. Although thousands of persons held tickets for the shows, only two parties informed Fair officials that they had not heard of the cancellation.

Another side of the Fair and media relationship is the willingness of stations and publications to take part in the Fair as exhibitors. Radio stations operating at the 1973 Minnesota State Fair included KDWB, WCCO, KSTP, WWTC, the State College System and WDGX. Emanating from the Fairgrounds were telecasts by KMSP-TV, WCCO-TV, KSTP-TV, WTCN-TV and KTCA-TV. Staffs of the Minneapolis Star and Tribune, St. Paul Dispatch and Pioneer Press and Farmer magazine maintained information centers at the Fair and provided day-by-day coverage of newsworthy events.

Thousands of persons took advantage of the presence of the media on the grounds by watching or taking part in shows, chatting with their favorite personalities or collecting one of the free souvenirs provided by some of the outlets.

Media support is an important ingredient in the success of the exposition. As in the past, this support is gratefully acknowledged by management of the State Fair.

## **THE FAIR WAS A BUSY, FASCINATING PLACE**

Everywhere one turned during the 1973 State Fair, something interesting was taking place. Bands, shows, demonstrations, recognition programs, celebrities and absorbing displays were all part of the intriguing world to be found inside the gates of the Minnesota Fairgrounds.

With no expense in addition to the outside gate admission charge, it was possible for Fairgoers to keep themselves entertained for hours. Although it is not practical to catalog all the special events which took place during the '73 Fair, mentioning several will demonstrate the scope and diversity of State Fair activity.

One of the most impressive entertainment areas was the Bandshell in Administration Park. Starting at 10 a.m. daily and continuing through 8 p.m., outstanding acts performed on the Bandshell stage. Featured groups included Little Angels of Korea, Jack D' Johns, Primo People, The Musical Harts, Don Cavitt's Sounds of the 30's and 40's, Benny Dixon and the Rebels, Just Two Plus One and The Gentlemen of Dixie.

When the regular schedule ended at the Bandshell, one of the year's most popular new programs got under way. The first annual Minnesota State Fair Amateur Talent Contest was a nightly attraction in Administration Park. Winner of the contest was Kithara, a jazz-rock band from Bloomington.

Free shows, concerts and demonstrations were the rule rather than the exception elsewhere on the grounds as well. On the schedule for Baldwin Hall in the Education Building were the Rex Accordion Band, International Institute Folk Dancers, Jimmy Lee and the Lee Sisters, Star Promenaders and Junior Lost Corners, Tom Bednarz, Reedy Family, David Dance Studio, high school bands and choruses and judo demonstrations. Jan Biley again was featured in the Creative Activities Building and Ted Johnson performed in the Hippodrome exhibit area.

Mexican Village presented hourly free shows from noon through 9 p.m.

each day of the Fair while Holter's popular wild animal circus paid another successful visit to the Fairgrounds.

The Minnesota Purebred Dog Breeders Association, first active at the Fair in 1972, returned to the exposition to present demonstrations on grooming, training, handling and obedience drilling and exhibits of many interesting dog breeds.

Folk dancing was a feature at the Territorial Pioneers Log Cabin where early photographs of St. Paul and Minneapolis were also displayed. Next door, at the Senior Citizens Building, entertainment was provided by quartets, trios, a folk balladeer and the Minnesota Over-60 Band. Performing in mall parades, Machinery Park and Plaza Park were high school bands from Madison, South Dakota; Parshall, North Dakota, and Bloomer, Wisconsin, in addition to the Optimist Club Boys Band from Moosejaw, Saskatchewan; Mounties Drum and Bugle Corps, St. Paul; Gopher State Band, Minneapolis, and the St. Paul Police Band.

August 24 was Band Day and 28 high school marching units competed during a special free show in front of the Grandstand. Winners were Central Senior High School, Red Wing; Lake City High School, and Rushford High School.

Another dimension to State Fair activity is sponsorship of programs and events which recognize and publicize various groups and individuals. Among these programs are the Minnesota Teacher of the Year selection (cosponsored with the Minnesota Education Association), outstanding senior citizens program (cosponsored with the Governor's Citizens Council on Aging and the Minnesota Federation of County Fairs), Farm Equipment Day, Education Recognition Day and Mayors, Legislators, News Media Day.

The 1973 Teacher of the Year, announced on August 26, is Thomas F. Stoltman, Winona. Selected the state's outstanding senior citizens were Mrs. Caroline Ellison, Monticello, and Wallace F. Simpson, Belview. The two goldenagers were honored at the Fair on Senior Citizens Day, August 30.

There were many other celebrities and well-known political figures at the Fair in 1973. It was possible for visitors to chat with them as they made their way to radio and television stations and other locations on the grounds.

Attractions which were particularly fascinating to youngsters included the "touch and see" artifact display in the Education Building, Future Farmers of America Barnyard, demonstrations and booths in the 4-H Building, free Children's Days Grandstand shows and wildlife ponds at the Natural Resources complex.

## NIGHT SHOWS

Fifteen performances of seven different shows were scheduled for presentation at the Grandstand, evenings during the 1973 Fair. Although only 11 performances actually were staged, they drew large crowds of satisfied entertainment seekers.

Cancellations were necessitated by the severe illness of Engelbert Humperdinck who was to have been the star of two shows each night, Friday, August 31, and Saturday, September 1.

Opening night, Friday, August 24, was the occasion for a demolition derby on the track in front of the Grandstand (a second derby, at 2 p.m., Saturday, August 25, was part of the afternoon schedule).

Kicking off the musical portion of the evening entertainment line-up, The 5th Dimension and Mac Davis performed Saturday and Sunday, August 25 and 26. Icarus, or Bill Moyes, the Australian kite-man, was another featured attraction at these shows as well as at several other night shows and race programs during Fair-week.

Television's Brady Bunch Kids and Dawn featuring Tony Orlando were next, with two shows the evening of Monday, August 27. A spectacular fireworks display, produced by Nationwide Fireworks, capped all evening Grandstand performances.

Country and western music, a fixture at recent Minnesota State Fairs, was presented August 28. Bill Anderson, LeRoy Van Dyke, Tommy Overstreet, Donna Fargo and Jerry Clower were the show's stars. On Wednesday and Thursday, August 29 and 30, Pat Boone and his family along with Rich Little provided music and comedy for Fair audiences.

There were no shows Friday and Saturday as a suitable replacement for Humperdinck could not be found in the time allowed. Sunday, September 2, Charley Pride made his third successful trip to the State Fair, captivating thousands of his fans at two shows.

## **YOUNG AMERICA**

Young America at the 1973 exposition was the gathering place for enthusiasts of rock music, folk songs, contemporary comedians and teen-oriented shops.

Continuing the policy of bringing up-and-coming bands to Minnesota and charging only 50¢ for their concerts, the State Fair presented Joy of Cooking (August 24-27), Gypsy (August 28-30) and Flash Cadillac and the Continental Kids (August 31-September 3).

Along with these nationally-known groups, the best Upper Midwest bands were showcased at Young America. Included were Cain, Sterling, Coal Duck, Backbone, Jesse Brady, BeBop and the Hubcaps, Reasons and Minnesoda. Comedians Harris Nelson and Bobby Smith were also featured.

In the 10 years since its inception, almost one million persons have been admitted to Young America. The price of tickets has always been 50¢, except in 1965 when a 75¢ charge was tried after 6 p.m. Over the years, fans have been able to see and hear many soon-to-be-famous groups such as Kenny Rogers and the First Edition, James Gang, Sha-Na-Na and Grass Roots.

## **HORSE SHOWS**

Intense preparation in the Horse Barn contributed to spectacular performances in the newly decorated, colorful Hippodrome as horse exhibitors strived to impress judges and their fellow equestrians during 1973 horse show competition.

Beginning Friday, August 24, and continuing through Wednesday, August 29, English-style and draft horses were the principal nightly attractions. In addition, there were matinees, Saturday and Sunday, August 25 and 26.

Western-style horses and tack were to be seen on the Fairgrounds Friday,

August 31 through Monday, September 3. Arabian, Morgan, Appaloosa, Palomino and Quarter Horses and a host of saddle club events were judged at the shows.

Almost 1,000 exhibitors, showing some 2,100 animals, participated in the '73 exposition's English and western horse shows.

The thrills and excitement generated by bronc and bull riding, steer wrestling, calf roping and barrel racing brought crowds to the Hippodrome for three complete rodeos, Thursday and Friday, August 30 and 31.

## RACES

A completely new racing format greeted speed fans at the 1973 State Fair. The Minnesota exposition was the only promoter in the country to include races sanctioned by the three major race organizers, United States Auto Club (USAC), International Motor Contest Association (IMCA) and National Association for Stock Car Auto Racing (NASCAR).

In addition to USAC and IMCA sprint cars and NASCAR late-model sportsman stock cars, modified stock car action and motorcycle races were part of the Fair's nine-day series.

Jerry Hansen, Wayzata, won the opening USAC race on Sunday, August 26. The second day of USAC competition, August 27, was highlighted by the wins of Tom Bigelow, Whitewater, Wis., and Tom Sneva, Spokane, Wash., in the two features of a twin-50-lap race.

Walt Foster, Cotton, Calif. (750 cubic centimeter class), Mark Oswald, Des Moines, Iowa (360 cc.), Greg Krenik, Mankato (250 cc.) and Ron Lane, Forest Lake (125 cc.), were the motorcycle winners on Tuesday, August 28.

During the two-day modified program, August 29 and 30, Bob Jusola, Burnsville, won two late-model races, while Dave Heensch, Mound, and Lynn Peterson, Lakeville, each won once in the sportsman division. Jusola and Peterson were also awarded overall titles.

Hansen returned to sweep both IMCA features, August 31 and September 1, making him one of the most successful State Fair drivers in recent years. Another accomplished chauffeur, Dick Trickle of Wisconsin Rapids, Wis., captured one of two NASCAR late-model sportsman features, Sunday, September 2, and went on to win the 500-lap Labor Day finale. Sunday's other winner was Rich Somers, Stevens Point, Wis.

## DEVELOPMENT, EDUCATION THRU COMPETITION

Fairs traditionally have been the proving ground on which farmers, craftsmen and other skilled persons have compared their accomplishments with those of their fellows. The obligation of the Minnesota State Fair to provide a broad program of public competition was fulfilled in 1973 as a record total of \$311,520 in premiums was awarded, based on the results of judging in more than 20 different departments.

Participating were some 9,500 exhibitors of livestock, fine arts, home crafts, farm crops, garden produce and baked and canned goods who competed for the recognition symbolized by ribbons and trophies as well as cash prizes.

Breakdown of the premium total includes: \$75,506 awarded in open live-stock classes; \$85,125 paid in junior classes (4-H, FFA and Education Departments); \$6,079 awarded for fine arts and creative activities; \$19,552 paid for the best agriculture, horticulture and bee products; \$46,943 awarded horse show and rodeo competitors; \$3,450 paid Band Day and talent contest finalists, and \$75,865 paid to race winners.

Appaloosa, Arabian, Belgian, Clydesdale, Morgan, Palomino, Percheron, Quarter, Saddlebred and Thoroughbred horses as well as Hackney and Shetland ponies were exhibited during horse shows and at halter. In the Cattle Department, owners of Ayrshire, Brown Swiss, Hereford, Guernsey, Holstein,

Shorthorn, Angus, Jersey, Milking Shorthorn, Charolais and Red Poll cattle showed their animals. A feature of the 1973 cattle competition was the Fair's Polled Hereford show, designated a national "Standard of Perfection" show by the American Polled Hereford Association. Polled Hereford exhibitors were offered a total of \$10,000 in prizes.

Swine producers showed Durocs, Hampshires, Chester Whites, Berkshires, Yorkshires, Spotted Hogs, Landrace and Poland Chinas. In addition, final winners in the Fair's barrow show were determined. This competition began in April with a special weighing conducted by State Fair officials at exhibitor's farms.

The second annual ladies' lead class opened competition in the Sheep Department and was followed by quality and market lamb shows. South-downs, Cheviots, Shropshires, Hampshires, Dorsets, Suffolks, Corriedales and Columbias were also judged. Chickens were exhibited and judged during the first seven days of the 1973 Fair and remaining poultry department classifications, including pigeons, rabbits, turkeys and waterfowl, were displayed the final four days.

Junior class competition encompassed a wide range of farm, school and home projects, entered in the Fair's 4-H, Future Farmers of America and Education Departments. Most open class livestock was exhibited during the first half of Fair-week while FFA and 4-H program members took over the Cattle, Swine and Sheep Barns from the Fair's second Friday through Labor Day. Projects and demonstrations were also featured in the Education and 4-H Buildings daily during the exposition.

The Creative Activities Building again proved most popular, from the point of view of competitors as well as visitors. Nearly 5,000 articles were entered and displayed. Fine Arts Department competition was conducted in cooperation with the University of Minnesota. The Fair art display was one of four regional shows held throughout the state, sponsored by the exposition and by the University's Agriculture Extension Service. Entry was open to all artists without the usual separate categories for different types of media.

Flower, Fruit, Bee Culture, Christmas Tree, Farm Crop, Vegetable and Potato Departments, with their many classes, lots and auxiliary shows, were housed in the Fair's Agriculture-Horticulture Building. The building was filled with prize-winning displays and related special events and exhibits were scheduled during the entire 1973 pageant.

## **ADMINISTRATION AND SERVICES**

Operation of the Minnesota State Fair is accomplished through a blend of well-qualified part-time superintendents and a permanent year-around staff, working under the secretary-general manager. These individuals are responsible for carrying out the basic policies of the Board of Managers as well as providing direction for the 1,500 additional part-time Society employees who, in turn, provide for the safety, comfort, convenience and entertainment of more than one million annual fall visitors.

Part-time superintendents head all Fair departments except Administration, Entry, Greenhouse, Maintenance/Construction, Publicity, Service, Space Rental and Treasurer. These eight departments are headed by full-time people who are part of a permanent staff of 30. In addition to the secretary-general manager, the office staff includes the assistant secretary-general manager, two

administrative assistants, treasurer, cashier, entry coordinator, bookkeeper and assistant bookkeeper, space rental superintendent and assistant, purchasing agent and publicity superintendent. Physical work and planning, as it relates to plant maintenance and improvement, is channeled through architectural, construction, mechanical, greenhouse and service divisions, whose superintendents and employees make up the balance of the year-around staff.

It is the additional job of the permanent staff to coordinate the shows, special events and conventions which are staged on the Fairgrounds during the remainder of the year. Servicing special events has become an increasingly important staff function as evidenced by the 66 shows held on the grounds in 1973.

The Fair's competitive departments, which last fall collectively distributed over \$300,000 in premium awards, are headed by individuals qualified in specific areas such as the arts, agriculture or education. Administrative guidelines for these superintendents are provided by the Entry Department which is also responsible for preparation and distribution of premium catalogues and correlation of judging records as well as payment of premiums.

The State Fair also operates a number of departments and divisions specifically to provide public services and accommodations for visitors and exhibitors, as well as handling the many behind-the-scenes tasks unique to the exposition. These departments, like those in the competitive categories, are under the leadership of individuals with qualifications and experience in definite areas including public safety, sanitation, ticket handling, music, motor races and stage show production. Administrative guidance is provided for each of the Fair-period service departments so that Board and management policy, as well as budget restraint, may be applied through a logical chain of staff responsibility.

In addition to regular employees, several hundred volunteers contributed to the successful operation of the 1973 State Fair. Included were the young men and women of the Farm Boys' Camp, Boy Scouts, Girl Scouts and Camp Fire Girls. These groups were responsible for ushering in the Grandstand and Hippodrome, parking vehicles, staffing information booths and conducting a building traffic survey.

## ANNUAL MEETING — 1973

The Minnesota State Agricultural Society, governing body of the State Fair, assembled for its 114th annual meeting at the Leamington Hotel in Minneapolis on Monday, January 15, 1973. Business sessions were conducted in conjunction with the Minnesota Federation of County Fairs, co-sponsors of the yearly convention.

Tuesday, January 16, Society delegates met to hear reports on the 1972 State Fair, including those of the president, secretary and treasurer. Credential and resolution committee reports were presented and accepted, as well as a report of nomination by the Hall of Fame committee. Two pioneer leaders in the formation of the Society, Alexander Ramsey and William Murray, were duly elected to membership in the Hall of Fame. Short presentations were made by representatives of 4-H and Future Farmers of America.

Immediately following this meeting, delegates from the seventh, eighth and ninth districts met in separate caucuses for the purpose of certifying nominees for election to the Society's Board of Managers with elections to be held the following morning as prescribed by law.

On Tuesday evening the combined banquet and ball of the Society and Federation was held in the main ballroom of the Leamington Hotel.

On Wednesday morning the Society conducted its final business session with the following elections taking place: president—Leo Keskinen, Grand Rapids (one-year term); vice president—Norris K. Carnes, St. Paul (two-year term); seventh district Board member—J. G. Tiffany, Redwood Falls (three-year term); eighth district Board member—Sulo Ojakangas, Hibbing (one-year term); ninth district Board member—Harveydale Maruska, Warren (three-year term). Elected an honorary life member of the Society was retired treasurer, Roy C. Sorenson, Edina.

After adjournment of the annual meeting, the Board of Managers, including its newly elected members, met and reelected John E. Libby to the position of secretary-general manager for a one-year term.

## OFF-SEASON

More than 1.8 million persons made use of Minnesota State Fair facilities during 1973. Of particular note is the fact that an ever-increasing proportion of this public utilization occurs during the Fair's so-called "off-season."

Last year, 66 shows or events, with a combined attendance of 557,845, were staged on the grounds during periods other than Fair-week. This is 31 per cent of the total recorded attendance.

A majority of last year's 66 Fairgrounds events lasted more than one day. As a result, Fair facilities were in almost constant use during the spring, summer and fall months. Two of the busiest buildings were the Grandstand—race track complex, where 13 events were held over a 33-day period with attendance of 346,325, and the Hippodrome, which hosted 12 shows comprising 27 days with attendance of 68,725. Other facilities with heavy usage during the off-season were the Horse Barn, Machinery Hall, Judging Arena, 4-H Building, Dairy/Animal Products Building and Food Show Auditorium.

Two new exhibit buildings which were opened for the 1973 State Fair, the Merchandise Mart and the Home Improvement Building, are ideally suited for trade show and sale usage. Heavy implementation of these facilities is anticipated beginning with the 1974 season.

Income produced by off-season rentals, including warehousing during winter months, has become an integral and necessary part of the exposition's operational budget. In 1973, these activities produced gross revenue of \$193,644.81, which represents almost six per cent of the Society's total operating income.

Originally, the State Fair Grounds was in Rose Township of Ramsey County, Minnesota, within the corporate limits of neither St. Paul nor Minneapolis. In 1954, when Falcon Heights voted to become a village, that part of the grounds which lies north of Como Avenue was included in the Village of Falcon Heights. All that part of the grounds lying South of Como Ave., the  $2\frac{1}{2}$  acres within the fence (Item 5 inside fence); and the two lots numbered thirteen and fourteen in Block 3, Lake Park addition, (Item 5 outside fence) are within the corporate limits of the City of St. Paul.

# REPORT OF LEGISLATIVE AUDITOR

Year Ended November 30, 1973

## AUDITOR'S REPORT

This report on an examination of the financial affairs of the State Agricultural Society covers the year ended November 30, 1973.

The examination was made in accordance with generally accepted auditing standards, and accordingly included such tests of the accounting records and such other auditing procedures as we considered necessary in the circumstances.

Depreciation has been taken on certain structures, the electric plant, and personal property. Depreciation is not taken on some structures, the gas, sewer, and water systems, and other improvements such as fences, sidewalks, streets, curbs, and gutters.

It is our opinion, subject to the foregoing paragraph, that the balance sheet and statement of income and expense in this report present fairly the financial position of the State Agricultural Society at November 30, 1973, and the results of its operation for the year then ended, in conformity with generally accepted accounting principles applied on a basis consistent with that of the preceding year.

### COMMENTS

The State Agricultural Society is a public corporation with the right of perpetual succession. Its membership is composed of the following.

1. Three delegates from each agricultural society or association in the State which maintains an active existence, holds annual fairs, and is entitled to State aid under Minn. Stat. Section 38.02 (1971).
2. One delegate to be appointed by the county board of each county in the State in which no county or district agricultural society exists.
3. Individuals, who by reason of eminent service to agriculture, horticulture, or in the arts and sciences connected therewith, or by long and faithful service to the Society, have been elected as honorary members.
4. Delegates from qualified State societies and associations as listed in Minn. Stat. Section 37.03 (4).
5. Members of the Board of Managers of the State Agricultural Society.

The management of the affairs of the State Agricultural Society is vested in a Board of Managers. The president is elected for a one-year term, the two vice-presidents for two-year terms alternately. The other managers are elected from each of seven regional districts not represented by a vice-president for terms of three years.

The year-around business is conducted under the stewardship of a secretary-general manager, elected by the Board.

All employees serve at the pleasure of the Board and the secretary-general manager who is authorized by the Board to make adjustments in the assignments and compensation of employees as he deems advisable.

Activities of the Society are financed by receipts from the annual fair and from rental of buildings and grounds.

### Admissions

Total outside gate admissions including vehicles, and grandstand admissions at the last four annual fairs were as follows:

The length of the fair was extended from 10 to 11 days in 1972.

### Campgrounds

Pre-numbered stickers are issued for all vehicles staying in campgrounds. Fees charged are based on number of days of occupancy. To improve control, stickers sold should be dated and a separate sticker issued for each day of occupancy.

The 115th Annual Meeting of the Minnesota State Agricultural Society was called to order by President Keskinen at 10:45 a.m., Monday, January 21, 1974, at the Hilton Hotel in St. Paul with a short business session to appoint resolution and credential committees. These committees met to conduct business at 10:00 a.m., Tuesday, January 22.

Secretary discussed with the Board his contingency plans as related to auto racing and the fuel shortage situation, to wit, (1) shortening the auto race schedule and (2) booking an attraction to provide alternate recourse in case auto racing should be curtailed or prohibited by federal directive. After consultation with Executive Committee, Secretary contracted for the services of the Tommy Hanneford Circus at the 1974 Fair (11 days—\$25,000.00). Upon a motion by Mr. Sincock, seconded by Mr. Scow and carried, these executive actions were approved.

President Keskinen recessed the regular Board session so that meetings of Standing Committees might be held. Secretary announced that in keeping with precedent, all members of the Board were invited to sit in on the deliberations of the various committees so that they might have full knowledge of the matters taken up at these meetings. While voting on committee business is limited to the membership of the particular committee, participation by all Board members is desirable during deliberations.

## **ADMISSIONS COMMITTEE MEETING**

Members present: Sincock, Chairman; Carnes; Maruska; Scow; Ojakangas; Keskinen; Libby.

It was moved by Mr. Ojakangas, seconded by Mr. Scow and carried that the committee confirm and approve the following administrative action for 1974:

Admission policies and prices outlined in Society Regulations (Division A, Section 4, Rules 4.01 through 4.07) should remain the same with the exception of Rule 4.06 which should be changed to read as follows and filed with Secretary:

"RULE 4.06. The Minnesota State Fair offers, principally as a service to its exhibitors, concessionaires and employees, a reduced rate for outside gate adult pedestrian and/or vehicle admission. Said discount may be taken advantage of by any individual in the following manner: Discount admission tickets and/or punch-card season tickets, must be purchased in advance, in lots of eleven (11) only, at \$8.25 for eleven (11) tickets. Sale of said discount tickets will cease at 5:00 p.m. on the first official day of the Fair. Tickets purchased in this manner will be non-refundable unless returned, in unbroken lots of eleven (11) only, to the Treasurer's Office (Bldg. No. 331) before 12:00 noon on the final day of the Fair. Odd lots (less than eleven tickets) must be paid for at the regular rate. (1-23-74)"

Afternoon Grandstand ticket scale to be set at \$3.00 (for seats in the main stand) and \$2.00 (for bleacher seats), with children under 16 years admitted to the bleachers for \$1.00. Evening Grandstand ticket scale to remain the same at \$5.00, \$4.00, \$3.00 (main stand) and \$2.00 (bleachers). Hippodrome ticket scale for all performances to remain the same at \$3.50, \$2.50, \$2.00 (reserved sections) and \$1.50 (unreserved sections).

Again, as a means of anticipating energy problems and to provide flexibility in the areas of group travel, use of mass, public transit and alternate, non-automotive travel to the Fair, Secretary was authorized by motion of Mr. Carnes, seconded by Mr. Scow and carried, to implement procedures, discounts and/or admission policies as might aid in such a program.

There being no further business, Admission Committee was declared adjourned.

## **ADVERTISING COMMITTEE MEETING**

Upon a motion by Mr. Sincock, seconded by Mr. Carnes and carried, it was decided to follow the same general advertising policy in 1974 as in 1973, using every radio/television outlet as well as every newspaper in Minnesota, the 17 western counties of Wisconsin and the two northern tiers of counties in Iowa, as a basic advertising area; also to continue issuance of the State Fair newsletter and roto brochure. Above motion also specifies that the firm of M. R. Bolin Advertising be retained to handle the Fair's 1974 advertising campaign.

There being no further business, Advertising committee meeting was declared adjourned.

## **RULES AND PREMIUM LIST COMMITTEE MEETING**

It was moved by Mr. Ojakangas, seconded by Mr. Maruska and carried that department supervisors and superintendents, in consultation with the Entry Department, be allowed to make minor adjustments in the rules and/or premiums of their particular departments in accordance with the general provisions of the 1974 Society budget.

It was moved by Mr. Scow, seconded by Mr. Sprengeler and carried that

the following change in Society regulations be approved and filed with the Secretary:

"RULE 6.05. Sale or distribution of any merchandise, including printed or written materials, except under license by the Society and/or from a duly licensed location, shall be a misdemeanor. (1-23-73)"

There being no further business, Rules and Premium List Committee meeting was declared adjourned.

#### **BUDGET COMMITTEE MEETING**

Secretary presented the complete budget for 1974 stating that same had been set in as realistic a form as possible with allowance for bad weather and other contingencies. He further reported a January 21, 1974, Planning Committee recommendation for approval of the improvement and maintenance portion of the submitted budget.

Upon a motion by Mr. Haeg, seconded by Mr. Scow and carried, the 1974 budget as presented and discussed (including the Planning Committee's maintenance/improvement program) was approved.

There being no further business, Budget Committee meeting was declared adjourned.

#### **RECONVENED MEETING OF THE BOARD**

Action(s) taken by the Admission, Advertising, Budget, Planning and Rules/Premium List Committee(s), which met previously, were approved upon a motion by Mr. Sincock, seconded by Mr. Scow and carried.

It was moved by Mr. Maruska, seconded by Mr. Ojakangas and carried that Secretary be authorized to make adjustments in staff salaries as he deems advisable.

It was moved by Mr. Ojakangas, seconded by Mr. Tiffany and carried that the same general rodeo format be offered in 1974 as was the case in 1973 and that the Secretary be authorized to negotiate terms of a rodeo performance contract with Barnes Championship Rodeo at approximately \$12,000.00.

Discussion was undertaken relative to expansion of the present Mexican Village complex on the west to Underwood Street with the integrated, enlarged facility to become an "International Village" involving other countries and other ethnic groups. It was felt, however, that such a plan might be better delayed for a year so as to get plans and financing in a more comprehensive form. It was then moved by Mr. Scow, seconded by Mr. Maruska and carried that Secretary be authorized to negotiate an exhibit/concession contract with Mexican Village, Inc. for 1974.

It was moved by Mr. Carnes, seconded by Mr. Sincock and carried that the Society's 1976 annual meeting be held at the Hilton Hotel in St. Paul on January 19, 20 and 21. (As per earlier action, the 1975 meeting is scheduled for January 20, 21 and 22 at the Leamington Hotel in Minneapolis).

Requests for July show dates from (1) the North Central Morgan Horse Association and (2) the State Half-Arabian Horse Association were approved upon a motion by Mr. Sincock, seconded by Mr. Tiffany and carried.

An application from Northernaire Productions, Inc. of Mankato, Minnesota, for lease of Grandstand stage and infield facilities on May 27, 1974, to produce a musical concert, was presented and discussed at length. After considerable discussion, it was moved by Mr. Haeg, seconded by Mr. Ramberg and carried that Secretary be authorized to accept or deny said application and, if accepted, to negotiate any and all terms and conditions of resulting contract he deems advisable.

Secretary presented a tentative outline of the Grandstand talent schedule currently under consideration for the 1974 Fair.

Secretary discussed the 1973 fireworks production at the grandstand handled by Nationwide Fireworks Company along with 1974 proposals received from several other fireworks companies. Following considerable dis-

cussion, it was moved by Mr. Tiffany, seconded by Mr. Ojakangas and carried that Secretary be authorized to negotiate a 1974 fireworks contract with the Zambelli Fireworks Company of New Castle, Pa.

Secretary presented a damage claim against the Society for \$50.00 by a Machinery Hill exhibitor (A-1 Concrete Unit Step Co., Inc. of Rosemount). Damage resulted when State Fair trash removal truck/vat struck an A-1 step display. Upon a motion by Mr. Scow, seconded by Mr. Sprengeler and carried, said claim was approved for payment.

An application for exhibit space from the Minnesota Region, Antique Automobile Club of America, was discussed in the context of its (possible) conflict with the present "Antique Auto Show," located under the East Bleacher. It was moved by Mr. Sincock, seconded by Mr. Scow and carried that Secretary and Space Rental Superintendent be authorized to negotiate a contract with AACA if details, terms and avoidance of conflict can be worked out.

Adjournment was moved by Mr. Tiffany, seconded by Mr. Ramberg and carried.

Meeting adjourned.
