
- Our district will be making reductions for the next three years to balance our budget and rebuild our Fund balance. We have a -3.0 enrollment drop per year over the last 6 years.

Deer River Mascot Board Decision

2023

You may have heard the Mn. State Legislature passed legislation in the 2023 session involving school mascots. Below is an excerpt from said legislation:

"American Indian mascot" means a name, symbol or image that depicts or refers to an American Indian Tribe (or any connection to); an individual, custom or tradition that is used by a public school as a mascot, nickname, logo, letterhead or team name of the district or school within the district. This includes symbols such as feathers, spears, tomahawks and Indigenous clothing. Schools and districts within a tribal reservation in Minnesota that have 95% American Indian students will be exempt from this legislation."

If a school had a Mascot or symbol impacted by the legislation and wanted to keep it, they could...

"Subd. 3. Exemption. A public school may seek an exemption to the prohibition by submitting a request in writing to all 11 federally recognized Tribal Nations in Minnesota and to the Tribal Nations Education Committee (TNEC) by September 1, 2023, and receiving that exemption from each Tribal Nation and TNEC. The exemption is denied if any of the 11 Tribal Nations or the Tribal Nations Education Committee oppose the exemption by December 15, 2023. A public school whose request for an exemption is denied must comply with changing your mascot by September 1, 2025."

At the August 14th, 2023, Deer River School Board meeting, by a vote of 4-2 the Board decided Not to seek an exemption and made the following decision:

The board voted to remove the spear and feather based on the Minnesota State Legislature's law passed on the use of Native American mascots in public schools.

The board's rationale for keeping the Warrior name is due to the word "Warrior: being non-specific and is defined as: brave person, experienced soldier; person who shows great vigor or courage, and sacrifices self for the good of others.
