# Prosecutor Training Grant Program A-PTG-2024-MCAA-003 Legislative Committee Report

#### **Train the Trainer**

**Course Objectives:** 1. Explain how the human brain learns. 2. Explain how instruction helps people learn more effectively and efficiently. 3. Use research-based instructional strategies to promote different kinds of learning. 4. Use effective feedback to promote trial advocacy skill development. 5. Apply instructional methods, strategies, and technology to design effective and efficient training.

Faculty included: Jim Hall, Hallmentum, Mark Rubin, St. Louis County Attorney, Retired and Victor Vieth, Zero Abuse Project.

The course was held at MCAA Office in St. Paul on May 1 - 3, 2024, and 10 Assistant County Attorneys were in attendance.

**Evaluation Summary:** Evaluations were completed by 8 of the 10 seminar participants. The overall value of the course was 4.75 out of 5.00. The students were asked to rate each speaker in four areas — length of session, level of detail covered, session usefulness and meeting expectations for the topic. All of the speaker averages were 4.57 or higher. The most liked session was Mark Rubin's How to Give Effective Feedback: Live Critique. The least liked session was the Elimination of Bias session.

We also received the following comments and suggestions: Best course I have been to in years. The class size was great! I like the more intimate class size. It energized me after talking to other prosecutors during lunch breaks. Great speaker. Easy two days to be alternative, if interested. Really enjoyed It & learned from it. I really hope that MCAA will offer more trainings for senior attorneys. While it is important for new prosecutors to receive training, seasoned attorneys benefit from trainings tailored to them just as much.

#### Trial Advocacy for New Attorneys

**Course Summary:** The value-add of this program is the small group workshops and exercises. Our Trial Advocacy course provides an immersive experience. Trial Advocacy reinforces the presentations from experienced faculty by forcing students to use the lessons gleaned from the general sessions. Students take the concepts presented into a small group workshop and apply them to the fact pattern. Students then try out the newly acquired skills in the exercise. The faculty critique is the polish.

The entire week functions as an integrated whole. Faculty presenting on the various stages of a trial are tasked with giving information generally applicable to the art of prosecution. Small Group Leaders guide students as they apply the lessons to the specific fact pattern. The faculty critique evaluates the students' performances and suggests areas for improvement. The small group and exercises are the most important component.

The course was held at Camp Ripley in Little Falls on June 25 - 28, 2024, and 33 County Attorneys and Assistant County Attorneys were in attendance.

**Evaluation Summary:** Evaluations were completed by 29 of the 33 seminar participants. The overall value of the course was 8.60 out of 10.00. When asked about the overall level of the course, the summary was: 3 Too Intensive? 2 Too Easy? 24 Just Right? Because this course is a combination of lecture and small group work, we ask the students about the amount of individual instruction. Their overall feelings were: 0 Too Much? 5 Too Little? 25 Just Right?

For future courses, it was suggested we add the following topics: More on exhibits. Make a record class would be helpful, top most common reversible errors, objections. Motions in Limine, objections. Trial prep with witnesses. Rules of evidence. Examples of laying foundation.

When asked if they had any additional thoughts they would like to share about your experience, we received the following comments: More time to practice during the day. Make the course longer. Great networking opportunity. Thankful for the presenters/faculty to provide so much infraction and information. This was an intense and at times stressful, but worthwhile experience. I felt I learned a lot.

# Minnesota's New Tax-Forfeited Property Legislation Webinar

Course Summary: Last May, the U.S. Supreme Court ruled in Tyler v. Hennepin County that it is unconstitutional under federal law for a Minnesota county to retain the proceeds from the sale of tax-forfeited property that exceed the tax debt on the property. Come learn about the new legislation passed this session that reformed Minnesota's process for handling tax-delinquent property from two Assistant County Attorneys who worked on the legislation.

The webinar was held from noon to 1:00 pm, on July 24, 2024, originating from the MCAA Office in St. Paul, MN. 70 County Attorneys and Assistants were in attendance.

**Evaluation Summary:** The overall value of the class 98% of participants thought the course was very good to excellent. When rating the speaker for the course 97% said the program met their expectations, 98% thought you demonstrated knowledge of the subject and 95% were easy to understand.

We also received the following comments: The speakers were very knowledgeable and confident, which helped me to understand the material even though it is not my area of practice. Thanks! More on this subject as its impact plays out; this could've been a several hour CLE - I hope there will be a follow up; I don't anticipate personally practicing and advising staff in this area, so the information was shared at a level that a novice or non-expert could understand. Thanks for being willing to answer all of the random questions (including mine). These two Assistant County Attorneys did an excellent job of communicating very important information in an understandable way.

**Course Summary:** Join MCAA Executive Director Robert Small to find out what happened this Legislative session and how it will impact your practice.

The webinar was held from noon to 1:00 pm, on July 31, 2024, originating from the MCAA Office in St. Paul, MN. 68 County Attorneys and Assistants were in attendance.

**Evaluation Summary:** We received very positive ratings for the seminar. For the overall value of the class, all of participants thought the course was very good to excellent. When rating the speaker for the course 93% said the program met their expectations, 99% thought he demonstrated knowledge of the subject and all thought he was easy to understand.

The course was held at the Greysolon Ballroom in Duluth on September 25 - 26, 2024, and 55 County Attorneys and Assistants were in attendance.

**Evaluation Summary:** Evaluations were completed by 12 of the 52 seminar participants. The students were asked to rate each speaker in two areas - information content and presentation style based on a scale of 1, being poor to 5, being excellent. The speaker averages were 4.14 for usefulness and 4.31 for level of detail. The most liked session was on Advantages of Minnesota Commerce Fraud Bureau, Local Law Enforcement Agencies, & State Fire Marshall Partnerships. The least liked session was Clemency Review Commission.

We received the following suggestions to improve the course: This is my most valued CLE/training I attend each year. The networking and casual conversation is most critical. I hope to be a resource to others as well as other electeds have been to me. I like the mixture of sessions addressing partners we work with as well as internal office issues.

## **Ethical Issues for Government Attorneys Webinar**

Course Summary: In this presentation, our experienced faculty review the ethics rules and discuss their application as they work realistic case scenarios facing criminal and civil government attorneys. The goal is to expose you to the rules and their application in order to alert you to potential ethical issues and situations.

The webinar was held from noon to 1:00 pm, on September 25, 2024, originating from the MCAA Office in St. Paul, MN. Over 244 County Attorneys and Assistants were in attendance.

**Evaluation Summary:** For the overall value of the class, 97% of participants thought the course was good to excellent. When rating the speaker for the course 99% said the program met their expectations, they all thought they demonstrated knowledge of the subject and were easy to understand.

We also received the following comments: The humorous slides were a very nice and welcome addition, these topics are very, very dry so I thought they were tastefully interspersed to help keep attention! Each speaker was very knowledgeable about their subject matter and it was easy for me to understand and track what each speaker was trying to get across--even if the subject matter was outside the specific area of government work that I do. Great seminar!!! I believe there is enough information to have an entire hour or more on just the criminal side of ethical issues for Government attorneys. Great combination of topics and presenters. Thank you! This MCAA CLE was particularly well done - focused, helpful content presented clearly and efficiently. Will Topka was excellent!! I think you could do separate sessions for civil ethics vs. prosecutor ethics.

#### **47th Annual MCAA Meeting**
