Purpose

This report fulfills the annual reporting requirement in Minn. Stat. § 611.59, subd. 4(b), which states: By February 15 of each year, the board must report to the legislative committees and divisions with jurisdiction over human services, public safety, and the judiciary on the data collected under this subdivision and may include recommendations for statutory or funding changes related to competency attainment.

Background

In 2022, amendments to Minnesota statute ch. 611 created the Minnesota Competency Attainment Board (MNCAB) and charged it with creating a statewide competency attainment system. The statewide competency attainment system includes forming the forensic navigator program and implementing certification processes for competency attainment programs.

MNCAB board members established a short-term goal for program development in the fall of 2023 aimed at soft launching the new work by the effective date, April 1, 2024. The goal included three components, start building the program, hire approximately ten (10) forensic navigators (one per judicial district), and provide services in both metro and greater Minnesota.

MNCAB Activities

Since the last report was filed, MNCAB has continued to build and expand competency attainment services statewide, marking several significant milestones. This section summarizes some of the key activities since the last report dated March 2024.

1. Start building the program – agency structure and hiring

Operational structures and supports established in 2024:

- Baseline human resources, finance, and information technology policies and procedures.
- Technology implemented to support daily work, e.g., Microsoft licenses, email domain, secure internet access, and a case management system.
- Access to statewide systems acquired, i.e., SWIFT and SEMA4, which permits MNCAB to independently hire employees, process payroll, and procure and pay for goods and services.

MNCAB's hiring progress in calendar year 2024:

- Quarter 1: Program administrator and human resources manager
- Quarter 2: Fifteen (15) forensic navigators, three (3) forensic navigator supervisors, IT manager
- Quarter 4: One (1) forensic navigator supervisor
- Quarter 4: Five (5) forensic navigators, human resources coordinator, two (2) learning & development specialists, office supervisor, and staff attorney



2. Hire approximately ten forensic navigators (one per judicial district)

As of December 31, 2024, MNCAB employs twenty forensic navigators who reside throughout the state of Minnesota. The forensic navigator position was opened again for applications in January 2025 and the hiring process is underway. MNCAB expects to conduct two to three rounds of hiring in calendar year 2025, with a goal of employing between fifty and seventy forensic navigators statewide by the end of 2025.

3. Provide services in metro and greater Minnesota

As of December 31, 2024, forensic navigators were assigned in 637 cases statewide, assisting 355 defendants in fifty-seven of Minnesota's eighty-seven counties. Average caseloads vary around the state. Some factors that affect a forensic navigator's caseload include travel time required to provide services, in person vs. remote court hearings, the status of the case (e.g., under civil commitment), and the level of a defendant's engagement.

Data Collection

The primary purpose for this mandated report is to provide a summary of data collected as outlined in Minn. Stat. § 611.59, subd. 4 **Program evaluations.** (a) The board shall collect the following data:

- (1) the total number of competency examinations ordered in each judicial district separated by county;
- (2) the age, race, and number of unique defendants and for whom at least one competency examination was ordered in each judicial district separated by county;
- (3) the age, race, and number of unique defendants found incompetent at least once in each judicial district separated by county; and
- (4) all available data on the level of charge and adjudication of cases with a defendant found incompetent and whether a forensic navigator was assigned to the case.

1. Statewide Court Data

In 2024, there were 10,296 competency examinations ordered by courts statewide. These examinations were for 4,020 unique defendants. The data reported is for calendar year 2024 and only includes data from adult criminal cases. In counties where the total number of people in the county was less than ten race data is not reported to protect the anonymity of the data. Detailed data as prepared and provided by the Court Research Office, State Court Administrator's Office is available in the attached Appendices.

2. Statewide Forensic Navigator Data

The Forensic Navigator Program received orders from sixty-eight or Minnesota's 87 counties appointing a forensic navigator in 2,945 cases in 2024. This reflects 1,599 unique parties. As of December 31, 2024, forensic navigators were assigned in 637 cases, assisting 355 unique parties in fifty-seven of the sixty-eight counties who sent orders to the program.
