RE: Semi-Annual Appointment Report, July 1 – December 31, 2024

Twice a year, MMB provides an Appointment Report that outlines the numbers of appointments that Minnesota state agencies made during the reporting period. This report fulfills the requirements outlined in Minnesota Statutes 43A.04, Subd. 7.

Takeaways from the report

- Minnesota state agencies made 6,741 appointments across all appointment categories between July 1 –
 December 31, 2024.
- This represents a modest 5 percent increase (or plus 333) in total appointments from the same reporting period last year.
- The Transfer (Voluntary Agency) appointment type significantly increased, representing the movement of Enterprise employees to the newly created Department of Children, Youth, and Families.

This number of appointments does not reflect the number of new employees. One employee may have several different appointments throughout the reporting period.
