### **AT A GLANCE**

The Council represents a diverse community estimated to be about 357,000 Asians<sup>1</sup> and 9,000 Pacific Islanders<sup>2</sup> descended from more than 40 nations including India, China, the Philippines, Laos, and Burma. The Council works for the implementation of economic, social, legal, and political equality of Asian Pacific Minnesotans through engagement with the governor and his cabinet agencies, the Legislature, other government agencies, and Asian Pacific organizations and community members.

The Council is composed of 11 community members appointed by the governor, and four members appointed by legislative leaders. The Council must include representatives from the five largest Asian Pacific Minnesotan ancestries in addition to six at-large community board members; no one ancestry group can have more than one representative on the Council.

According to the U.S. Census Bureau, the Asian American community is the fastest growing minority population in the nation. In Minnesota, the Asian Pacific population grew from 4.8% in 2012 to 6.3% in 2022.<sup>3,4</sup>

### **PURPOSE**

Pursuant to Minn. Stat. § 15.0145, the Council on Asian Pacific Minnesotans is an executive branch agency tasked with the responsibility of working for the implementation of economic, social, legal, and political equality of Asian Pacific Minnesotans. Our primary customers are the Governor, the legislature, state agencies, and Asian Pacific organizations and community members. The Council's key priorities include advising, advocating, and facilitating engagement on behalf of Asian Pacific Minnesotans.

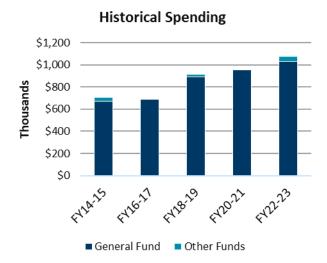

### Recommendation:

The Governor recommends additional funding of \$9,000 in FY 2026 and \$19,000 in each subsequent year from the general fund to help address operating cost increases at the Council on Asian Pacific Minnesotans.

### Rationale/Background:

The cost of operations rises each year due to increases in employer-paid health care contributions, FICA and Medicare, along with other salary and compensation-related costs. Other operating costs, like rent and lease, fuel and utilities, and IT and legal services also grow. This cost growth puts pressure on agency operating budgets that remain flat year to year.

Agencies face challenging decisions to manage these rising costs within existing budgets, while maintaining the services Minnesotans expect. From year to year, agencies find ways to become more efficient with existing resources. For FY 2026-27, agencies will need to continue to find additional efficiencies and leverage management tools to help address budget pressures. Holding open vacancies in certain programs or delaying hiring in other programs are examples of ways agencies manage through constrained operating budgets. Such decisions are difficult and must be weighed against a program's ability to conduct business with less staffing and its impact to service delivery.

This recommendation provides additional resources to help address these cost pressures and pay for agency operations.

# **Proposal:**

The Governor recommends increasing agency operating budgets to support current services. For the Council on Asian Pacific Minnesotans, this funding will help cover expected growth in employee compensation and insurance, IT services, and other operating costs.
