

PURPOSE

AT A GLANCE

The Board of Behavioral Health and Therapy exists to regulate the practices of alcohol and drug counseling, professional counseling, and professional clinical counseling in the State of Minnesota. Regulation of these professions is necessary to protect the health, safety, and welfare of the public when they receive mental health and substance use counseling services. The Board carries out its mission through effective licensure and enforcement of statutes and rules that ensure a standard of competent and ethical practice.

Agency Profile

Licensure fees fund the Board and we receive no general fund dollars. Minnesota Statutes section 214.06, subdivision 1(a) compels the Board to collect fees in the amount sufficient to cover direct and indirect expenditures. Funds are deposited as non-dedicated revenue into the state government special revenue fund. From this fund, the Board receives a direct appropriation to pay for agency expenses such as salaries, rent, costs associated with disciplinary/contested cases, and operating expenditures. It also pays statewide indirect costs through an open appropriation.

In addition to Board operations, licensure fees fund activities that support multiple boards and/or other agencies. Some of these are the Department of Administration Small Agency Resource Team (SmART) (inter-board), the Administrative Services Unit (inter-board), the Health Professionals Services Program (inter-board), the Office of the Attorney General for legal services, and the Criminal Background Check Program (inter-board).

STRATEGIES

The Board of Behavioral Health and Therapy promotes and protects the health and safety of the citizens of Minnesota and accomplishes its public protection mission by:

- Setting educational, supervision, and examination requirements for initial licensure as a licensed professional counselor (LPC), licensed professional clinical counselor (LPCC), or licensed alcohol and drug counselor (LADC).
- Issuing the LADC license or temporary permit, LPC license, or LPCC license to practice only to qualified individuals.
- Setting the requirements for renewal of a license or permit and administering the renewal process.
- Setting standards of ethical practice.
- Responding to inquiries, complaints and reports regarding applicants and licensees.
- Investigating complaints of alleged violations of statutes and rules, holding educational and disciplinary conferences with licensees and applicants, taking disciplinary or corrective action when appropriate against practitioners who fail to meet minimum standards of practice, and reporting public actions to national databanks.
- Maintaining a website that provides information to the public about complaints and discipline, including a list of disciplinary and corrective actions taken by the Board.
- Offering online services from the Board's website, including license verification and links to the full text of public disciplinary orders the Board has adopted against licensed professionals.
- Approving continuing education activities.
- Providing information about licensure requirements and standards of practice to students, applicants, licensees, and other interested parties.

Change Item Title: Add New Compact Privilege to Practice Fee

Request:

The Governor recommends establishing the Minnesota Board of Behavioral Health and Therapy's (the Board) Interstate Compact Privilege to Practice fee in Minnesota Statute, in line with Minnesota Session Laws 2024, Chapter 127, Article 29, section 1. The new fee will cover the Board's operational expenditures associated with the new licensing process. This would increase revenues by an estimated \$20,000 in FY 2026 and \$20,000 in each subsequent year in the state government special revenue fund.

Rationale/Background:

The mission of the Board is to protect the public through effective licensure and enforcement of the statutes and rules governing the practice of alcohol and drug counseling, professional counseling, and professional clinical counseling. The Board is fee funded and receives no General Fund dollars. Fees must be collected to cover all expenditures.

During the 2024 session, legislation passed establishing an interstate licensure compact for licensed professional counselors. The Counseling Compact ("Compact") allows professional counselors to apply for a privilege to practice in any state that is part of the Compact. This eliminates the need for professional counselors to obtain a separate license in each state where they wish to practice.

The Board will incur costs by being part of the Compact. Costs include database maintenance, staffing, and participation in Compact Commission meetings. The Compact language adopted in Minnesota Session Laws 2024, chapter 127, article 29, section 1 allows the Board to collect a fee from individuals who reside outside of Minnesota who apply for a privilege to practice, which will allow them to provide professional counseling services to Minnesota residents. The revenue collected from this fee will cover the expenses described above.

Proposal:

The Governor recommends creating a new fee for a privilege to practice that may not exceed \$100. The Counseling Compact is still organizing (rule writing, building central database, etc.), so it is currently difficult to determine exact costs. For this reason, the Board is proposing a "will not exceed" structure that will allow the Board to adjust the fee as cost impact for the Board is better understood.

Change Item Title: New Staff Position

Request:

The Governor recommends an increased appropriation of \$150,000 in FY 2026 and \$150,000 in each subsequent year from the state government special revenue fund for one new staff position at the Minnesota Board of Behavioral Health and Therapy (the Board).

Rationale/Background:

The mission of the Board is to protect the public through effective licensure and enforcement of the statutes and rules governing the practice of alcohol and drug counseling, professional counseling, and professional clinical counseling. The Board issues licenses to LADCs (Licensed Alcohol and Drug Counselors), LPCs (Licensed Professional Counselors), and LPCCs (Licensed Professional Clinical Counselors). These professionals provide essential mental health and substance use counseling services to Minnesota citizens.

Every year, the number of licensees increases. Between June 30, 2014 and June 30, 2024, the number of regulated persons has more than doubled, going from approximately 4,000 licensees to approximately 9,400 licensees. Each Fiscal Year, the Board receives approximately 1,000 new license applications. The Board expects this number to continue to increase. With this growth, the workload for Board staff continues to increase. A new staff position will increase the Board's administrative capacity to manage its workload and conduct regulatory oversight more efficiently.

The Board currently collects sufficient dollars through fees paid by counselors to fund this base budget increase. No fee increases are necessary. The items in this change item request will be funded through fees deposited in the State Government Special Revenue Fund. The Board receives no General Fund dollars.

Proposal:

The Governor recommends increasing the Board's appropriation to support an additional staff position. This new position will assist in overall management of the Board office, including taking on some supervision duties currently assigned to the Board's Executive Director and management of the Board's licensure process.
