Introduction

Pursuant to Minnesota Statutes, section 216C.375, subd. 11, beginning January 15, 2022, and each year thereafter until January 15, 2035, the Minnesota Department of Commerce (Commerce) must report to the chairs and ranking minority members of the legislative committees with jurisdiction over energy regarding

- 1. grants and amounts awarded to schools under this section during the previous year;
- 2. the amount of electricity generated by solar energy generating systems awarded a grant; and
- 3. the impact on school electricity expenses.

The original statute required reporting on (a) financial assistance, including amounts per award, provided to schools under section during the previous year; and (b) any remaining balances available under this section but it was removed with the enactment of Laws of Minnesota 2023, Chapter 60, article 12, section 36.

Background

The Solar for Schools (SFS) grant program provides financial assistance to enable eligible schools to install and operate solar energy systems that can be used as teaching tools and be integrated into the school curriculum. SFS is funded through General Fund (GF) and Renewable Development Account (RDA) appropriations. Appropriations in FY22-23 were passed as part of the 2021 Minnesota Special Session (Minnesota 2021, 1st Spec. Sess. Chapter 4, Article 1, Section 2, Subd. 8(c)-(d), Article 2, Section 3, Subd 6, and Article 8, Section 24, Subd. 5(a)). Appropriations for FY24 were passed as part of the 2023 Minnesota Legislative Session (Minnesota 2023 Session Laws, Chapter 60, Article 10, Section 2, Subd 2(c) and (e) and Article 11, Section 2, Subd. 12). These program appropriations are outlined in Table 1.

2023 Legislative Updates

The 2023 Minnesota Legislative Session resulted in significant program updates and improvements (Minnesota 2023 Session Laws, Chapter 60, Article 12, Section 36) including repealing Minn. Stat. § 216C.376, and incorporating schools in Xcel territory from the repealed Solar*Rewards Solar for Schools program (S*RSFS) into the Commerce-managed program, updating grant metrics, increasing the maximum allowable system size, expanding eligible schools to include cooperative districts, and adding various consumer protections and data collection requirements. These changes were incorporated into the program as of the January 2024 Request for Proposal (RFP) funding round.

As of January 2024, eligible schools include Independent, Special, and Cooperative School Districts, as well as Tribal Contract schools. Grants are designed to cover up to 40-70% of the cost to purchase and install a solar energy system. For K-12 schools, the maximum allowable grant is determined by the <u>Adjusted Net Tax Capacity</u> (ANTC) divided by the <u>Adjusted Pupil Unit</u> (APU). The allowable grant award levels as of January 2024 are detailed in Table 2.

2024 Program Summary

In 2024, Commerce held two Request for Proposal (RFP) funding rounds, detailed in Table 3. This section includes high-level metrics of the Commerce SFS program including the total number of grants awarded, amounts awarded to specific schools, the total amount of remaining funds, a cumulative summary of previous years' projects, and other project information.

As of December 2024, 46 Round 1 full applications have been approved to receive a grant, with 41 having executed grant contracts with the Department and the final five in negotiations. These 41 grantees are detailed in Table 4. An additional 17 Round 2 schools have been invited to submit full applications. A full list of program grantees and public project details is included as Attachment 1.




Figure 1: Cumulative Solar Capacity by Project Application Year Capacity (MWdc)

These 46 projects represent a cumulative solar capacity just over 10 MW $_{dc}$, with another 17 projects potentially adding to this total capacity for the year. The total capacity for 2024 greatly exceeds those of previous years, as detailed in Figure 1. This is likely the result of the program incorporating Xcel school eligibility into the Commerce-run program design, as well as increasing the allowable system size for schools outside Xcel to up to 1 MW $_{ac}$ with electric utility approval.

While solar capacity from 2024 Round 1 projects exceeds that of the 2022 and 2023 program years combined, the number of projects is akin to previous program years. Demand for the grant program has remained strong and consistent across program years.

Combined with program years 2022 and 2023, the 132 funded projects received \$17.4 million overall in grant funding. The projects, combined, are anticipated to produce 16 million kWh of electricity annually, to deliver a cumulative \$1.36 million in electricity costs savings annually, and save over \$61 million in electric costs over the systems' 25-year lifetimes. These numbers are broken down by program year in Table 7.

There are some grant projects not represented in Table 7. Of the 46 projects approved for 2024 grants, 41 have fully executed grant contracts. The remaining five will be included in future reports, should those contracts become fully executed. Of the 100 2022-2023 grantees, nine were awarded grants under S*RSFS, previously managed by Xcel Energy. Data for these fields was not collected as part of that application process.

Grant Budget Reservations

SFS grant funds currently allocated are detailed in Table 8. Allocated funds include the 17 2024 Round 2 projects with funds tentatively reserved pending submittal and approval of full applications.

Total Grant Budget for each category is calculated using the sum of appropriated funds less admin costs, except for the K-12 Xcel budget. The K-12 Xcel Total Grant Budget is the sum of unallocated S*RSFS funds transferred to the Department (\$5,175,691), the cumulative reservations for the nine active S*RSFS projects (\$2,106,334), and the program appropriation from the 2023 Legislative Session (\$14,310,000) less 10% for admin. The Department is in communication with Xcel to locate and transfer any unaccounted-for funds from the original S*RSFS \$8M program appropriation.

Program Impact and Outlook

Prior to the SFS program, Minnesota had 184 schools with solar photovoltaic systems. Due to the SFS program, 146 schools have now installed, or are on track to install, new PV systems – nearly doubling the number of schools with onsite solar. After, the current funding round concludes, we anticipate another 65 schools will install solar, bringing the program total to 211 projects. SFS funded projects are likely to increase the state's solar school capacity by 28 MW_{dc}, tripling its pre-SFS solar school capacity. Through SFS, Minnesota has more solar schools than the national average.(Brighter Future: A Study on Solar in U.S. K-12 Schools).




Figure 6 Map of 141 Solar for Schools Grant Recipients

There are roughly 360 Independent, Special, and Cooperative school districts in Minnesota. The 141 SFS grantees alone, illustrated in Figure 6, represent 69 unique school districts, bringing the total number of districts in the state with solar to 102. The districts are comprised of an estimated 1500 individual school buildings, excluding any duplicate addresses, administrative buildings, and virtual classrooms.

In total, once the program funding is fully expended, Minnesota will be home to nearly 400 solar schools with a cumulative capacity of nearly 42 MW_{dc}. The Solar for Schools program is, therefore, likely to result in nearly 30% of school buildings being solarized across the state, triple the current national average. (Minnesota Department of Education Schools and Districts Database).
