Adopted Rules

The Department of Revenue ("Revenue") adopted three rule amendments in 2024.

Sales and Use Tax - Property Brought into Minnesota R-04831

Amended Minnesota Rules, part 8130.4300, subpart 1 to update outdated references and add language from Minnesota Statutes, section 297A.665(f). The Department moved to amend these rules under the good cause exemption procedures outlined in Minnesota Statutes, section 14.388.

The Commissioner of Revenue signed the order adopting the rule amendment on February 16, 2024, and the final rule amendment was published in the State Register on March 4, 2024.

Board of Assessors – Assessor Licensing, Education, and Conduct R-04779

Amended Minnesota Rules 1950 to reflect recommendations by Department of Revenue staff in the Property Tax Division. The changes affect Board of Assessors rules for assessor licensing, education, and conduct.

The Office of Administrative Hearings approved the order adopting the rule amendment on April 26, 2024, and the final rule amendment was published in the State Register on May 20, 2024.

Petroleum Tax – Refunds for Power Take-Off Units or Auxiliary Engines R-04840

Amended Minnesota Rules, part 8125.1301 to update terminology and align the rule with current industry and Department practices. The Department moved to amend these rules under the dual notice procedures outlined in Minnesota Statutes, section 14.225.

The Commissioner of Revenue signed the order adopting the rule amendment on, October 8, 2024, and the final rule amendment was published in the State Register on November 18, 2024.

Rulemaking in Progress and Rulemaking Records

The Department currently has no active rulemaking projects.
