#### Chief Silgjord,

Pursuant to the professional services agreement between The Axtell Group and the Sartell Police Department, The Axtell Group has completed an independent Portable Recording System (PRS) biennial audit as required by Minnesota Statutes, section 13.825, subdivision 9.

The Axtell Group assessed whether the Sartell Police Department (SPD) has in place the policies, procedures, protocols, staff, systems, and importantly – practices – that appropriately collect, classify, store, secure, and manage PRS data according to sections 13.825 and 626.8473. The Axtell Group assessed how the data are used, whether the data are destroyed as required under section 13.825, and whether the SPD's program complies with subdivisions 7 (authorization to access data) and 8 (sharing among agencies) of section 13.825 and with section 626.8473.

The Axtell Group's audit included a review and assessment of the SPD's policies, procedures, records, the PRS platform itself, including platform portal interfaces and access functions, the PRS vendor contract, audit logs, and PRS equipment inventory. The Axtell Group also conducted an interview of key staff responsible for administering the program, including the program manager responsible for release, retention, and destruction of PRS data. The Axtell Group also accessed video data as necessary to verify statutory compliance.

The elements cited under Minnesota Statutes sections 13.825 and 626.8473 include:

- Written policies and procedures
- Data classification
- · Retention of data

- · Access to data
- Inventory of portable recording system technology
- Use of agency issued portable recording systems
- Sharing among agencies
- Biennial audit
- Notification to the BCA
- Portable recording system vendor

It is The Axtell Group's determination that the Sartell Police Department is in compliance with Minnesota Statutes sections 13.825 and 626.8473 based on the following evaluations:
