As the Executive Director of the Minnesota Board of Nursing, I am submitting this report to the Legislature in compliance with Minnesota Statutes section 15.0395, Interagency Agreements and Intra-Agency Transfers. The referenced statute requires the head of each agency to provide reports to the chairs and ranking minority members of the legislative committees with jurisdiction over the agency's budget for:

- interagency agreements or service-level agreements and any renewals
  or extensions of existing interagency or service-level agreements with
  another agency if the cumulative value of those agreements is more
  than \$100,000 in the previous fiscal year; and
- transfers of appropriations between accounts within or between agencies, if the cumulative value of the transfers is more than \$100,000 in the previous fiscal year.
