Minnesota Statute § 14.05, subdivision 5, directs state agencies to report to you by December 1 of each year whether any of their rules are obsolete, unnecessary, or duplicative of other state or federal statutes or rules. The Minnesota Board of Chiropractic Examiners (MBCE) has reviewed its rules and found the following:

- Minn. R. 2500.2505: MBCE address is now 335 Randolph Ave, Suite 280, Saint Paul, MN 55102;
- Minn. R. 2500.1150, A: became obsolete when the corresponding Minnesota Statute § 148.106 regarding Peer Review of services and fees was repealed; and it has been reported as obsolete in years past.
