## OEMS Rulemaking Docket

This rulemaking docket is current as of August 11, 2025 and is prepared as required in accordance with Minnesota Statute 14.366. OEMS began operation as a successor to the Emergency Medical Services Regulatory Board on January 1, 2025. Any uncompleted rulemaking projects of EMSRB will start over under the Office of EMS and are maintained on this docket. Previously completed rulemaking activities of EMSRB are not included on this docket.

### Ground Ambulance Vehicle Standards

The Office of EMS is considering adoption of a revised rule Chapter 4690.1500. The changes under consideration would include the adoption of updated ground ambulance vehicle standards to the current version of either the Commission on Accreditation of Ambulance Service Vehicle Standards, or the current version of the NFPA ambulance standard. The current standard cited in regulation is from 1983. No notices related to this potential rulemaking have been posted at this time. ### EMS Patient Care Reports

The Office of EMS is considering adoption of new rules pertaining to the submission of EMS patient care reports as required under Minnesota Statute 144E.123. Changes under consideration could include a timeliness requirement for submission of reports, and data validity requirements. ### Recently Completed Rulemakings

#### Medications Eligible for Variance Related to BLS Ambulances (Expedited)

In response to a rulemaking petition from an EMS physician, the Office of EMS is considering adoption of a revised rule Chapter 4690.8300. The changes under consideration would allow EMTs to administer intranasal glucagon as opposed to being limited to intramuscular, resulting in potential cost savings to ambulance services. In addition to adding an option of anticholinergics for nebulizer treatments. These rules were filed with the Minnesota Secretary of State on July 23, 2025, and were adopted and became effective with publishing in the State Register on August 11, 2025. 

Dear Judge Mortenson:

The Minnesota Office of Emergency Medical Services proposes to adopt expedited rules relating to the types and routes of medications that can be administered by BLS ambulance services with specific variance approval. The Office of Emergency Medical Services has the authority for the expedited rules under 144E.011 Subd. 3 (1). This letter requests that the Office of Administrative Hearings review and approve these rules under Minnesota Statutes, section 14.389.

Enclosed are the documents required under Minnesota Rules, part 1400.2410, subpart 2, items A to K. Paragraphs A to K of this letter are keyed to items A to K of part 1400.2410. Unless otherwise stated, the document is enclosed.

- A. Enclosed: the proposed rules, including the Revisor's approval.
- B. Enclosed: the Notice of Intent to Adopt Expedited Rules as mailed and published in the *State Register* on March 24, 2025.

**Proposed Amendment to Rules Relating to Variances for certain drugs for BLS ambulances, Minnesota Rules, 4690.8300 Subp. 7; Revisor's ID Number 4914**

**Introduction.** The Minnesota Office of Emergency Medical Services intends to adopt rules under the expedited rulemaking process following the rules of the Office of Administrative Hearings, *Minnesota Rules*, part 1400.2410, and the Administrative Procedure Act, *Minnesota Statutes*, section 14.389. You may submit written comments on the proposed expedited rules until **4:30 p.m. on April 30, 2025**.

**Subject of the Expedited Rules.** The proposed expedited rules are about the specific medication variances that can be applied for by basic life support (BLS) ambulances. This rule as proposed would allow BLS ambulances to apply for variances that would allow anticholinergics by metered dose inhalers or nebulizers. Additionally other methods of administration of glucagon and epinephrine, including intranasal would be permitted.

**Statutory Authority.** The statutory authority to adopt these rules is 144E.011 Subd. 3 (1) and 144E.16 Subd. 4 (4).

The statutory authority to adopt the rules under the expedited rulemaking process is 144E.011 Subd. 3 (1).

Your comment should identify the portion of the proposed expedited rules addressed and the reason for the comment. In addition, you are encouraged to propose any change desired. You must also make any comments that you have on the legality of the proposed rules during this comment period. If the proposed expedited rules affect you in any way, the agency encourages you to participate in the rulemaking process.

Or the agency may adopt substantially different rules if it follows the procedure under *Minnesota Rules*, part 1400.2110. If the final rules are identical to the rules originally published in the *State Register*, the agency will publish a notice of adoption in the *State Register*. If the final rules are different from the rules originally published in the *State Register*, the agency must publish a copy of the changes in the *State Register*.

**Adoption and Review of Expedited Rules.** The agency may adopt the rules at the end of the comment period. The agency will then submit rules and supporting documents to the Office of Administrative Hearings for review for legality. You may ask to be notified of the date that the agency submits the rules. If you want to be so notified or want to receive a copy of the adopted rules or want to register with the agency to receive notice of future rule proceedings, submit your request to the agency contact person listed above.
