RE: Minnesota Department of Transportation's Rulemaking Docket and Official Rulemaking Record Submission

Dear Legislators:

This letter provides the annual submittal required by Minnesota Statutes, [section 14.116\(a\)](#), which states:

By January 15 each year, each agency must submit its rulemaking docket maintained under section 14.366, and the official rulemaking record required under section 14.365 for any rule adopted during the preceding calendar year, to the chairs and ranking minority members of the legislative policy and budget committees with jurisdiction over the subject matter of the proposed rule.

#### **Rules Adopted in 2025**

The Department completed three rulemakings in 2025.

First, the Department updated the incorporation by reference to the *Minnesota Vehicle Requirements for Special Transportation Services and Limousines* in M.R. 8840.5700 using the Good Cause Exempt Rulemaking procedures. The document itself has not changed since its original adoption in August 2023, just the link to access it.

Second, the Department updated the airport zoning standards in Chapter 8800. The amendments:

- aligned the rules with changes to Minn. Stat. Ch. 360;
- clarified and made minor modifications to the size shape, and land use restrictions of the commissioner's standard for airport zoning ordinances;
- replaced obsolete language regarding existing residential neighborhoods with new language protecting existing land uses provided in statute; and
- added new language regarding clear zone requirements.

Finally, the Department updated the rules governing for-hire limousine services and limousine permit requirements in Chapter 8880. The amendments addressed changes to the industry and the authorizing statute that occurred since the Department last amended the rules in 1994. Additionally, the amendments are intended to ensure the safety of passengers, clarify requirements, and ensure consistency with other commercial vehicle programs administered by the Department.
