### RE: Disaster Assistance Contingency Account Transfers and Payments

The purpose of this memo is to provide information about the current balance of the disaster assistance contingency account (DACA), transfers to the DACA from unused disaster appropriations and payments made from the disaster assistance contingency account in calendar year 2025, in accordance with the requirements under M.S. 12.221 subd. 6, M.S. 16A.286, and M.S. 16A.28 subd. 9.

#### Current Disaster Assistance Contingency Account Balance

As of January 1, 2026, the unencumbered available balance in the DACA was \$31,447,830.39.

#### Transfers to the Disaster Assistance Contingency Account

The DACA was last replenished in October 2025 when \$25,363,719.44 was transferred from the general fund to the account. Minnesota Statutes, section 16A.286 requires the commissioner of Minnesota Management and Budget (MMB) to transfer from the general fund to the DACA the difference between \$50 million and the balance in the DACA at the end of the biennium if the general fund final closing balance for the biennium exceeds the projected ending balance at the end of the previous regular legislative session by at least \$50 million. The statute directs MMB to make this transfer by October 15 following the end of the previous biennium. The fiscal year 2025 closing balance in the general fund exceeded the projected closing balance at the end of the 2025 legislative session by at least \$50 million. The DACA balance was \$24,636,280.56 on June 30, 2025, and as a result, \$25,363,719.44 was transferred from the general fund to the account on October 15, 2025.

During calendar year 2025, three transfers from two disaster appropriations totaling \$31,550.74 were made to the DACA in accordance with M.S. 12.221 subd. 6. No transfers were made under M.S. 16A.28 subd. 9. Individual amounts that comprise these totals can be provided by written request.

## Calendar Year 2025 Expenditures

The table below details spending from the DACA in calendar year 2025 in accordance with the requirement under M.S. 12.221 subd.6(d). A total of \$25,086,994 was allocated in 2025 for federal- and state-declared disasters. Of that amount and previous years' transfers, \$26,030,759 was expended in 2025.

The reason for the difference between the amounts transferred for specific disasters and the actual spending is cycle time. The typical fiscal life cycle for a state disaster, from declaration to closeout, is 18 months, and 72 months for a federal disaster. Once the Department of Public Safety's Division of Homeland Security and Emergency Management (HSEM) determines the amount to be spent on each event, they establish a specific disaster sub-appropriation and transfer the necessary amount from the disaster assistance contingency account. The amount transferred from the disaster account for each declared disaster is based on formal, on-the-ground, documented damage assessments and is not a general estimate. The figures are generally more accurate for state disasters, which are much easier to budget for because of their more limited scope and minimal changes to the project worksheets. The practice of establishing a separate appropriation for each disaster and setting aside the amount needed to pay the state's obligation gives a clearer picture of the progress towards closing out each disaster and knowing how much funding is available for future events.

The table below shows the disasters that received funds from the disaster assistance contingency account in calendar year 2025. Incidents named with an "SD" are state declared disasters and incidents named with a "DR" are federally declared disasters.
