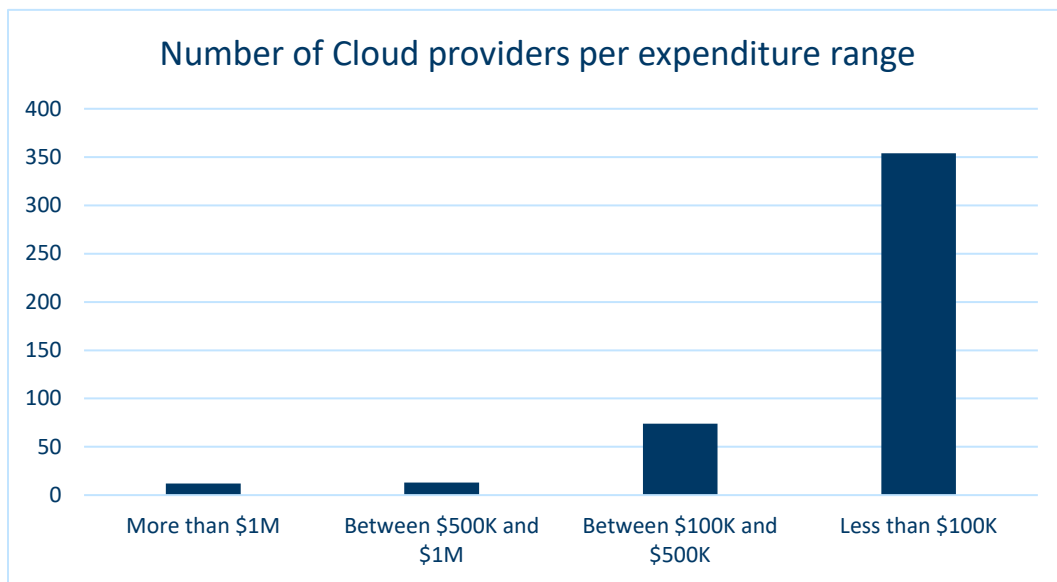

## I. Executive summary

This report provides information about Minnesota IT Services (MNIT) expenditures for FY2025 with our cloud providers. Additionally, this report includes information about FY2025 projects that leveraged cloud providers.

MNIT embraces a multi-cloud approach, with a primary cloud provider. This sets standards that reduce costs and improve efficiency for most solutions. MNIT's multi-cloud approach enabled us to partner with 453 cloud providers in FY2025 with engagements totaling over \$78 million. These individual engagements ranged in cost from small to more than \$500,000. Figure 1 below shows the number and the associated percentage of MNIT cloud providers for FY2025 by various expenditure ranges.

## II. Enabling Legislation

Minnesota IT Services (MNIT) presents this Cloud Computing Progress report in accordance with Minnesota State Statute [16E.03, Subdivision 5 \(a\)](#) which states:

- a) *No later than January 15, 2024, and annually thereafter, the state chief information officer shall, in consultation with the Technology Advisory Council, report on the progress of executive branch cloud adoption to the chairs and ranking members of the legislative committees with jurisdiction over executive branch information technology policy. The report shall include, but not be limited to, the following:*
- 1. an accounting of each state agency's expenditures for cloud computing initiatives and software as service solutions; and*
  - 2. cost projections, timelines, and the names of any cloud provider selected for current computing projects that incorporate cloud computing solutions, and percentage of total cloud use.*
- b) *This subdivision expires December 31, 2027.*

## III. Background

The State of Minnesota's Intentional Cloud Approach is our dedication to improve security and resiliency by moving to scalable, cloud-hosted infrastructure with innovative, modern capabilities. This approach embraces a multi-cloud environment while providing guardrails around certain services to focus processes, training, and strategic direction towards a common objective.

A primary provider is a common approach used by technology service providers to set standards that reduce support costs and improve efficiency, institutional knowledge, and service delivery for specific technology services. MNIT sets standards for primary providers regarding a variety of enterprise services, including email, server, workstation hardware, etc. Minnesota's primary cloud standard is flexible enough to accommodate exceptions for unique agency or service needs.

According to Gartner, 89% of organizations like MNIT work with only one cloud provider or have a primary cloud provider. This includes 61% that follow an approach like MNIT's with one provider considered as the primary cloud provider, and other providers used when hosted solutions or other strategic decisions dictate another path.

### Benefits of primary providers

- Efficiently train the State workforce in the technology and terminology of one environment. In 2022, over 1,000 MNIT employees started training to implement and use solutions from our primary cloud provider.
- Reduce the cost of setup and maintenance of cloud environments by leveraging economies of scale. This can improve the speed of innovation.

- Mature processes that are easily transferrable across the executive branch, reducing the risk that the state faces and removing friction points enterprise-wide.

**Minnesota's primary cloud standard is flexible and accommodates:**

- Data sharing options between cloud environments to accomplish agency goals.
- Software as a Service (SaaS) solutions leveraged in the partner's preferred environment if it passes MNIT's accessibility and security standards.
- An agency or partner that has business or technical needs that cannot be addressed by our primary cloud provider.

## IV. Cloud Computing

### MNIT's Expenditures in FY2025

The table below lists MNIT's cloud providers, expenditures for cloud computing initiatives and software as service solutions, and percentage of cloud expenditures for FY2025. This data excludes MNIT's Office 365 cost for our communication and collaboration suite.

**Note:** Expenditures to individual cloud providers of less than \$600,000 annually represent less than 0.79% of the total FY2025 expenditures and therefore are not significant enough to be included in this report.
