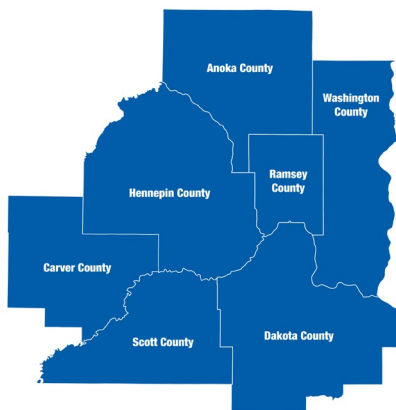

The Metropolitan Council is the regional planning organization for the seven-county Twin Cities area. The Met Council operates the regional bus and rail system, collects and treats wastewater, coordinates regional water resources, plans and helps fund regional parks, and administers federal funds that provide housing opportunities for low- and moderate-income individuals and families. The 17-member Council board is appointed by and serves at the pleasure of the governor.

Introduction

The Metropolitan Livable Communities Act (LCA) requires the Metropolitan Council to report to the Minnesota Legislature by February 1 of every year which municipalities elected to participate and which did not elect to participate in the local housing incentives account program (“Program”) for that calendar year (Minn. Stat. § 473.254, subd. 9).

About the Livable Communities Act

The LCA advances the policies within the Metropolitan Development Guide ([Imagine 2050](#)), including expanding housing choice by creating and preserving affordable housing, improving safety, and ensuring everyone can meet their needs within their community by connecting housing, transportation, and jobs. Cities and townships within the seven-county area that participate in the Program may receive grants from the three funding accounts of the LCA: the tax base revitalization account, the livable communities demonstration account, and the local housing incentives account. Further, only LCA-participating cities and townships may apply for and receive grants from the polluted sites cleanup program administered by the Minnesota Department of Employment and Economic Development. Finally, the law says the Council “shall give consideration to a municipality’s participation” in the Program when making discretionary funding decisions.

LCA Participating Municipalities

As detailed on the following page, 81 municipalities are participating in the Program in 2026. Every 10 years, the Council and participating municipalities re-negotiate affordable and lifecycle housing goals following the completion of the decennial updates to local comprehensive plans required under the Metropolitan Land Planning Act. In 2020, the Council and local governments negotiated affordable and lifecycle goals for the 2021-2030 decade. The primary requirement to participate in the Program is to adopt these goals locally. When cities do so by November 15, their participation begins the following year and continues through 2030, which is when the current goals expire. The list on page 4 of this report includes the cities and townships not participating in 2026. Figure 1 illustrates the geographic extent of participating cities and townships.
