Dear Senator Ranum:

The Minnesota Department of Human Rights (MDHR) submits a semi-annual report to the Legislature summarizing the results of its investigation and resolution of human rights complaints. A report detailing the Department's activities during the period of January 1, 2001 to June 30, 2001 is attached to this letter.

From January 1, 2001–June 30, 2001, MDHR closed a total of 683 cases, an increase of 10% over the previous reporting period. On June 30, of the 970 cases needing a determination, only 15 (1.5%) were older than 12 months. The average investigator caseload per enforcement officer (does not include the cases dismissed or resolved through mediation) remained low, at 25 cases per full-time equivalent.

Meeting our statutory directive to make a determination in a case within one year of filing, while maintaining manageable caseloads, remains a top priority. During this reporting period, the average time from filing to a determination of no probable cause was 328 days; from filing a probable cause determination was 365 days, including 12 split determinations where probable cause was found on one or more allegations.

The Legislature also tasked the Department to achieve 75% of Department dismissals within six months. I am pleased to report that during this reporting period, 88% of our dismissals were accomplished within six months of the charge filed date.

From January 1, 2001 to June 30, 2001, 84 cases (12% of the total number of cases filed) were referred to the Office of Dispute Resolution (ODR). During this time period, ODR returned 67 cases to the Department for investigation. A total of 42 cases were mediated, with 30 resulting in settlements.

During the reporting period, MDHR recovered a total of \$863,235 for aggrieved charging parties. In addition, MDHR has modified its procedures to promote increased use of predetermination settlements to expedite case processing and recovery of damages. Since January 1 of this year 27 cases have been satisfactorily resolved prior to a determination. This is an increase of 33%, compared to the preceding six months; 29 cases are currently involved in this process.

ALTERNATIVE DISPUTE RESOLUTION (ADR) PROJECT

ADR case activity during the period January 1, 2001, through June 30, 2001:

Cases referred to ADR:

84 cases (This is 12% of the number of charges filed during report period.) Cases are typically sent to ADR between 3 and 4 months from their filing date, only after the answer and rebuttal are received and the case is screened for merit.

None of the 84 cases referred were actually filed with the Department during the 1/1/01--6/30/01 report period.
