

THE NORTWEST REGIONAL DEVELOPMENT COMMISSION

The Northwest Regional Development Commission was created, February 8, 1973, by the Governor, in response to petitions from local units of government within the Region representing nearly 80% of the regional population. The Commission is organized under the Regional Development Act of 1969 which allows local units of government to petition the Governor to create a Commission within the officially designated regions.

The Northwest Region includes Kittson, Marshall, Norman, Pennington, Polk, Red Lake and Roseau Counties. This Region has some 288 units of local government including 7 counties, 58 cities, 229 townships and 37 school districts. These units of government are represented on the Commission in the following way: Each county has a county commissioner representing county government, a township supervisor representing the townships in the county, a mayor or councilman representing city governments in the county and in addition there are two people representing school districts in the Region. The NWRDC has also created ten commission positions for citizens representing various public interests.

The Full Commission serves as the policy making body which determines what the role of NWRDC will be and how the statutory responsibility of the Commission will be carried out. The Board of Directors is responsible for Commission operations on a month to month basis and functions as the review board for clearinghouse activities. Planning and development activities of the Commission are carried out by committees which are organized to provide for geographic representation and to draw upon the expertise that exists within the area.

Prior to the creation of RDC's, local governments had little opportunity to participate in areawide decisions because the decision making structure was fragmented and related primarily to narrow functional programs of state or federal agencies, not local government. The Regional Development Act is the tool local governments use to expand their involvement in areawide planning, coordination of areawide programs, and research to shift the orientation of areawide decisions from a state/ federal program perspective to a local perspective addressing locally identified needs and blending these areawide programs into the ongoing programs of local governments.

REGIONAL DEVELOPMENT ACTIVITIES FERGUS FALLS HOSPITAL STUDY

In 1975 the Minnesota State Legislature authorized and funded two Citizens Advisory Task Forces to study the future utilization of Fergus Falls State Hospital. The Northwest Task Force representing the counties of Region I - Kittson, Marshall, Norman, Pennington, Polk, Red Lake, and Roseau - and Mahnomen County, was paralleled by a similar Task Force in Region IV. Combined the two Task Forces represented the service area of Fergus Falls State Hospital. The Northwest Task Force was appointed by the Northwest Regional Development Commission and function as a committee of the Commission.

In carrying out its mandate the Northwest Task Force adopted six objectives consistent with legislative expectations. Summarized, the objectives were to:

- 1. Identify current chemically dependent, developmentally disabled, and mentally ill populations in the study area.
- 2. Project future populations in the three disability groups.
- Determine the most appropriate manner of providing community-based services to the populations.
- 4. Develop innovative approaches to deinstitutionalization in addition to community-based care.
- 5. Develop recommendations on the funding and administration of service/treatment programs.
- 6. Establish recommendations on the future utilization of Fergus Falls State Hospital.

These objectives were addressed from the point of view of people, what services they need and what kind of system could respond to those needs.

Recommendations were developed for improving the mental health delivery system which focused on mental health programs/services, program funding, and on the future utilization of Fergus Falls State Hospital. These recommendations are made in the context of improving upon what the Task Force found to be an already good service delivery system.

Major problems with the implace system of mental health services were 1) fragmentation of services due primarily to categorical funding; and 2) the inability of the system to be flexible enough to be able to respond to local priorities.

In its report to the Legislature, submitted January 2, 1977, the Northwest Task Force recommended that: community based programs be expanded as an effective alternative to institutionalization. Funding should flow to the counties for purchasing non residential services for the chemically dependent, developmentally disabled and mentally ill according to local priority needs; and categorical funding for programs should be intergrated at the state level and passed on to the counties in block grants for this purpose. Services should be offered on an 'open market' basis with user fees covering all costs and funds following the person rather than flowing to the institution. Planning for the services and the allocation of funds should be done under the policy control of the counties consistent with a state system of standards/guidelines for services. The Fergus Falls State Hospital has been serving the Northwest region very well. The principal problems with the state institution has been the decline in population from about 2,000 to approximately 500 at the present time. The Northwest Task Force expects that the population will continue to decline as the impact of community programs grows. However, it is expected that there will be an ongoing need for the type of service offered at the State Hospital for a small percentage of people from the Northwest region. No recommendations were made on whether or not the State Hospital should be phased out because that decision should be made by the State. However, it appears that the main problem with closing any state institution is how to find a new home for the staff, not what to do with the patients of the institution.

Recommendations were submitted to the Legislature January 2, 1977. A second report will be prepared during the first half of 1977 dealing with the data which was collected for the study.

A final report was prepared for submission to the 1977 Minnesota State Legislature in coordination with the Region IV Task Force.

In the coming year there will be legislative hearings on the report in order to complete the task of providing information to the Legislature as it considers the issues involved in providing appropriate, responsive and accountable mental health services to the citizens of Minnesota.

ECONOMIC DEVELOPMENT

The NWRDC was funded by the U.S. Department of Commerce, Economic Development Administration during late 1976 to begin an analysis of the economy of the Region and develop an Overall Economic Development Program (OEDP). The OEDP will identify the area resources for economic development and propose a strategy for the development of those resources and the creation of new private sector jobs.

Region I has a rapidly growing labor force which appears to be growing faster than the number of new jobs created each year. If the areas resources can be tapped to increase the rate of new job development, the area will be able to avoid the tragedy of high unemployment. Persistent high unemployment is a potential problem in Region I during the mid 1980's and persistent high unemployment usually results in out migration from the rural areas. NWRDC believes the potential exists within the areas strong agricultural resource to expand the areas economy enough to utilize the great manpower resources in labor force.

The Commission assisted several local units of government in developing their economic programs (area OEDP) and projects. Most of this assistance was either information gathering or technical advice. At the request of the City of Winger for example, an economic profile was developed to assist the community in attracting outside investment to construct a Whey processing plant. Local project development activities of this nature will be emphasized in the Commission's economic planning program in the upcoming year as development priorities are determined and implementation programs are formulated.

REGIONAL DEVELOPMENT GUIDE

The NWRDC completed "Phase I" of the Regional Development Guide in July of 1976. This marked the completion of the first year of a two year program to develop the Guide which has been funded in part by a grant received from the Upper Great Lakes Regional Commission.

The purpose of the Regional Development Guide is to consolidate information on current planning programs, maps, adopted policies and programs of the NWRDC into one document. The Regional Development Commission will use this document to guide its operations in implementing the Regional Development Act. Local units of government and interested citizens will be able to use the Regional Development Guide both as an information resource document and to become aware of the activities of the RDC in meeting areawide needs. It is hoped that this Guide will be helpful in making the resources of the Commission more accessible to the people and local governments of the Region.

Contained within ''Phase I'' of the Guide is information about the general character of the Region such as transportation, land use, housing, economic development, manpower, and natural resources. Phase II of the Guide will be completed in July of 1977 and will address physical, social and economic development priorities outlined by the Commission including policies and recommendations for programs. The Guide will be presented to local government and the general public at a public hearing prior to adoption by the NWRDC.

The Guide will be refined annually and is the document which is intended to meet the requirements of the Regional Development Act which calls for the adoption of a comprehensive development plan.

WATER QUALITY

The Northwest Regional Development Commission (NWRDC) established the Water Quality Management (WQM) Advisory Committee on November 23, 1976, in accordance with Section 208 of the Federal Water Pollution Control Act of 1972. The goal of this Act is to restore all of the nation's waters, wherever feasible, to at least 'fishable and swimmable'' quality by 1983. Each state must work out a ''plan of action'' by November of 1978 which will assist that state in achieving the 1983 goal. The Minnesota Pollution Control Agency (MPCA) has been designated by the Governor as the agency charged with the responsibility of coordinating the State WQM planning effort.

The primary function of the WQM Advisory Committee is to identify Region I's water quality problems especially non-point pollution problems and recommend ways in which the pollution sources might be dealt with. In addition, the WQM Advisory Committee is responsible for establishing and maintaining mechanisms for stimulating local citizen participation during the entire State WQM planning process. The activities of the WQM Advisory Committee are part of a statewide planning program, mandated by the Federal Government, designed to clean up the nation's waters.

The structure of the Committee consists of a maximum of 21 voting members who are appointed by the NWRDC Board of Directors and ex officio members who are appointed at the discretion of the Committee. The Committee members represent a fair cross section of elected officials of Cities, Townships, Counties, Soil and Water Conservation Districts, Watershed Districts, state and federal agencies and public interest groups from within the Region.

At this writing, the Committee is in the process of becoming formally organized with the first meeting to take place in early January, 1977. Initial areas of concentration include Committee orientation and internal organization; development of an active Citizen Participation Program and development of a work plan for 1977.

The Committee's recommendations will be used by the State Plan Development Task Force at the state level in formulating Minnesota's Water Quality Management Plan.

Housing

Region I has a shortage in the general supply of housing units; a very high percentage of old housing units and a shortage in the number of subsidized units for the low income and elderly. In addition, with traditional energy supplies diminishing and costs rising rapidly, many people are finding it difficult to afford to live in their own homes.

The NWRDC has attempted to address this situation over the past year by actively working to help make a variety of state and federal housing programs available to the residents of the Region.

The Commission has established an allocation plan to ensure an equitable distribution of home improvement grant funds within the seven counties, available through the Minnesota Housing Finance Agency. In addition, several housing information workshops were conducted, along with extensive media coverage, in order to acquaint builders, bankers, homeowners, public officials and the general public with available resources to meet their housing needs.

The NWRDC is cooperating with several state and federal agencies that administer housing programs in developing a State Housing Allocation Plan so that programs compliment each other rather than conflict or duplicate. Hopefully this effort will result in a comprehensive approach by governmental agencies in the administration and implementation of programs. Housing programs can then be ''packaged'' to meet the particular housing needs of an area.

The housing planning activity of the Commission has been moving toward the development of a regional housing plan. This activity is funded in part by a grant from the U.S. Department of Housing and Urban Development '701'' Program. The purpose of this plan will be to identify housing needs of the Region and available housing resources and to establish ongoing programs of action to efficiently meet housing needs in an equitable manner. This plan is scheduled for completion in June of 1977 and will be reviewed through the public hearing process prior to formal action by the Commission.

REGIONAL ARTS TASK FORCE

The Northwest Regional Development Commission established a Regional Arts Task Force in cooperation with the Minnesota State Arts Board during 1976. The Arts Task Force is still in its developmental stages and will produce its first work plan early in 1977. The principle roles of the group are to facilitate local Arts development, to assess the need for various types of Arts programming in the Region, and to review and make recommendations on grant applications for Arts projects. Information gathered up to this point by the Task Force indicates that there is a great deal of interest in Arts programming within the Northwest Region. However, very little state or federal funds for the Arts are currently being spent in the Northwest Region. State and federal grants for Arts programs have traditionally gone to urban and metropolitan areas and it is hoped that this Task Force will be able to assist in getting some of those funds to flow into our rural area.

The Task Force will complete a needs assessment for Arts programming in Region I early in 1977. This will lead to the development of a plan or strategy for action to meet identified needs.

LAND USE

The Regional Commission's role in land use planning is limited to an analysis of changing land use patterns, identifying competing land uses and estimating total land needed for new development. The Commission has no regulatory authority but serves as a source of information and technical assistance.

The major regional land use concerns which have been identified are the preservation and protection of agricultural land, water management which addresses drainage, flooding and water supply issues and public land management. Urban development occupies only about .4% of the land in Region I and as a result urban land use issues are generally local issues.

The Commission is funded by the U.S. Department of Housing and Urban Development "701" program to complete a land use plan for the Region. This plan will describe area wide land use problems within the Region and will recommend alternatives for their solution. The plan will also assess the impact of growth and development on the land. Policies to guide decision making regarding area wide land use issues will be a part of the plan which is scheduled for completion in August 1977.

MANPOWER PLANNING

The NWRDC does manpower planning under a contract with the Governor's Manpower office. The purpose of this agreement is to decentralize manpower planning functions from the state to the local level. During 1976 the Regional Commision planned for the expenditure of approximately \$700,000 for Manpower needs. This funding came from the Comprehensive Employment and Training Act (CETA) Title I, for the purpose of training and employing people. Other funding, (approximately \$800,000) under title II and VI of CETA also came into the region and was distributed to the counties for public service jobs.

The Commission has appointed a Regional Manpower Advisory Committee (RMAC) which serves as the planning group for manpower programs. The RMAC role is to, 1) identify and document area manpower needs, 2) recommend a system of manpower servers designed to meet local identified needs on a priority bases within the limits of available resources and 3) to monitor and evaluate on-going manpower programs.

For 1977 the RMAC has recommended that the follwoing groups receive priority for CETA services. Veterans, minorities, female head of households, youth (14-21), older workers (55+), public offenders, and Welfare recipients. The RMAC is recommending that 87% of the CETA Title I funding be used for classroom training, on the job training, work experience and supportive services. The remaining 13% should be allocated to operate an "In School youth program" to provide work experience for economically disadvantaged youth.

In 1976 the Region I manpower program provided summer employment for 602 youth, part time work for 145 disadvantaged young people in school, and employment for disadvantaged older workers (55 +) as well as training and work experiences to upgrade the skills of 1800 people in other priority categories.

TELECOMMUNICATIONS

About two years ago the Northwest Regional Development Commission and Headwaters Regional Development Commission organized a non-profit corportation, Northwest Telecommunications, to develop telecommunication services in the two Region area. Both Regions view communications as a vital link in rural development activities and established Northwest Telecom to address three basic objectives: 1) to expand commercial television coverage to those areas not now receiving American television; 2) to expand public television coverage to serve everyone in the 12 county area; 3) to establish a broadband telecommunication network as a service delivery system for health, education business, criminal justice, government and others.

It is believed that the potential impact of telecommunication services will be comparable to that of rural electrification and rural telephone, perhaps much greater.

The year 1976 saw additional progress made in the telecommunications project. A feasibility report was completed for Northwest Telecommunications, Inc. containing a summary of: the problems encountered by the service providers on the solutions that telecommunications might offer; a summary of the complimentary telecommunication facilities in place in the Project Area; a proposed telecommunications system; a projected price for the proposed system; a compilation of some promising funding sources; and a staff organizational plan for the future. The feasibility report was intended to serve as a guide and as a point-of-departure for the development of future telecommunications capabilities in the Project Area.

During the year, three new cable television systems went on the air in the 12 county Project Area: Mahnomen, Middle River, and Bagley. In addition, three more franchises are in various stages of development: Greenbush, Red Lake Falls, and Fosston.

The State Department of Transportation is experimenting with a concept that would allow current weather and road conditions to be displayed on the time-and-weather channel on the cable television systems. The system in Bemidji is the first in the Project Area to participate, but interest has been demonstrated in other cities as well.

During November, a conference on rural telecommunications was held in Washington, D.C. and was attended by Rusty Hastad from the Commission and Rod Belsheim for the Northwest Telecommunications staff. The Office of Technology Assessment (and arm of the U.S. Congress) sponsored the conference in an effort to gain more understanding of integrated telecommunications systems. An integrated system (such as the one proposed by Northwest Telecommunications) is one that is usable by more than one service agency; one that would be useful to providers in health, education, mental health, law enforcement, social services and others. Northwest Telecom could very well be the only organization in the nation that is attempting an integrated system at this time.

Planning is underway in the Project Area for participation in a demonstration in continuing medical education through the Mayo Clinic. The demonstration will involve a transmission from the Mayo Clinic to the CTS satellite and a portable Earth Station in the Project Area to receive the signal.

In 1977, considerable efforts will be extended to obtain major systems financing for public services from such sources as the Office of Telecommunications Policy, Energy Research and Development Administration, the Minnesota Energy Agency, the USDA Rural Development Service, and others.

THE REGIONAL TRANSPORTATION PLANNING COMMITTEE

The Regional Transportation Planning Committee has been organized for two years. The Committee was created to attempt to identify transportation problems which were areawide or regional in nature and to recommend a strategy for resolving these problems.

During 1976 the Committee began to focus on five modes of transportation, rail, transit, pipeline, air and highway. The Committee set up a series of public hearings to solicit comments from the general public as well as from industry and government, on problems in each of these five modes. Testimony obtained at these hearings, as well as information gathered from a survey of business and industry, will be used in formulating testimony to the Minnesota Department of Transportation early in 1977. The Minnesota statutes creating the Department of Transportation require each Regional Development Commission to prepare a regional transportation policy plan. The NWRDC expects that a policy plan will be adopted during 1977 based upon the research and public input the Transportation Committee has completed.

The Tansportation Committee is also responsible for reviewing major transportation proposals and assessing the impact other development may have on the areas transportation system.

TECHNICAL ASSISTANCE

Technical assistance or local government assistance provided by the NWRDC falls into essentially four categories, grantsmanship, planning, information and special project assistance. This assistance is available upon request within the limits of staff time.

The NWRDC role in grantsmanship is limited to assisting the applicant by providing information on state/federal grant programs, deadlines, special requirements, and in many cases, supplying application forms. NWRDC staff will assist the applicant in providing supporting data and other necessary information and will review the application for completeness. During 1976 some 80 applicants were given assistance by NWRDC.

Planning assistance is usually provided to build up local government's capacity to carry on its own planning or is available on a contract basis to local governments for short term planning projects. During 1976 Polk County contracted with NWRDC to do a four month planning study for Community Health Services. This is a study which is done to identify needs and to establish priorities for a state subsidy grant for Community Health Services. It is anticipated that four other counties will consider contracting with NWRDC to assist them in Community Health Services planning during 1977.

Other planning assistance has been in the form of short term technical assistance to communities and townships to assist them in formulating planning programs, zoning ordinances, development plans, etc. Five communities, one township and two counties were assisted during 1976.

NWRDC provides information to people in the Region upon request. Some examples of information which is frequently sought are: demographic data, names of contact people in various state or federal agencies, housing programs, statistical data on the areas economy, its labor force, etc. Information requests are a daily occurrence at NWRDC.

The fourth category of technical assistance the NWRDC gets involved with is special projects. These are short term efforts designed to assist a local government, group or even person resolve a problem with state or federal government. During 1976 NWRDC was involved in two special projects. The first was brought to the attention of NWRDC by the Northwest Regional Library which was concerned by proposed state rule and regulations.

A state agency was proposing rules which would increase the service area of regional libraries and get the state involved in administration matters relating to staff size, hours of operation and other matters. NWRDC studied the matter, developed a position paper in support of local control and assisted in getting the state agency to drop its proposed rules. Area Legislators, persons from the State Planning Agency and others participated.

The second special project involves three counties of Region I having problems in classifying and managing public lands. The counties had over the past several years been working with the Minnesota Department of Natural Resources in classifying public lands to their highest and best use and then disposing of those lands which were agricultural. There were problems in the classification process and the counties felt they would be more successful if they tried a coordinated approach in dealing with DNR. NWRDC was contacted and agreed to assist in the effort. Legal advice was sought and NWRDC was advised that some contradictions in the existing statutes should be cleaned up as a means of resolving the counties problems. It is expected that a bill will be prepared for submission to the Legislature in 1977 to help resolve this problem.

COMMUNITY HEALTH SERVICE ACT

planning study

The Minnesota Community Health Services Act of 1976 authorized planning grants and state subsidies for the purpose of defining, developing and maintaining integrated community health services under local (county) administration. The Polk County Board of Commissioners applied for a planning grant in November, 1976, and a grant was awarded by the Minnesota Department of Health for the period of December 1, 1976, through March 31, 1977. The Polk County Board then contracted with NWRDC to administer the grant and perform the work necessary to preparation of a comprehensive county community health services plan. During December, an inventory of existing health services was begun, Advisory Committee members selected and a mailing list was compiled. During January, 1977 a series of provider and consumer questionnaires will be distributed to gather information on current and future health care needs in Polk County. Using the services inventory and the questionnaire data, the Advisory Committee will establish community health care priorities and prepare a plan to meet those priorites. If this plan is approved by the Minnesota Department of Health, Polk County will be eligible to apply for approximately \$91,000 per year in health care subsidy monies. Services eligible for state support include emergency medical services, public nursing services, and environmental and sanitation services.

coordination

Regional Development Commissions are granted certain review/coordination powers under M.S. 462.391 and under parts I and IV of the Federal Office of Management and Budget Circular A-95.

The general purpose of these reviews is to attempt to bring programs and services with regional impact which are funded by the State or Federal Government grants or loans into harmony with each other, to prevent duplication, and to make those programs consistent with the programs of local governments.

During 1976 NWRDC operated as a regional Clearinghouse for grant and loan review. This system is to review all applications for state and federal grants or loans to determine the extent to which a proposed project duplicates, runs counter to, or needs coordination with other projects or programs; the extent to which it might be revised to increase its effectiveness or efficiency and to determine the program's consistency with state and federal environmental policy.

The Commission uses a project notification system for the review process in which notifications are sent out to agencies, groups or individuals who are or may have an interest in the proposed program, soliciting their comments. If there are negative comments the Clearinghouse can call a conference between the applicant and others interested in the program to attempt to resolve the problems.

This function provides for agency and public input into the development of new programs in the Region.

During 1976 the NWRDC strengthened its review function considerably by expanding the number of contacts made on projects and by conducting a more thorough analysis by Commission staff. NWRDC Clearinghouse reviewed 110 projects during 1976. The Clearinghouse can simply choose to make either a positive or a negative review on projects. NWRDC has chosen in many cases to write detailed comments which describe the findings of the Clearinghouse. Included in this report is a listing of projects reviewed. The Clearing comments are categorized as: supportive, conditionally supportive, or conditional. Projects with conditional comments are those in which the Clearinghouse has found some need for additional coordination of the project before funding.

The Clearinghouse has begun an effort to evaluate projects after they have been funded and operating to gain a better understanding of the operation of areawide programs.


