## CHAIRMAN'S LETTER

Even though the concept of regional development commissions has not always been well accepted in parts of Region 5 and in the state as a whole, we have attempted to make best use of its resources in our area. Local technical assistance is still the backbone of our efforts. It is far more important to us to respond to local needs than to react to programs or plans from the state or federal level.

During the past year, we, as local government officials in Region 5, began to establish long term goals to guide us in decision making. Those goals recognize the dignity of the individual citizen and his or her involvement in decisions of government, particularly at the local level. Most important is the fact that the goals came from County Commissioners, Mayors, Councilmen, School Board Members and Township Officers. The next step will be to transfer our goals into action in all program areas, to strengthen local control, to build up the economy of the Region, and to enhance the quality of life in Region 5.

As part of our response to local need, we have begun a program of Personnel Management Consulting for four of our counties, a jail study will begin for three counties, and assistance will be offered to all local governments, schools, and health care facilities in energy conservation in buildings.

In the past year, we strengthened internal management through a new accounting system called an Indirect Cost Plan. Also, thanks to help from the State Planning Agency, our work program was developed with more measureable objectives and work elements. This gives us a better tool for evaluating the effectiveness of our work and the staff who carry out our directives.

Finally, I would like to take this opportunity to thank the Commission members for their support, regular attendance at our meetings, and interest they show in our activities. The same holds true for the advisory committees. They work hard and give a great deal of time to the programs we operate. The staff also deserve our appreciation for their service and patience as we deliberate issues in our Region.

Our motto for the future must be to "*serve local needs and demands*" as we work together on common problems for the Region. Together, we build our individual strength.

## THE REGION

Natural amenities abound in Cass, Crow Wing, Morrison, Todd and Wadena Counties, yet each is unique in its own way. The last ice age brought glacial drifts, outwash areas and a variety of soil types which has created patterns of use for the land in these five counties. Agricultural use is more appropriate in some parts of the Region and forest in other areas where the acid soils have encouraged heavy stands of timber. The basins left by huge glaciers gave us many lakes and streams which attract the city dweller to life or recreation "up north".

Past and present changes in both the physical and human environment have resulted in a mixed economy. The leading resources for livelihood have been agriculture, tourism, and forestry products.

Some problems of the Region are not dissimilar to problems in other rural areas of the nation. We import more in dollar value than we export. The job base is seasonal, thus creating higher levels of unemployment.

Unlike some rural areas, however, the population in Region 5 is increasing. Greater demands are made for services and pressure for development of the natural environment areas is increasing.

Separate and uncoordinated solutions to these problems must be avoided. All the components of both the public and private sector need to be engaged in a comprehensive effort to strengthen development for the future. The task is long range. The report which follows, outlines the activity of the Region 5 Regional Development Commission for 1979 to draw together the local governments in a joint effort of solving present problems and planning for the future.





## ECONOMIC PLANNING AND DEVELOPMENT

Planning activities and local assistance for Economic Development in Region 5 are funded primarily by the Federal Economic Development Administration (EDA); other support includes the local levy and HUD 107 funds. Region 5 Regional Development Commission's strategy to affect economic development as a designated EDA District involves the following components: 1) economic development planning; 2) capacity building at the local level to provide the basis for economic development projects; 3) technical assistance and grantsmanship on specific economic development projects; 4) promotion of inter-governmental cooperation and coordination on local, regional, state and federal programs.

The Overall Economic Development Plan was approved by EDA, and designation as an Economic Development District was received in August 1979. Analysis of the problems and potentials of the forest, agriculture and tourism sectors is the focus of the planning program for FY80.

Local assistance is a major emphasis of the Region 5 Economic Development program. Assistance is provided upon request to communities interested in economic development, existing businesses seeking to expand and business prospects considering location in Region 5.

The 18-member Economic Development Advisory Committee reviews planning activities and advises the Commission on economic development issues.



## LAND USE/WATER QUALITY PLANNING



The Minnesota Water Planning Board completed the report entitled "Toward Efficient Allocation and Management: A Strategy to Preserve and Protect Water and Related Land Resources." The Region 5 Land Use/Water Quality Advisory Committee reviewed background material for the plan as submitted by the Water Planning Board. The plan was presented for public hearing in May.

For the past three years the Minnesota Pollution Control Agency (MPCA) has been in the process of analyzing non-point sources of pollution. Ten non-point source topics were identified by the MPCA:

- Agriculture
- Construction Activities
- Feedlots
- Forestry
- Highway De-Icing Chemicals
- Mining
- Pesticides
- Roadside Erosion
- Urban Runoff
- Residual Wastes

The Committee and the Commission participated in the development of the Minnesota Water Quality Management Plan by reviewing material presented on each of these topics. The draft plan was presented for public review and comment in November.





## HOUSING



In May 1978, the Commission submitted an Areawide Housing Opportunity Plan (AHOP) to the Department of Housing and Urban Development (HUD). The purpose of the plan was threefold. The first section was a description of the housing stock in the Region coupled with a thorough needs analysis. Secondly, an Allocation Plan was developed. The Allocation Plan was a recommendation for distribution of housing resources by county and in some instances, by municipalities. The Allocation Plan presented percentage distributions and suggested numbers of units as targets for fulfilling the need identified. As housing programs are implemented, the Plan will require evaluation and consideration for redistribution, perhaps annually.

The final section of the Plan set forth housing production and program targets as well as goals, objectives and strategies in relation to the housing need in the Region.

After considerable review on the part of HUD, the Region 5 AHOP was not accepted. However, the Allocation Plan has been extremely useful in terms of reviewing applications for housing units from not only HUD, but Minnesota Housing Finance Agency (MHFA) and the Farmers Home Administration (FmHA).

A complete update of the AHOP cannot proceed until the 1980 Census is completed and the information becomes available. However, the methodology for calculating county and municipal priorities for assisted housing units allows for updates as information is received on the number of new units completed.

## EMPLOYMENT PLANNING



Region 5 is responsible for monitoring Employment and Training Programs in the 5-county area, developing and submitting a plan to Rural Minnesota CEP, (the CETA Prime Sponsor for a 19-county area in Northern and Western Minnesota). The objective of the plan is to identify target groups for employment and training services and to ensure the utilization and coordination of all employment and training services.

Major employment concerns in Region 5 include seasonal employment and low median income. Employment services targeted in the plan to address these problems include: high school equivalency, vocational occupational classroom training, on-the-job training, work experience, job placement and vocational assessment.

The 19-member Regional Employment Advisory Committee monitors employment programs, assists in plan development and advises the Commission and Rural Minnesota CEP on regional employment concerns.



## COMMUNITY HEALTH SERVICES



The Cass-Todd-Wadena-Morrison Community Health Services Board contracts with Region 5 for administrative services to the four-county program. Region 5 provides secretarial services to the Board of Health, Executive Committee, Advisory Committee and Administrative Task Force; compiles the four-county fiscal reports, budgets and budget revisions; and provides technical assistance to county public health directors upon request.

The Community Health Services program is funded by the Minnesota Department of Health. Annual plans are submitted to request funds for the following areas: community nursing services, home health services, health education, disease prevention and control, emergency medical services, environmental health and administration. County priorities and goals are determined through a public meeting process. Individual county health committees meet throughout the year to plan service delivery.

Crow Wing County operates a single county Community Health Services program similar to the four-county program.



## SPECIAL PROJECTS



Several of the local Housing and Redevelopment Authorities in the Region operate the HUD Section 8 Rental Assistance Program. To qualify for this rental assistance a family must meet certain eligibility requirements in terms of income. The unit to be rented must also meet requirements such as quality and rental price. This rental price guideline or "Fair Market Rent" (FMR) is set for every county in the nation by HUD.

A study was initiated in Cass, Todd and Wadena Counties because many of the HRA's in those counties had difficulty in finding units to rent that met the FMR. The survey found that 68% of all units were above the **FMR**.

After the report was issued the FMR structure was changed twice. The original problem has been mitigated, however the situation will continue to be monitored closely.





## TRANSPORTATION/TRANSIT



Transportation issues in Region 5 are reviewed by the Transportation Advisory Committee. The Committee has monitored the MN/DOT planning process and examined issues such as the Great River Road, inter-county highway numbering, potential rail abandonments and public safety. The Committee advises the Commission on all A-95 reviews of transportation projects.

Assistance has been provided on transit projects in Crow Wing County, Brainerd and other communities.



## SOCIAL DEVELOPMENT PLANNING



The Commission decided that the planning efforts for social development should be targeted to meet specific needs of the local units of government which it serves. As a result, several differing projects were initiated and/or completed.

- 1) A five-county survey of public buildings and facilities regarding their accessibility for the handicapped was completed, and the results of this study were published. In addition, the Commission is continuing to provide technical assistance to local units of government in the area of Handicapped Accessibility.
- 2) Technical assistance was also provided to the social service agencies in all five counties for the purpose of developing a method to evaluate and monitor the delivery of social services purchased by the counties. A performance review mechanism was also developed for the Wadena County Social Service Agency.
- 3) An informational Data Bank system is currently being developed to provide accurate and up-to-date data for local units of government.
- 4) A study of the jail systems in Morrison, Todd, and Wadena Counties is being initiated to determine the most feasible approach to the problems of incarceration in this multi-county area.



## ARTS



The main activities of the Arts Council for 1979 have been:

Producing a monthly arts newsletter.

Holding two workshops: One on grants and one on publicity and tax exempt status for organizations.

Granting funds. Funds granted for the year amount to \$16,591 and went to the Brainerd Area Arts Alliance, Madhatters of Wadena, Heartland Symphony Orchestra, Morrison County Historical Society, Musician's Residency Foundation of Merrifield, and the Cross Lake Community Center. The grants to the Morrison County Historical Society was for artists' drawings of historical buildings in the area and was the first grant for the state with an architectural basis.





## AREA AGENCY ON AGING



The Tri-Regional Area Agency on Aging is administered by Region 5 Regional Development Commission for social services grants let in Region 5, 7E, and 7W that assist elderly persons in their endeavor to maintain an independent way of living.

In 1978, the older Americans Act, which governs the operation of Area Agencies on Aging, was amended, consequently affecting the operation of the Tri-Regional Area Agency of Aging. Part of the amendments mandated that the Area Agencies on Aging administer the congregate meal program. For the Tri-Regional program, this meant the cost benefit of a single administrative office for several regions was no longer as attractive as it had been in the past.

A transition plan was implemented July 1, 1979, that will, by December 31, 1979, cause Region 5 to become a single designated Area Agency on Aging as well as become the administrator of the Nutrition Project in Region 5 which is let to a Community Action Program.

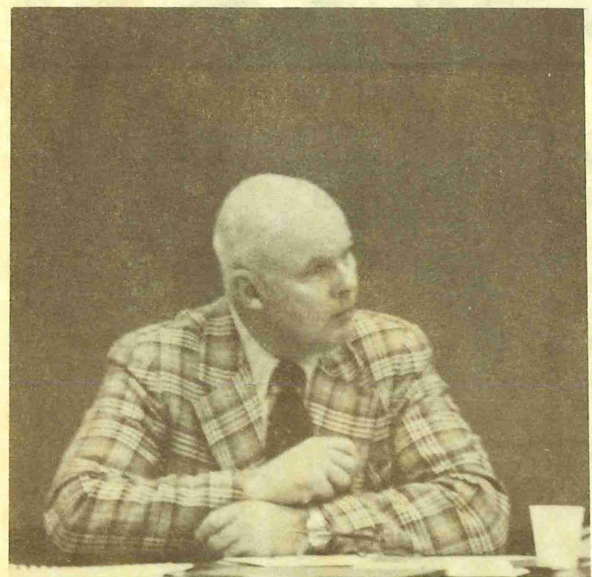
During 1979, \$130,000 were let in federal funds by the Region 5 Regional Development Commission for grants to agencies within Region 5. Major priorities addressed were in-home health services, information and referral, and county coordinators on aging.

## COMPREHENSIVE PLANNING

The Commission has decided to initiate a comprehensive planning process for Region 5. Its goal is to develop a planning guide which can be used as a basis for all A-95 reviews and which clearly reflects a consensus of public opinion regarding the direction our economic, physical and social planning should take. The planning guide will consist of goal statements, specific policy guidelines, and a method to coordinate existing plans within this overall framework.

## REGIONAL CLEARINGHOUSE REVIEW

The Region 5 Regional Development Commission in 1975 was designated by the Governor of Minnesota as the "clearinghouse" for the five county area of Central Minnesota. Regional clearinghouses are required by the Federal Office of Management and Budget under Circular A-95, and are set up to facilitate the coordination of state, regional and local planning and development efforts. As a clearinghouse, the Commission is empowered to review and comment on local project applications requesting, federal and state grants and loans.

*The A-95 review process has been developed to:*

- a) encourage the coordination of state and federally funded and assisted programs with local and area-wide plans and programs
- b) eliminate duplication and inefficiencies in proposals
- c) provide an opportunity to local persons/agencies to review and comment on proposals before they are funded

*In addition to the authority granted the Commission under Circular A-95, the Commission is also granted the following powers under the Regional Development Act of 1969:*

- a) review and comment on long-term comprehensive plans of local governmental units within the Region
- b) review and comment on plans of independent boards and commissions having multi-county or multi-community impacts, for conformance with regional plans and policies.
- c) review and comment on applications for federal and state grants or loans made by governmental units, independent commissions, boards or agencies within the Region by governmental units, independent commissions, boards or agencies within the Region

Upon receipt of a project notification, the Commission contacts local units of government, agencies and individuals that may be affected by or interested in the project, and requests their comments. Once these comments are received, the Commission provides a final review of the project. The project applicant is then responsible for sending the application, along with all comments, to the potential federal or state funding agency.

The Regional Clearinghouse Review procedure does not guarantee or deny the funding of a project; rather, it provides the potential funding sources with an idea of the impact that the project may have within the Region.
