The Board provides uniformity in the regulation of boxing through the preparation, amendment and adoption of rules and regulations governing the conduct of boxing, the time and place thereof, enforce regulations, assist at professional bouts with weigh-ins and dressing room surveillance so as to ensure safety of the participants and provide properly staged show for the fans.

Section 1. 341.115 New Law passed by state legislators in 1982 Any contest, match or exhibition in which cash prizes of \$5 or more or other prizes worth \$100 or more are offered to any boxer shall comply with all rules of the board of boxing governing professional boxing. For purposes of this section, tropnies, travel expenses and subsistence expenses shall not be considered prizes. No boxer participating in these contests, matches, or exhibitions shall engage in consecutive contests with less than a seven day interval. No boxer shall participate in these contests, matches, or exhibitions unless the boyer has submitted an affidavit of physical fitness to the board and has been examined by a physician designated by the board. The affidavit shall state: (a) that the boxer has previously participated in ten amateur or professional matches sanctioned by the board of boxing or sanctioned by a board which regulates boxing in another jurisdiction; or (b) that the boxer has regularly trained for at least 90 days under the supervision of a second licensed by the board of boxing, or a second or trainer or the equivalent licensed in another jurisdiction. The examination shall include, but not be limited to, an electroencephalogram, unless the boxer has submitted to the examining physician (a) the results of an electroencephalogram administered within one year of the contest, match or exhibition; and (b) an affidavit stating that the boxer has not been knocked unconscious in boxing competion since the last electroencephalogram was administered. The examination shall be performed at the expense of the promoter.
