CHAIRMAN'S REPORT

July 1, 1984

It has been my pleasure to serve as Chairman of the Region 5 Regional Development Commission for almost three years. During these years I have seen this agency continue to develop and maintain useful and viable programs that meet local and regional needs. This is due in large part to the strong and committed leadership of the local elected officials that serve on the Commission. The entire membership of the Commission as well as the Board, Advisory Committees, and staff are listed in the following section. This report covers the period of July 1, 1983 through June 30, 1984. It summarizes the programs and assistance provided by Region 5.

Once again Region 5 is pleased to report the receipt of several Small Cities Development Block Grants by local communities:

A total of 35 grants were made (out of 135 applications) in the state for a total of \$18,079,447. Grants in Region 5 represent 20% of the total awarded. Region 5 staff wrote the Browerville and Long Prairie applications and provided limited assistance on the remaining two. In addition Region 5 staff wrote a successful Small Cities Economic Grant for Staples which was funded in May at \$250,000.


We are proud of the contributions we have made in the past year and will continue to place the needs of local communities as top priority in the coming year.

AREA AGENCY ON AGING

The Minnesota Board on Aging has designated the Region 5 Regional Development Commission as the Region 5 Area Agency on Aging. The planning and service area for the Area Agency on Aging includes the counties of Cass, Crow Wing, Morrison, Todd and Wadena.

According to the Older Americans Act of 1965, as amended, the overall purpose of the Area Agency on Aging is to plan for and coordinate the development of needed services for older persons. To guide the activities of the Region 5 Area Agency on Aging during 1984, 1985 and 1986, a three-year Area Plan on Aging was developed. Based on this plan, Table 1 shows the services which are projected for 1984 within Region 5.

To assist the Area Agency on Aging, the Region 5 Advisory Committee on Aging recommends action on grant applications, plans and other activities. The Region 5 Regional Development Commission takes final action on all grant awards and major activities.

During calendar year 1984, approximately \$520,000 was awarded for the provision of 183,750 congregate meals and 58,500 home delivered meals. In addition, approximately \$188,000 was awarded to provide a wide variety of supportive services, such as home health aide, adult day care, legal education, and respite care. An amount of \$33,689 was also awarded for the development of senior centers; this money was allocated to the Region 5 Area Agency on Aging by the McKnight Foundation.

In summary, the counties of Region 5 contributed \$144,298 toward these programs, and older persons themselves donated over \$315,000 in cash to help defray the overall costs of these services. A listing of funding information for Region 5 during 1984 is located in Table 2.

Several important projects and activities were either initiated or completed during the year. The second Annual Conference on Aging was held in Brainerd, focusing on chemical health and how this relates to older persons; the Region 5 Area Agency on Aging is continuing its efforts to inform older persons about potential chemical abuse. A survey is currently being conducted to determine how many local physicians are assisting older persons in filling out insurance forms; information is also being collected and compiled regarding the acceptability of medicare assignment as full payment for services. A report is also being developed regarding meals services for older persons in Region 5.

ARTS PROGRAM

The Region 5 Arts Program awarded \$3,000 of McKnight Foundation funds for semi-professional arts organizations. Also awarded were \$14,874 of Minnesota State Arts Board grant funds which are for the development of arts activities in the Region. The organizations which received these funds are listed in Tables 1 and 2.

The Five Wings Arts Council reviews all applications for both state and private foundation funds, then recommends to the Commission those projects which it feels should be funded and at what level of funding. The Five Wings Arts Council assists the Region 5 Arts Program staff in the planning and implementation of special programs and workshops designed to improve the capacity of local arts groups.

The Region 5 Arts Program staff provides technical assistance to individuals and groups on such matters as grants writing, availability of funds, resource lists, and other technical help with arts projects. In 1984 the arts program presented workshops in watercolor and oil painting and a workshop in art education methods for elementary teachers.

The Region 5 Arts Program will have approximately \$14,000 of state funds for granting to local arts groups in fiscal year 1985, \$5,000 of McKnight funds and \$9,300 of Blandin Foundation funds.

COMMUNITY HEALTH SERVICES

The Cass-Todd-Wadena-Morrison Community Health Services Board contracts with Region 5 for administrative services to the four-county program. Region 5 provides secretarial services to the Board of Health, Executive Committee, Advisory Committee and Administrative Task Force; compiles the four-county fiscal reports, budget revisions; and provides technical assistance to county public health directors upon request.

The Community Health Services program is funded by the Minnesota Department of Health. Annual plans are submitted to request funds for the following areas:

- Community Nursing Services
- Home Health Services
- Health Education
- Disease Prevention and Control
- Emergency Medical Services
- Environmental Health
- Administration

County priorities and goals are determined through the public meeting process. Individual county health committees meet throughout the year to plan service delivery. The four county Board of Health, Executive Committee, Advisory Committee and Administrative Task Froce also meet to monitor activities and joint projects. In 1984 special projects included the development of a copmputer program for public health agencies, operation of the Cass-Todd Hypertension Program; implementation of the Cass-Morrison Sanitarian program; and receipt of a Maternal Child Health Services grant in Cass County.

Crow Wing County operates a single county Community Health Services program similar to the four-county program.

DEVELOPMENTAL DISABILITIES

Developmental Disabilities are handicapping conditions which have an onset before the age of twenty-two, which are life-long in duration and which interfere with normal day-to-day activities and employment. Common disabilities include mental retardation, cerebral palsy, epilepsy, autism and accident or disease related handicaps. It is estimated that about 2.75 percent of the population, or about 4,000 people in Region 5, are developmentally disabled.

Depending on the particular disability, the disabled person can face a confusing array of services. During a lifetime, a typical developmentally disabled person may receive special services from their local school system, county social service and health departments, state departments of health, public welfare and vocational rehabilitation, and from Federal programs such as Social Security and Legal Services. Special programs also exist for particular groups such as the sight and hearing impaired, the non-ambulatory, the mentally retarded and so forth.

With such a variety of services and agencies, it is not unusual for the disabled person or the parent of a disabled person to feel confused about where to start seeking assistance. Similarly, service providers may feel the need to make connections with other providers in order to make referrals and to prevent wasteful duplication of services. It is the role of the Region 5 Developmental Disabilities Advisory Committee and staff to provide information, promote coordination and cooperation, identify gaps and overlaps in services and to offer technical assistance with new problems and to develop new services. The Region 5 Developmental Disabilities Program helps to unify what otherwise can be a rather fragmented system of services.

During 1984, the Region 5 Developmental Disabilities Program concentrated on providing behavior management training to staff at Developmental Achievement Centers. Additionally, the program focused on developing new vocational opportunities for developmentally disabled people living in the community. Other areas of effort included printing of a Products and Service Catalog for regional Development Achievement Centers, publication of a highly successful regional newsletter (DD RESOURCE), proposal development and grant writing, and technical assistance with various problems varying from government regulations to research on census information.

ECONOMIC AND COMMUNITY DEVELOPMENT

The Region 5 Economic and Community Development program includes the operation of assistance programs to local government and businesses in the areas of community development, economic assistance, technical assistance and planning.

Community Development assistance this past year included preparation of several comprehensive Small Cities Development Block Grants (SCDG) for local governments. The 1984 SCDGs awarded for projects in Region 5 are: Browerville Redevelopment Project; Long Prairie Community Water System; Cass County Housing Authority; Remer Community Development. Grants in Region 5 represent 20% of the total amount of \$18,079,447 awarded in the state.

Economic assistance programs involved a series of acitivities. Region 5 aided in the preparation of several Economic Development Grants, Urban Development Action Grants, a Park and Recreation Planning Grant, and several Capital Improvements Plans.

Planning and technical assistance continue to be a major commitment of Region 5 staff. Planning assistance was provided by staff in a variety of projects including such diverse areas as transportation, park and recreation, natural resources, solid waste management, economic development, housing and lake shore management. Technical assistance also encompasses a wide variety of areas including zoning administration, fire district mapping, township road recording, comprehensive planning, school district mapping, and a variety of other projects.

The Community Development Advisory Committee advises the Commission and staff on planning activities, review of local projects and overall program efforts in the areas of economic development, agriculture, forestry, tourism, housing and natural resources.

The chart on the following page summarizes the major technical assistance and grants writing projects completed in the past year by Region 5 staff. In addition, assistance was provided to many local units of government, businesses and community groups.

FIRE MAPS

TRANSPORTATION PLANNING

The Commission, through its Transportation Advisory Committee (TAC) has continued to monitor Local, State, and Federal transportation programs and legislation that have regional significance. The Commission has also participated in efforts to improve the major highway transportation links in Region 5.

During the past year the TAC undertook a comprehensive review and update of the Transportation Plan. The updated plan now includes more data on the four major modes of transportation in Region 5 as well as goals and policies in the four modes.

Region 5 has continued to provide technical assistance to the local units of government in the area. Technical assistance projects in the last year have included assisting townships with road recording and assisting the communities along Highway 10 in their attempts to have the four lane construction completed. In addition, Region 5 has assisted communities in studying the impact of railroad abandonment and other transportation problems. The Region 5 Regional Development Commission has continued to act as a liaison and make recommendations to the Minnesota Department of Transportation and the legislature on issues that impact transportation services in Region 5.

ROAD INCONSISTENCY STUDY IMPLEMENTATION

In 1982-1983 a special study was conducted by the Region 5 Transportation Advisory Committee on problems created by inconsistent road signage, load limits, and road and bridge characteristics which exist between counties on adjoining County State Aid Highways in Region 5.

During the past year implementation of the recommendations of the study began. The individual counties have begun changing county road signs to ensure consistency between counties. Currently the TAC is working on methods of implementing the regional routes proposed in the study. The implementation of route systems will probably be completed in the near future.

PROJECT REVIEWS

PROJECT REVIEW SYSTEM

The Region 5 Regional Development Commission was designated by the Governor of Minnesota in 1975 as the "clearinghouse" for the five-county area of central Minnesota. Regional clearinghouses under the authority of Executive Order 12372 (replacing Circular A-95), State Regulations and the Regional Development Act review and comment on local project applications requesting federal and state grants and loans through a process entitled Project Review System (PRS).

The PRS process was developed to: a) encourage the coordination of state and federally funded and assisted programs with local and area-wide plans and programs; b) eliminate duplication and inefficiencies in proposals; c) provide an opportunity to local persons/agencies to review and comment on proposals before they are funded.

In addition to the authority granted the Commission under Executive Order 12372, the Commission is also granted the following powers under the Regional Development Act of 1969: a) review and comment on long-term comprehensive plans for local governmental units within the Region; b) review and comment on plans of independent boards and commissions having multi-county or multi-community impacts, for conformance with regional plans and policies; c) review and comment on applications for federal and state grants or loans made by governmental units, independent commissions, boards or agencies within the region.

Upon receipt of a project notification, the Commission contacts local units of government, agencies and individuals who may be affected or interested in the project, and requests their comments. Once these comments are received the Commission completes a final review of the project. The Final Review comment is then forwarded to the State Clearinghouse along with a copy of all responses received. The State then forwards the Region 5 comment along with the State comment to the appropriate federal funding agency.

The Regional Clearinghouse Review procedure does not guarantee or deny the funding of a project; rather it provides a vehicle for informing, collecting and forwarding comments on projects that may have an impact within the region. On the following pages is a listing of all projects reviewed by the Commission for the period from July 1, 1983 through June 30, 1984.
