Report from ARDC Chair, Marilyn Krueger

Dear Friends,

We celebrated our fifteenth anniversary with a new look, a new address, and a hard hitting appraisal of economic development in NE Minnesota

In February, Congressman James Oberstar introduced an economic growth appraisal and readjustment strategy performed for ARDC by the Fantus Company. Fantus is perhaps the most acclaimed business relocation firm in America, and their hard analysis of the Arrowhead region shows why. Critical in the best professional sense, the appraisal identifies our assets and exposes our developmental liabilities, and offers sensible and constructive recommendations to deal with them. The upshot is that we now know how we are seen by the national business community, we have five targeted industry groups we know we can satisfy, and we have realistic recommendations to keep us on target.

To strengthen our role in this readjustment we've created a new technical assistance group called NORTHSPAN. NORTHSPAN is private, non-profit, and a direct affiliate of ARDC. This affiliation means that Arrowhead communities and other NE Minnesota clients can get a blend of private and public professional services tailored to move projects. Expect NORTHSPAN to be agile, competitive, and responsive to local clients.

We've also organized a community assessment team that visited ten communities and helped three evaluate the strengths and weaknesses of their development programs. We're organizing a regional shippers' association to reduce freight costs through consolidated shipments and backhaul loads. And we've tasted our first success in federal contract procurement—a national defense contract for Garon Knitting of Duluth, secured by ARDC staff. Our immediate intention is to make this help available to industries throughout the Arrowhead Region.

ARDC has also been streamlined. The Emergency Medical Services Association begun under ARDC auspices is now on its own—as an independent association of emergency medical providers. Starting in 1978, ARDC guided the association through planning and development phases that culminated in the implementation of a \$500,000 advanced life support system for NE Minnesota.

But we are still active in health care. Our seven county long-term care project will create a cost-effective system of community based care that supports the independence of disabled seniors via in-home services, congregate housing and case management. In addition the planning and financial assistance available through ARDC's Aging Program helped make new senior centers a reality in Biwabik, Aitkin and Barnum.

Our series of conferences on current problems, FOCUS-90, continued in 1984 with a symposium on the potential for mini-steel production in NE Minnesota. A session in September will deal with local success stories in small community development. Stories like how construction of one plant in Virginia spurred expansion at another; or how the Town of White, Aurora and Hoyt Lakes earned the first multi-community Minnesota STAR CITY designation; or how International Falls is rallying to respond to a crisis.

I know the stories because our staff is behind the scenes on so many of them. They have been for fifteen years. The IMPACT is evident in this report. Thanks for taking the time to read it, and please stop in to see us and enjoy our new look at Arrowhead Center.



IMPACT'85

There were major investments in the Arrowhead Region last year. Whether it was directly funding a senior center in Barnum or packaging the State's first multi-city Star Cities designation for Aurora-Hoyt Lakes, ARDC was in the thick of it.

The figures below, measured from July 1, 1984 through June 30, 1985, are provided to help demonstrate the level of ARDC's involvement in local and regional projects. Our involvement is as varied as the investments and projects themselves. Sometimes straightforward, often complex and critical, our role is seldom incidental. It is to help counties, cities and development groups put together projects that accomplish what they want...and need. It is to make their projects fundable. It is also to work with local entrepreneurs and established businesses to develop financing packages that increase the applicant's chances for success. And this works two ways, because it not only provides the funding agencies with professionally prepared applications, but also gives them a better shot at sound project investments, which maximizes their impact and minimizes their risk. All of which serves to strengthen and encourage the financial interaction between state, federal and local sponsors that is so important to economic readjustment.

There is no question that a good deal of money would be invested in NE Minnesota with or without ARDC playing its part. Projects would be funded, loans would be made, jobs would be created. But in a time when resources are becoming ever more scarce, and so competitively sought out, every project has to be carefully constructed. And each investment in the local economy has to be a quality investment, so that each new job has the best chance of being a permanent one. That's where ARDC has made a difference.
