Clause a: GENERAL STATEMENT OF BOARD ACTIVITIES

This description should cover both FY 89 and FY 90 and include any changes (additions/deletions) in activities between those years.

The Board of Boxing provides uniformity in the regulation of boxing through the preparation, amendment and adoption of rules and regulations governing the conduct of boxing.

The Board, consisting of 7 members appointed by the Governor, enforces the regulations governing boxing and assists at all professional bouts with weigh-ins and dressing room surveillance. It licenses all promoters, managers, referees, seconds and professional boxers to provide for the safety of the participants in the ring and to assure the fans of properly staged shows. This sport, in Minnesota as elsewhere, subscribes to the World Boxing Association regulations, and, on a professional level, requires cooperation on a national scale through the various state commissions. The Board members are commissioners.

The Board encourages the organization of amateur boxing programs throughout the state. There are 800 to 1000 amateur boxers active in the state of Minnesota. They range in age from ten to thirty six. The amateurs are not licensed. The legislators considered amateur boxing as a civic and community function, similiar to high school athletics such as football, baseball, basketball, etc.

There are no exams given, but clinics are held at licensed locations by licensed coaches throughout the state.

Full Contact Karate is a dangerous sport, because the opponents are allowed to knock each other unconscious by "Kicking" also besides hitting.

Kick Karate is under close supervision of the Boxing Board and has almost become extinct due to the safety precautions the Board makes them follow. The State of Minnesota is known nationally as a state that is fully supervised and regulated.

Safety is number one in the State of Minnesota at all ages. Amateur Boxing, Professional Boxing and Kick Boxing.



The professional boxers must sign an affadavit stating how many bouts they have had, that they have been active, and are physically fit to receive a license on the night of the boxing show. They are examined and weighed in before the show and pay the fee of \$5.00 either to renew their previous license or receive a new one.The professional boxers from out of state may not fight in Minnesota till they have been checked out with their home state commission, and a computer system out of New Jersey by the executive secretary. (The Board has given him the power to decide if they are qualified to fight.) There are <u>3</u> professional <u>Managers</u> between the ages of 35-59 they are all from Minnesota.

There are <u>10</u> professional <u>Referees</u> between the ages of 35-59 (9) and <u>1</u> between the ages of $\overline{60-65}$ they are all from Minnesota.



Professional, Amateur, and Kick Boxing is held in high regards nationally, and carries a good reputation throughout the United States for the excellant environment it provides.

Boxers appearing in Minnesota have appeared in nearly 40 of the 50 states. Also, Canada, Africa, and Europe.

Past History:

- 1. Amateur Boxing has changed over the years, and much for the better.
- 2. All coaches and referees must be registered with the State Boxing Board.
- 3. It is now mandantory for all amateur boxers to wear head gear in all amateur events.
- 4. All amateur events are supervised by a Commissioner or a Deputy Commissioner.
- 5. Amateur boxing is to give each participant a chance to condition themselves and to have a healthier body and mind, and to give them a chance to compete in a sport where they are matched with competitors with the same ability, same weight class, same age bracket. Not all sports programs offer this.
- 6. Our purpose is not to develop professional boxers, the goal is to build sportsmanship, and to develop self confidence and discipline.
- 7. Most of the amateur boxers are between 12 and 20 years of age, and come from all walks of life, and all nationalities, and are all treated as equals.
- 8. As in any sport, comaraderie and competition and self confidence developes which can carry them over into life.
- 9. There has been a decline in amateur boxing in the State of Minnesota due to high insurance cost. The Board of Boxing emphazises safety first in Minnesota. The Board feels that quality bouts are better than quanity, where as an amateur boxer could risk injury.
- 10. Amateur boxing is a program to help the youth of the state, and does not receive any Eederal Money.
