#### Clause a: GENERAL STATEMENT OF BOARD ACTIVITIES

The Minnesota State Board of Medical Examiners has been given the following responsibilities:

### 1. Licensure to Practice Medicine and Surgery

### A. FLEX Written Examination

The FLEX examination, a three day examination, was adopted by the Board in December, 1971 and is the examination used by all states within the United States. It is also used by Puerto Rico, the District of Columbia and the Province of Saskatchewan.

The FLEX score of 75.0 on each part is the passing score used by all states, including Minnesota. The examination is given in June and December. This examination is in two parts, each 1 1/2 days long.

### B. FLEX Examination Other States

The Board has authorized the office to accept application on the basis of FLEX examination taken in other states in lieu of taking our written examination of applying on the basis of reciprocity. Many of these applicants are international medical school graduates.

### C. Reciprocity

Minnesota has reciprocity with all other states having examination requirements equal to or greater than Minnesota's. This means Minnesota will accept exam scores from other states, but does not guarantee licensure.

#### D. Endorsement of National Board of Medical Examiners

One normally becomes a Diplomate of the National Board of Medical Examiners by taking Day 1 (basic science subjects), as a second

year medical student, Day 2 (clinical science subjects), as a fourth year medical student and Day 3, (clinical competence), as a first year resident. This is the basis on which most United States graduates and many Canadian graduates are licensed in Minnesota.

### E. Endorsement of National Board of Osteopathic Examiners

Since the Board of Osteopathy was merged with the Board of Medical Examiners in 1963, the only license the Doctor of Osteopathy can obtain in Minnesota is the license to practice medicine and surgery; the same license as issued to the Doctor of Medicine. They may apply on the basis of reciprocity, examination or the National Board of Osteopathic Examiners.

### F. Endorsement of Medical Council of Canada

Minnesota Session Laws 1977, Chapter 7, authorized the Board to grant licenses to licentiates of the Medical Council of Canada.

### 2. Endorsement of Certification to Other States

During the two-year period, July 1, 1988 to June 30, 1990, 105 Minnesota licentiates used their Minnesota license to obtain licensure by reciprocity in other states. In addition to the above endorsements, thousands of certifications are made to the Drug Enforcement Administration, hospitals, drug companies and so forth.

### 3. Professional Corporations

During the two-year period, July 1, 1988 to June 30, 1990, 110 new corporations were formed, bringing the total of corporations formed since the original law was passed in 1951 to 1316. The number of corporations registered is 760, as of June 30, 1990.

#### 4. Temporary Licenses

A temporary license to practice medicine can be issued until the next Board meeting if all requirements for a full licensure have been met. From July 1, 1988 to June 30, 1990, 606 temporary licenses were issued.

### 5. Physical Therapy

Physical therapists have been registered in Minnesota since 1953. Physical therapists may be registered on the basis of having passed the Assessment Systems, Inc. (ASI) exam, the Professional Examination Service (PES) examination or the American Registry of Physical Therapy Examination (no longer available).







Clause q: The following numbered cases are summaries of individual complaints that were pending on the biennial report for July 1, 1986 through June 30, 1988 involving allegations of sexual contact between a physician and a patient. These include the following in their respective numbered sections:

- 1.A listing of the allegations.
- 2. Findings of investigation or a statement that the investigation is "in progress."
- 3.A listing of the steps the Board has taken in acting on the case.
- 4. Statement of disposition.
- 5. Rationale for disposition.

#### Cases #1-#4

- 1.Allegation that physician engaged in sexual misconduct by inappropriate touching and comments to a patient. Another patient alleges physician coerced her into having sexual intercourse. Sexual misconduct allegation is combined with report restricting physician's medical staff privileges because of poor medical practices and PADS report indicating higher than anticipated prescribing of controlled substances.
- 2.Investigation revealed credible complainants and recommended disciplinary conference with the physician.
- 3. Discipline Committee review, AGO investigation, re-review by Discipline Committee, full Discipline Committee appearance.
- 4.Stipulation and Order requiring permanent surrender of physician's Minnesota license and prohibiting physician from reapplying for licensure in Minnesota or any other state in which physician is licensed. If physician seeks license renewal in any state, Board may reopen file. Reference to sexual misconduct is deleted.
- 5.In the interest of bringing the matter to a settlement and avoiding a contested case proceeding, the Discipline Committee agreed to drop reference to sexual misconduct in the statement of the facts but to require permanent surrender of Minnesota license.

- 1. Allegation that physician engaged in sexual misconduct with patients by inappropriate sexual touching and requests for sexual favors. Sexual misconduct allegation combined with allegations of unprofessional conduct, inability to practice medicine with reasonable skill and safety to patients by reason of alcohol abuse, and failure to cooperate with the Board's investigation.
- 2. Investigation supported allegation, and physician denied allegation.
- 3. Discipline Committee review, AGO investigation, full Discipline Committee discussion, Discipline Committee appearance.
- 4. Stipulation and Order that physician resign Minnesota license and not reapply for Minnesota license. If physician seeks Minnesota relicensure, Board may reopen investigation.

5. The Board has probable cause to proceed, but the complaints, all of which are contested, may be unresolvable due to the passage of time. Respondent denies all complaints, no longer resides in Minnesota, and represents that he has retired from practice in Minnesota.

## Case #6

- 1. Allegation that physician engaged in sexual conduct with a patient which is sexual, including intercourse.
- 2. Investigation substantiated the allegation.
- 3. Discipline Committee review, AĞO investigation, Discipline Committee conference, interim stipulation, and required psychiatric evaluations by a consulting psychiatrist and a psychologist.
- 4. Stipulation and Order restricting physician's license: physician restricted from any sexual conduct with a patient, required to undergo psychotherapy and boundary training, required to meet quarterly with a Board member, and required to pay a civil penalty of \$2,400.
- 5. Allegation substantiated. Physician admits sexual relationship with complainant.

## Case #7

- 1. Allegation that physician had been dating a patient and was sexually active with this patient.
- 2.Investigation revealed that physician admits to dating the patient. Sexual allegation substantiated. Psychiatric evaluation concluded no evidence of psychiatric disorder.
- 3. Discipline Committee review, AGO investigation, Discipline Committee conference, psychiatric evaluation, second Discipline Committee conference.
- 4. Stipulation and Order reprimanding physician, requiring physician to pay Board costs (\$2,369.02), and requiring notification to Board and completion of boundary issues course if physician returns from retirement to active practice.
- 5. Allegation substantiated.

#### Case #8

- 1. Allegation that physician was sexually inappropriate with a patient by hugging and making inappropriate comments.
- 2. Investigation revealed a dispute of facts between the patient and the physician.
- 3.Discipline Committee review, initial and follow-up AGO investigations, full Discipline committee discussion, full Discipline Committee conference, required boundaries discussion meeting, second full Discipline Committee discussion, and second Discipline Committee appearance.
- 4.Dismissal.
- 5. Allegations were not substantiated.

#### Cases #9\_#12

- 1. Allegation that physician engaged in sexual misconduct with six patients by inappropriate touching and being excessively rough during pelvic examinations.
- 2. Investigation revealed six credible witnesses and and a physician who denies the allegation.
- 3. Discipline Committee review, AGO investigation, Discipline Committee conference.
- 4.Stipulation and Order which prohibits sexual conduct with a patient, prohibits pelvic exams unless attended by a female nurse, requires reports from supervising physicians, requires follow-up interviews with physician's women patients, requires physician to meet quarterly with a Board member, requires physician to pay a civil penalty of \$3,000, and requires the physician to complete a sexual attitude assessment seminar and a pelvic exam seminar.
- 5. Six credible and unrelated witnesses describe essentially similar but separate occasions of sexual misconduct by the physician.

#### Cases #13-#19

1. Allegation that physician engaged in sexual misconduct by making sexual advances toward a patient through inappropriate touching. Two other patients allege physician failed to have a female

attendant present, as required by physician's Order. Several other complaints of a variety of allegations are outstanding.

2. Investigation results are indeterminate.

3. Discipline Committee review, AGO investigation.

4.Pending.

5.N/A.

#### Case #20

1. Allegation that physician sexually assaulted a patient while the patient was under hypnosis.

2. Investigation revealed a patient who claimed the case was one of mistaken identity and that the incident had not occurred. The patient wished not to meet in person with the investigator.

3. Discipline Committee review, AGO investigation.

4.Dismissal.

5. Patient recanted initial allegation and wished not to meet in person with the investigator.

### Case #21

1. Allegation that physician is sexually involved with one of his patients.

2.Investigation supported the allegation.

- 3. Discipline Committee review, AGO investigation, full Discipline Committee conference.
- 4.Pending.

5.N/A.

#### Case #22

1. Allegation that physician was having a sexual relationship with a patient.

2. Investigation revealed a dispute of facts between the patient and physician but confirmed numerous sexual encounters.

3.Discipline Committee review, AGO investigation, mental and physical examination, and Complaint Review Committee conference appearance.

4.Stipulation and Order prohibiting physician from engaging in sexual contact with a patient; restricting practice to a group practice approved by the Board; requiring a female nurse or assistant to be present at all times when physician examines female patients; requiring counseling with a Board-certified psychiatrist or psychologist; requiring boundary issues training; requiring a meeting with the Board, six months after the date of the Stipulation and Order, to review patient care; requiring physician to pay a civil penalty of \$9,000; and requiring physician to notify Board if physician returns to Minnesota to practice medicine.

5. Allegation was substantiated.

## Case #23

1. Allegation that physician was sexually inappropriate with male patients by looking at them in a seductive way and rubbing himself in the groin area in their presence.

2. Investigation revealed a dispute of facts between the physician and the patient.

3. Discipline Committee review, AGO investigation, full Discipline Committee discussion, and Discipline Committee appearance.

4.Dismissal.

5. Allegation not substantiated.

## Cases #24-#25

1. Allegation that physician made inappropriate sexually connoted remarks to a patient.

- 2. Investigation revealed a complainant who is reluctant to press the investigation and a physician who denies the allegation.
- 3.Discipline Committee review, AGO investigation, full Discipline Committee discussion, Discipline Committee member one-on-one discussion with physician regarding boundary issues.

4.Dismissal.

- 4.Dismissal.
