In accordance with Minnesota Statutes Sections 3.195 and 214.07, copies of this report were delivered to the Legislative Reference Library, the Governor and the Commissioner of Health.

Clause a: General Statement of Board Activities

The following activities of the Board of Nursing continued during FY97 and FY98:

- Approval of nursing education programs preparing for licensure of registered nurses and licensed practical nurses.
- Licensure and registration by examination and interstate endorsement of registered nurses and licensed practical nurses.
- Registration renewal including continuing education requirement.
- Registration of public health nurses.
- Authorization of nurse practitioners and clinical nurse specialists in psychiatric and mental health nursing to prescribe drugs and therapeutic devices.
- Verification of licenses to other states and agencies.
- Processing disciplinary complaints.
- Registration of nursing firms (corporations).
- Maintain lists of professional nursing organizations which meet specified criteria and have authority to certify advanced practice registered nurses as certified clinical nurse specialists, certified nurse midwives, certified nurse practitioners and certified registered nurse anesthetists.
- Participation in the HIV and HBV prevention program (M.S. 214.17-214.25).
- Participation in the Health Professionals Services Program (M.S. 214.31-214.37).

Although no new authorities were given to the Board of Nursing during FY97-98, the Board undertook the following activities in order to maintain and improve its communication with and responsiveness to licensees, complainants and other interested consumers:

- Developed a general information brochure about the Board of Nursing.
- Attempted unsuccessfully to amend the Nurse Practice Act.
- Began development of a web site on the Northstar network.

- Developed Nurseline, an on-line system used to verify the licensure status of any Minnesota nurse, in cooperation with Communications Media Division, Minnesota Department of Administration.
- Updated the Board's licensure computer system for more efficient service to applicants and licensees.
- Began the development of a computer system for the processing of complaints, monitoring of cases and creation of reports.
- Implemented a process to determine the need for a statute and/or rules on the topics of delegation by nurses, professional-personal boundaries and advanced practice registered nursing.
- Spoke to approximately 60 nursing, employer, other health professionals and other groups about the Nurse Practice Act.

The Board of Nursing continued its strong involvement in the work of the National Council of State Boards of Nursing, Inc., the voluntary organization made up of the 61 boards of nursing throughout the United States and territories. Board and staff members held elected as well as appointed positions and participated in the development of licensing examinations, a disciplinary data bank and a multistate licensure system.

Members also attended meetings and supported the activities of the Council on Licensure, Enforcement and Regulation (CLEAR) and the Citizen Advocacy Center (CAC).

Approved programs are surveyed for continued compliance with applicable Minnesota Rules at least once every ten years. During FY 1997, two professional and three practical nursing programs were granted renewal of approval based on survey. One professional and one practical nursing program were placed under special Board oversite because of low pass rates for first time candidates on the licensure examination. One other practical nursing program was removed from Board monitoring because it successfully raised its pass rate on the licensure examination.

During FY 1998, two professional and one practical nursing program were granted renewal of approval based on survey. The two programs placed under Board oversite during 1997 raised their pass rates on the licensure examination. These programs were removed from Board oversite; monitoring of the programs will continue for at least one more year. One professional and two practical nursing programs were placed under special Board oversite because of low pass rates for first time candidates on the licensure examination. This oversite will be for at least one year.

All professional and practical nursing program directors attested to compliance with all applicable rules during FY 1997 and FY 1998.
