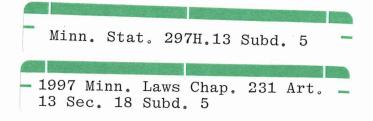
SOLID WASTE MANAGEMENT TAX

This is the second of three reports on the receipts from the solid waste management tax, as required by Minnesota Statute 1997, Section 297H.13, Subdivision 5. The table on Page 3 shows the solid waste management tax figures for the period May 1, 1998, through August 31, 1998.

This report also includes revised figures for the period January 1, 1998 through April 30, 1998, based on line-item reports we ran December 2, 1998. The original line-item numbers are subject to change as a varying number of tax returns routinely undergo further processing and editing. The total of the revised figures now more closely match the dollar amounts that were actually deposited from the solid waste management tax (SWMT), SCORE tax (sales tax on waste management services), and solid waste generator assessment (SWGA) lines.

Along with the SWMT amounts, we have also included the following for your convenience:

- Receipts for the period May 1, 1998, through August 31, 1998, from both the SCORE tax and the SWGA for waste management services received prior to January 1, 1998, and
- A chart giving
 - ⇒ The total receipts for two periods, January 1, 1998, through April 30, 1998, and May 1, 1998, through August 31, 1998, for the SWMT, SCORE tax & SWGA.
 - \Rightarrow Total amounts deposited for the two periods for SWMT, SCORE tax, & SWGA.

Note: Please see the appendix to the first report for information regarding the enactment of Chapter 297H, solid waste management tax, the requirement of three reports, an overview of the solid waste management tax, an explanation of the solid waste lines on the ST-1 return, the history of solid waste taxes, and the use of revenues.
