URBAN INITIATIVE BOARD

Report to the Minnesota Legislature, 1998

Minnesota Statutes 116M.17, subd. 4, requires the Urban Initiative Board to "... submit an annual report to the legislature of an accounting of loans made... including information on loans to minority business enterprises, the impact on low-income areas, and recommendations concerning minority business development..." The Department of Trade and Economic Development provides administrative support to the Board and this program.

An eleven-member Board oversees this program. The board consists of three state agency leaders and eight public members appointed by the Governor. Currently, this board is composed of the following members:

The Urban Initiative Program was created in 1993 to strengthen minority enterprise development, encourage private investment, create jobs for minority and other persons, and promote economic development in Minneapolis, St. Paul, and eight inner-ring suburbs. It does this primarily by making loans to new and expanding businesses in these cities.

Urban Initiative loans are made through a network of fourteen certified nonprofit organizations (see **Appendix 1**). These organizations received grants which they match equally, using funds from private, non-government sources. These pools of state funds and private money are used by the nonprofit organization to make loans from \$10,000 to \$300,000. The businesses eligible for these loans include technologically innovative industries, value-added manufacturing, and information industries. Micro enterprises, which generally employ less than five people, are also eligible for loans from \$1,000 to \$10,000. These micro enterprises can include retail businesses.

Individuals and businesses operating in one of ten cities targeted by statute, apply directly with one of the organizations noted above. The organizations carefully consider the application, the nature of the business and management, its potential for success and repayment, and its projected impact on the community. If the application is given initial approval, it is forwarded to DTED for final consideration by the Commissioner.

1998 Activities

In calendar 1998, 59 loan applications were received and 52 proposals were approved totaling \$868,791 in state funds (see **Appendix 3** for details). Seven applications were withdrawn or the initial approval was canceled. One loan - Quality Select Personnel - has been paid off. The state contributed an average of \$16,707 to each loan, ranging from \$150,000 to a low of \$1,850. The median amount of state funds was \$9,867.50. These loans helped to leverage slightly over \$4 million in total investment.

Four loans were made to child care businesses. Six of the projects supported the startup or expansion of a restaurant or a catering business.

Loan Fund Since Inception

The Program made its first loan in February 1995. By the end of calendar 1998, the Department had approved a total of 195 loan proposals and disbursed \$3,765,091 in state funds. The table below summarizes the activities of all the Urban Initiative partners to date.

In 1998, the Board and DTED approved two organizations to participate in the program, Entrepreneurial Advantage, located in St. Paul, and the Minnesota Working Capital Fund. Because the grants were not put in place until late in the year, these organizations did not make any loans in 1998.

The average loan included \$24,400 in state funds. The median amount contributed by the state per loan has been \$10,000. The Urban Initiative Program has helped to generate an estimated \$16,741,000 in total business investment, primarily in Minneapolis and St. Paul.

Twenty-two businesses, which had received twenty-seven loans, have closed operations. Generally, these failures can be attributed to a lack of market demand, competition from other businesses, missteps by management, and, in one case, the death of the entrepreneur. Six of the

businesses were restaurant, catering services, or food product manufacturers. Five businesses were involved in the medical or technology-based products. In all cases, these were startup or very new businesses.

Seven of these businesses have nevertheless continued to repay their loans. A total of \$255,257 in state funds has been formally written off - or 6.8% of the state's total contribution. Twenty loans (\$406,958 in state funds) have been paid in full.


While we are encouraged by the relatively low level of losses to date, the Department continues to expect that the percentage of Urban Initiative loans written off will increase over the next five years. This is in keeping with the nature of the businesses which the Program is intended to support. Most of the entrepreneurs participating in the Program have very limited access to traditional sources of capital, for a variety of reasons. In addition, about one-third of the businesses supported by the program are "startups," which historically have a high failure rate.

A summary report showing the cash fund balance for the Urban Initiative fund is included as **Appendix 2**.

Business Profile

The next two sections - the nature of businesses assisted by the Urban Initiative Program and the jobs which these businesses have created - include information about only those businesses that are currently operating. At the end of calendar 1998, 168 Urban Initiative loans had been made to 133 businesses currently operating. The Figure below shows the breakdown of these loans by business sectors.


Percent of Loans by Business Sector



The Urban Initiative Program is intended to support the development of non-traditional entrepreneurs, especially women and minorities. The ownership of the businesses which have received loans through the Program reflects this focus. By the end of 1998, almost 84% of the active Urban Initiative loans were made to businesses owned by racial or ethnic minorities.

The Figure below provides a further breakdown.

Percent of Loans by Racial Group



In terms of gender, 91 of the active loans have been made to male-owned businesses at the end of 1998. Female-owned businesses have 54 loans, and businesses owned by two partners, generally a married couple, had 23 loans. Ten white, female-owned businesses have loans.

Fifty-seven of the "active" loans have been made to startup businesses -, i.e., those just opening their doors, while 90 loans were made to companies expanding their operations. Twenty-one loans have been made to retain a business operation. In these situations, loans were made to prevent the loss of jobs by the business closing down or moving its operations.

Job Creation

The Urban Initiative Program is also intended to support the creation of job opportunities in its targeted cities. The table below indicates the total number of jobs created with the support of the Program, excluding the owners of the businesses.

The wages paid to these employees varied widely, ranging from an average of \$5.00 to \$37.70 per hour. Overall, the median salary is \$8.00 per hour, while the average wage was \$11.00 per hour. One job has been created for every \$7,485 of state funds that has been invested.

At the time of application, the "active" businesses projected that they would create 633 jobs (again, not counting the owners). The 503 jobs listed above do not include 29 businesses which either did not report, or whose loans were made after the reporting deadlines. At the time of application, these 29 businesses projected that they would create a total of 89 jobs. The actual and projected jobs created would total 592.5 jobs. The average wages projected at the time of application were \$10.80 per hour. The actual reported wages were slightly higher.

The businesses paying the lowest wages - \$5.00 to \$7.00 per hour - tended to be small retail operations. Sixteen out of the 21 lowest paying businesses were retail firms. On the other hand, the highest paying jobs - twelve out of the top 20 - tended to be in the construction and manufacturing sectors. These highest paid jobs ranged between \$10.60 and \$37.70 per hour.

An average of three jobs was created by each "active" loan or project, while the median is two. The fewest number of jobs per loan was clustered in the retail and service sectors. Thirteen businesses reported that they did not create any jobs, not counting the owner of the business. Eleven of these businesses were classified as in the service sector. Another eighteen businesses reported actually creating one job each. Of these projects, ten businesses were classified in the retail sector. On the other hand, the twenty loans creating the largest number of jobs went to companies in the manufacturing, service, and construction sectors. For more information regarding each existing business loan see **Appendix 4**.

Technical Assistance

In 1995, the Legislature amended the original statutes, allowing the Board to capture investment income earned on the original \$6 million appropriated to underwrite the loan program. Using this authority, the Board acted to provide business clients with technical assistance. Technical assistance is described as a process of helping business owners: evaluate their abilities' and/or the needs of their business; make knowledgeable choices about their business; develop new skills; or underwrite one-time expenses related to the implementation of their business plan. This assistance could be provided by organization staff or paid consultants.

The Board allocates 20% of the investment earnings from Urban Initiative Fund to support this technical assistance. Under the Board policy, each business receiving an Urban Initiative loan is eligible for up to \$3,000 of assistance in any one fiscal year. During the 1998 calendar year a total of 32 businesses applied for technical assistance funds totaling \$86,700.

The Board and DTED staff have also provided "technical assistance" to various state agencies, local governments, business entities, and the public. This assistance has been primarily in the form of responding to inquiries about the Urban Initiative Program and other business programs.

Program Survey

The Department's Analysis and Evaluation Office recently completed a survey of the Program's nonprofit partners and the businesses which have received loans. The survey was designed to provide the Department with feedback regarding client expectations, critical comments regarding the administration of the program, suggestions for improvement, and ideas for future directions.

All of the nonprofit organizations were mailed questionnaires and twelve returned them. In addition, a total of 135 questionnaires was mailed to business clients, and 73 were returned. The results were obtained from a frequency distribution run, and converted into readable statistical tables. A number of open-ended questions were asked both surveys and the responses were included in the reports.

Nonprofit organizations. The survey of our certified partners included questions regarding the nature of the organizations and the businesses assisted. Almost all of the non profits responding indicated that they "generally assist" service sector businesses (11 out of 12 organizations). On the other hand only six indicated that they assist manufacturing businesses. In addition, most of these businesses are generally small (five employees or less), while only one nonprofit assists large companies (more than 20 employees).

Organizations were asked to rank the importance of a number of criteria used to make Urban Initiative loans. Eleven organizations ranked the following criteria:

While the organizations seemed generally satisfied with the administration of the program, two organizations were very dissatisfied. DTED needs to clarify its written instructions and should evaluate the timeliness of its loan disbursement. Four of the organizations felt that the time line for loan disbursement was too slow. According to our logs, it takes an average of 14.2 days for the Department to respond to a loan request - i.e., from the date a request is received to the date the Commissioner signed a letter responding to the request.

Two non profits indicated that the written instructions used in the certification process were not clear. Regarding the operation of the loan program, two organizations indicated that the disbursement process and written instructions were not clear.

The nonprofit partners were also asked to rate the extent to which the Program contributed to a list of outcomes for the loan recipients. The organizations felt that the most significant contribution of the program was providing affordable financing and improving the business' cashflow. Two organizations indicated that the program made little or no contribution to job creation for low-income individuals and improving business productivity.

Loan recipients. The survey of businesses which had received loans found that most were in the service sector (53%), followed by retailers (21%) and manufacturers (11%). A majority (67%) had been in business five years or less, while 19% had been in business between six and ten years. The average length of time in business was 63 months. Most responding businesses (58%) were owned by men and 80% were minority-owned.

The businesses listed insufficient credit history or poor credit history as the principal difficulty in obtaining a loan. Almost half used the loan proceeds for working capital, followed by acquisition of new equipment and acquisition or improvement of land or building.

The businesses also identified the top five issues they currently faced. These were:

The survey asked a number of questions regarding the loan recipients satisfaction with the loan application process, the training or assistance provided to the business, the impact of the program, and issues facing the businesses. Most of the businesses appeared to be satisfied with the application process. A majority (60%) strongly agreed that the staff of the nonprofit organization was helpful, and that the criteria for approving the loan were adequate. The most negative comments related to the timeliness of organization staff to questions and the time line for loan approval.

Slightly over 43% of the businesses indicated they had received some training from the nonprofit organizations. Generally, the organizations were given high marks for the training and technical assistance they provide. In particular, these clients were very satisfied with the organization's willingness to help, training in communications skills, loan packaging, and business planning. Businesses were most critical of the assistance given in the area of product pricing and accounting. Just over 22% of the respondents indicated that they were very dissatisfied or dissatisfied with the overall quality of assistance received.
