

COMMUNITY CORRECTIONS SURVEY

Introduction:

It became increasingly apparent to staff of the Department of Corrections and others over the past year or more that there was a need for more information about the total "Community Corrections" activity in Minnesota than was available from any one source. The evaluations completed by the staff of the Governor's Commission on Crime Prevention and Control provided a partial picture as did a review of activities taking place in Community Corrections Act counties and a review of Department of Corrections activities. Such sources still left large gaps which needed to be accounted for.

As a result, the Community Services Division surveyed the State for data from as many community programs as we could locate that would give a picture of what is taking place in "Community Corrections" in Minnesota.

In determining projects or programs to be included in the survey and those to be excluded, the following guidelines were developed:

- 1. Community Programs to be Surveyed Included those:
 - a. Which receive all or most of their funding through or from a criminal justice organization such as police, courts or LEAA.
 - b. Where a majority of referrals come from a criminal justice agency such as the police, courts, county or State corrections agency.
 - c. Where the major purpose is preventing clients from becoming involved with criminal justice agencies.
- II. Projects or Programs to be Excluded:

Charles Marin

a. Community programs whose primary purpose is chemical dependency treatment and where client status in the criminal justice system is incidential.

- b. Out-of-State resources.
- c. Group homes other than those operated by the Department of Corrections or court certified.
- d. In-house programs of public and private hospitals, jails, or regional corrections centers.
- e. Residential treatment centers whose primary focus is on other than Correctional clients.

Included with this report as Appendix D, is a listing of the projects which responded to the survey. For those who are interested, copies of the survey questionnaire form are available upon request from the Community Services Support Unit, 430 Metro Square Building, 7th and Robert Streets, St. Paul, MN 55101.

CAUTIONS TO THE READER:

- 1. These results are from a survey. No claim is made or should be inferred that the result constitutes completeness, evaluative research, a basis for individual program comparison or a basis for generalization to other community programs not included in the survey.
- 2. In spite of the work of local Correctional practitioners and their diligent search for community programs, some were missed which will be included in future surveys.
- 3. Total responses to the survey were approximately 150. After eliminating those in existence less than 1 year and those where significant data was unavailable, the survey sample is 118.
- 4. Expenditure year (survey year) was defined as "the most recent 12 month period for which data is available". These terms which are used throughout this report take into account the varied fiscal, grant and calendar years on which programs base their data.

Summary:

The survey results reported here confirm the impression that correctional activities at the community level in Minnesota are occurring with great variety, serving large numbers of clients and doing so at comparatively reasonable costs compared to institutionalization and at appropriately low levels of risk for the community. The activities surveyed are, of course, inter-related to many ongoing community services including probation, parole, social service agencies both public and private, police, courts, etc.

While many of the clients served by the programs reporting in this survey were also on probation or parole, many were being diverted from those parts of the system. For purposes of comparison, there were 15,909 clients on probation and parole in Minnesota as of 9/1/76.

While programs designed to serve chemically dependent clients whose status in the criminal justice system was incidential to their chemical dependency are not included in the following survey information, Appendix C provides some information on Statewide chemical dependency residential treatment programs as well as Hennepin County's chemical dependency treatment programs. Because of the method of data collection utilized in the chemical dependency programs, it is not possible to determine precisely the proportion of clients who are also correctional clients.

Program Description:

As will be noted in the following, an attempt was made to classify programs by the type of program (residential or nonresidential) the target group to be served and the primary purpose.

Responses from 118 programs show that 65 are primarily residential, 47 are primarily non-residential and 6 serve both non-residential and residential clients.

For the same 118 programs 24 serve primarily adults, 84 serve primarily juveniles and 10 serve both.

Table | provides a cross-tabulation of the types of community programs by clientele served.

Responses from 117 programs regarding their primary purposes revealed 35 programs serving as pre-trial diversion, 16 as alternatives to local incarceration while 39 had as their primary purpose serving as alternatives to State incarceration. Eight programs provided for re-entry from State institutions (halfway houses) and 19 were some combination of the above 4 categories.

Table 2 provides further detail and cross-tabulations of this data in the residential and non-residential categories of response. It should be noted that the 8 residential pre-trial diversion programs were all serving juveniles.

Details regarding specific services available to clients in the programs as surveyed, are shown in Appendix A. The responses indicate that programs not only offer many services directly as part of their program but rely heavily on referral to other community agencies for supplemental services.

Of the 118 programs responding, 71 were residential (or both residential and non-residential) and during the survey year 2,663 clients were served in-residence while 684 additional clients were served as non-residents by those same programs. The average length of stay was 99 days and the average occupancy rate was 75%. Total in-residence capacity of the 71 programs is 964.

Survey responses from 48 non-residential programs indicated 12,809 clients served during the survey year. All of these programs provide screening and referral services, some provide limited direct service to clients while a few provide many services directly in addition to screening and referral to other community resources.

Among all 118 programs providing data, a total of 16,156 clients were reported as served during the survey year. It must be noted that these are not necessarily separate individual clients as the survey was not based upon tracking individuals. It is assumed that some of the same clients would have been served by more than 1 program.

Profile of Client Groups:

A total of 115 programs provided information on the racial/ethnic background of clients. The overall figures show the programs served 9,862 whites, 1,374 blacks, 614 Native Americans and 172 chicano and other ethnic groups. Further detail is available in Table 3. Racial Characteristics N=115

Clients who were reported in the survey as having no present adjudication or conviction constitute the largest single group 3,116. This category was intended to identify those clients referred to the criminal justice system because of deviant behavior, but who were being served to divert from or prevent further penetration into the formal system. The survey was not precise enough to confidently identify all of those clients reported as having no present adjudication or conviction as actually being referred for prevention or diversion purposes.

Supplemental information provided and knowledge of some of the programs suggests that the clients are referred by agencies such as the police, schools, families, etc. and in many cases delinquency petitions or criminal complaints are held in abeyance pending satisfactory completion of one of these prevention or diversion programs.

In reviewing the data in Table 4 regarding clients who had been adjudicated delinquent or convicted of crime, it is interesting to note that residential programs served larger proportions of offenders against person than did the nonresidential programs. This would seem to indicate that community programs are part of a screening system which provides the greatest degree of supervision and control to those offenders who pose the most serious potential threat to the community.

Table 4 provides detail regarding clients served in the various categories of programs with information as to sex, age and offense categories.

Program Cost:

As expected, residential community corrections programs are more costly per client than are other categories of community corrections programs but they still appear to be a reasonably economical means of serving the offender when compared to most other residential alternatives. Briefly, the cost per client on the average was shown to be \$2,555 for residential care and \$168 for non-residential service.

Per diem costs for residential programs averaged \$25.84. Juvenile programs average \$26.33 per day, adult programs \$24.69 per day while programs serving both juvenile and adult clients averaged \$27.10. The cost per client for juvenile programs was \$2,471 - for adults \$2,628 and for programs serving both juveniles and adults \$3,195.

While they are not necessarily primarily correctional in focus, private residential treatment centers serving juveniles vary in cost from \$40.00 to \$58.00 per day according to the Minnesota Council of Residential Treatment Centers.

Cost per client data for State institutions provides a comparison in considering overall costs and as can be seen in Table 5, there is a substantial difference between community residential costs per client and institution costs. The average per case cost for community residential service is \$2,555 compared to average per case cost of \$7,025 for State institutions. It should be noted that it cannot be assumed that all of the residential community clients would have been in institutions but for these programs. Many would have been on probation or parole or would have received no supervision. All of these, of course, are cheaper alternatives but given the fact of residential care, it is provided more economically in community programs based upon this survey.

In attempting to further clarify the cost picture, the survey attempted to determine which programs obtained their facility at token cost or no cost. Responses indicated that 75% of the non-residential programs obtained their facility at either token cost or no cost while only 24% of the residential facilities had such an advantage.

Survey responses reveal that a combination of State and county funding accounts for well over half of the total funding with Federal funding being just under 40%. Adult programs account for approximately 34% of total costs, juvenile projects 58% and combination programs approximately 8% of the total funds.

What is the Result:

While the survey does not include follow-up data, the information collected reveals a very substantial amount of service provided to clients in the community at a very low level of risk during the period of service provided by the programs. The proportion of clients served who were terminated for being either arrested or convicted of new offenses or for probation or parole technical violations seems to indicate that both the screening process provided by the system and the level of supervision provided by the community programs are in keeping with the aims of providing client service at reasonable cost and risk levels.

Details on program completion and types of termination are shown in Table 6.

- II. HENNEPIN CO. CHEMICAL DEPENDENCY TREATMENT PROJECTS BOTH RESIDENTIAL & NON-RESIDENTIAL 9 MONTH PERIOD (1/1/76 -9/31/76)
 - A. There are 6 programs in Hennepin County which have a substantial percentage of their clients referred by the criminal justice system. It should be remembered that this accounts only for direct referrals and the percentage with involvement in the criminal justice system is much higher.
 - B. 6 programs received 944 referrals during the above 9 month period and 290 or 30.7% were from the criminal justice system.
