
This publication provides covered employment and wages by major industry group for each county in Minnesota for the First Quarter of 1981. Industries are classified in accordance with the 1972 Standard Industrial Classification Manual. Excluded from coverage in the State of Minnesota are:

- 1) The self-employed;
- 2) Farms with less than four employees in 20 weeks;
- 3) Insurance and Real Estate salespeople who work only on a commission basis;
- 4) All railroad transportation employment;
- 5) Those employed by a church for religious work;
- 6) Minor children, spouse and parents working for the owner of a business;
- 7) Elected officials at the Federal, State, or Local level of government;
- 8) The Red Lake Chippewa Tribe;
- 9) Students working for the school while a full-time student.

Asterisks (*) indicate that there are too few employing establishments in an industry to allow publication in accordance with the State's nondisclosure law. Where two or more industries cannot be disclosed, both have been marked with asterisks, but employment and wages for both are still included in the grand total. Where only one industry could not be disclosed, we have rolled that industry's data into another, marking the nondisclosure with an asterisk and the combined industries with a commercial A (@).

Please note, as well, that the cities of Minneapolis, Saint Paul, and Duluth appear separately at the end of the counties as well as being included in their respective counties. The pages labelled "Unattached" that appear after these cities include traveling salespeople who have no fixed location and those few employers who are not able to break out multiple locations.
