Introduction

This report presents information about the two million Minnesotans who are women and girls. It focuses on the 76,000 Minnesota women and girls who are minorities. Minority Women in Minnesota is patterned after Women In Minnesota, a previous publication of the Commission on the Economic Status of Women, and it is intended to be a factual base from which to look at the status of women in Minnesota and how it varies by race.

The first part of this report contains a narrative description of minority women in Minnesota. The second part contains detailed tables. Definitions of terms can be found at the end of this publication. The 1980 Census of Population and Housing is the primary data source for this publication. Additional information is from the Minnesota Higher Education Coordinating Board and other state and national sources.

The total numbers in this report are different from those in Women in Minnesota because data are reported here only for persons who are White, Black, American Indian, Asian and Hispanic. There is an additional group of persons classified as Race not elsewhere classified (Race n.e.c.) who are not included in this report. Race n.e.c. includes all other races which were not included in the specific categories listed on the census questionnaire. The total number of Race n.e.c. persons in Minnesota is 2,963.

All data in Minority Women in Minnesota are unduplicated counts. This means that if a person identifies her/his race as White and also identifies her/himself as being of Hispanic s/he is counted in the Hispanic category in this report.

In Minority Women in Minnesota all races are identified as proper nouns and are therefore capitalized.

At the time the 1980 Census was conducted many of the Cambodian and Laotian refugees had not arrived in Minnesota. It is estimated that there are 21,000 Cambodian, Lao and Hmong refugees in Minnesota. These refugees may have very different educational and economic profiles than the Asian population that was in Minnesota in 1980.

This report is based on the results of the 1980 U.S. Census. The Census has been questioned by many minority groups for undercounting minority populations. The Council on Black Minnesotans estimates that the total Black population in Minnesota in 1980 was 60,000, 8,419 higher than the 51,581 reported in the 1980 census. The Indian Affairs Council estimates that there were 44,782 American Indians in Minnesota, instead of the 35,749 reported in the census. Similarly, the Spanish Speaking Affairs Council estimated the Hispanic population in Minnesota in 1980 was 52,000, 19,885 higher than the 32,115 reported in the census.

About the Census

The U.S. Census, conducted every 10 years, is the most comprehensive data base of its kind. In 1980, the census gathered an estimated 3.3 billion items of information from more than 220 million people in approximately 80 million households spread over 3.6 million square miles of territory.

In March of 1980, every household received a census questionnaire. There were two different questionnaires: one with 19 questions and one with 46 questions. About one in six households, selected at random, received the longer form. The remaining households received the short form.

The answers to the short form constitute what is called "100 percent count" or "complete count" data. This report is based primarily on sample data from the long form, expanded to represent the total population.

Information from the census is made available in a number of forms, including printed materials and computer tapes. Following some delays in releasing data, some of the Minnesota information gathered during the 1980 census has been made available in published form. The Census Bureau published a report on general population characteristics in 1982 and a report on general social and economic characteristics was issued in 1983.

In 1984, Summary Tape File 4 (STF 4) was issued, and most of the information in this report is based on that file. It provides statistics with greater subject and demographic detail than printed reports. The Commission on the Economic Status of Women requested computer runs from this file.

As a result of the data generated, this report contains comprehensive information about the status of minority women in Minnesota. This data is not otherwise available in published form.

Each of the tables in this report indicates a data source used. For the tables based on the 1980 census, these sources are:

- *Summary Tape File 2 (STF 2), with general population characteristics, based on complete count data.
- *Summary Tape File 4 (STF 4), with general social and economic characteristics based on sample data estimates.

Although the census is far more reliable than other surveys, census information is subject to both sampling and nonsampling errors. Sampling errors arise from the selection of persons and households to be used in a sample. Nonsampling errors are the result of all other errors that may occur during the collection and processing phases of the census including both human and mechanical errors. More technical information about sources and reliability of the estimates, as well as technical documentation for the tables in this report, is available for review in the Commission office.

Population Characteristics

In 1980, minority persons comprised 17 percent of the nation's population. Minnesota has a relatively small minority population, accounting for just under 4 percent of the state's 4 million residents. Eighty-four percent of all minorities in Minnesota reside in urban areas and almost three-quarters of the minority population live in the Twin Cities metropolitan area. Just under half of Minnesota's minorities live in the cities of Minneapolis or St. Paul. Almost four of five Black Minnesotans live in Minneapolis or St. Paul, while only about one in four Asian Minnesotans live in these two cities.

Blacks are Minnesota's largest minority group, making up 1.3 percent of the state's population and slightly more than one in three minority persons in Minnesota. American Indians are the second largest minority group accounting for almost one in four minority persons. Slightly more than one in five minority persons in the state is Hispanic, while Asians are the state's smallest minority group with one in five minority persons being Asian.

Female Population

There are roughly two million women and girls in Minnesota accounting for 51 percent of the state's population. This percentage has not changed in the last decade.

Minority women make up 50 percent of the state's minority population. Black women account for slightly less than half of Black Minnesotans, at 48 percent. American Indian and Asian women are each more than half of their respective population groups with women accounting for 52 percent of the American Indian population and 53 percent of the Asian population. Hispanic women account for half of Hispanic persons in Minnesota.



Age

Between 1970 and 1980 the female population in Minnesota became older. The number of White women under 18 decreased by 18 percent, while the number of White women 18 to 64 increased by 16 percent and the number of White women 65 and over increased by 22 percent. These changes in the White female population are in sharp contrast to the age distribution of the minority female population which remained relatively stable over the past decade.

The female minority population is significantly younger than the population as a whole. Forty-two percent of minority females are under age 18, compared with only 27 percent of the White females that are in this age group. Forty-one percent of the White female population is under age 25, while 57 percent of minority women are in this age group. American Indian females have the largest percentage of women under 25, with 59 percent of American Indian females in this age group.

White women over age 65 are 14 percent of the state's White female population, but only 5 percent of the minority female population is over age 65. Blacks have the highest percentage of women over age 65 of all minority groups, with almost 6 percent of Black women in this age group.

The median age of White females in Minnesota increased in the last ten years from 27.6 to 30.6 years. The median age for minority females is significantly lower than for White women and has changed little over the last decade. In 1970, the median age for minority females in Minnesota was 21.2 years. In 1980, it was 20.5 years.



Educational Attainment & Enrollments

Educational levels have changed dramatically in a relatively short period of time in Minnesota. In 1980, 73 percent of Minnesotans age 25 and over had completed high school, compared with only 44 percent in 1960. The proportion of persons who had completed four or more years of post-secondary education more than doubled in the same period from 8 percent in 1960 to 17 percent in 1980.

Levels of educational attainment differ for men and women and by race.

The proportion of persons receiving a high school diploma appears to have stabilized. Among those age 25 to 44, 92 percent of women and 90 percent of men have completed 12 or more years of education. White women 25 to 44 are more likely than minority women of this age to have completed high school. Ninety-two percent of White women compared with 75 percent of minority women have completed this much education. Of minority women age 25 to 44, Blacks are the most likely to have completed high school with four of five Black women having at least 12 years of education. American Indian women in this age group are the least likely to have completed 12 years of school with 67 percent.

Educational attainment for minority men is similar to that of minority women in every racial group except for Asians. Seventy-five percent of Asian females have at least 12 years of education compared to 82 percent of Asian males.

Both men and women are pursuing higher levels of education than in the past. Among persons over age 25, 37 percent of men compared to 32 percent of women have some postsecondary education. Asian women are more likely than other women to have post-secondary education, at 44 percent. Thirty-four percent of Black women, 32 percent of White women, 26 percent of Hispanic women and 18 percent of American Indian women over age 25 have some post-secondary education.



The proportion of women with four or more years of post-secondary education also varies by race. For women 25 and over, Asians have the highest proportion of females with four or more years of post-secondary education, at 28 percent. Fourteen percent of White and Black women, 10 percent of Hispanic women and 5 percent of American Indian women have four or more years of post-secondary education.

Increases in the level of educational attainment of women are particularly striking when comparing women 65 and older with their daughters and granddaughters. While only about 40 percent of the older women are high school graduates, more than 90 percent of women age 25 to 44 have completed high school. In all racial groups the proportion of women receiving high school diplomas more than doubled for the younger group.

The percentage of women with some post-secondary education has more than doubled between generations: 44 percent of the younger women and only 19 percent of the older women have some college. This is true for women of all races. The increase is most dramatic for Black and Asian women where the proportion tripled. Fourteen percent of older Black women compared with 42 percent of younger Black women have some post-secondary education. Among Asian women, 16 percent of the older women and 51 percent of the younger women have this much education.

Post-Secondary Enrollments

In 1970, women were outnumbered by men in each of the post-secondary education systems in the state. Since that time women have become the majority of enrollees in state universities and community colleges. Their enrollment at the University of Minnesota, at 49 percent, is almost equal to that of male students. Enrollment patterns vary by institution and race. While 53 percent of all White students at the University of Minnesota, state universities and community colleges are female, only 45 percent of the minority students at these institutions are female.

American Indian women are the only minority group that has more female students in each of these institutions than male students. Half of White students and half of Black students at the University of Minnesota are women, while more than half of American Indian students at that institution are women. In contrast Asian women are only 38 percent of Asian students at the University. White and American Indian women are more than half of the White and American Indian students at state universities and community colleges. However, this is not true for any other racial group.

Marital Status

The substantial majority of women in Minnesota were married and living with their husbands in 1980. About one-fourth of women had never married. Men are more likely than women to be single or married, and less likely to be widowed. Marital status patterns in Minnesota vary by race.

White, Asian and Hispanic women are most likely to be married and living with their husbands, with the majority of women in each group falling into this category. Black and American Indian women are less likely to be married with 38 percent of American Indian women and 30 percent of Black women married.

Black women are most likely to be single (never married), with over 40 percent of Black women in this group. Asian women are the least likely to be single, accounting for only 24 percent of Asian women.



Black women are the most likely group of women to be separated or divorced, at 16 percent. Asian women are the least likely to be in these categories, at 8 percent.

Black women are the most likely to be widowed, 14 percent, and Asian women are the least likely to be widowed, with 4 percent.

White, Black and American Indian men are more likely than their female counterparts to be single or married and less likely to be separated, divorced or widowed. Asian and Hispanic men are less likely than their female counterparts to be married.

In 1980, 75 percent of all Minnesota women between the ages of 15 and 24 were single. Black women in this age group were most likely to be single, at 85 percent. By contrast, only 70 percent of Asian women of this age group were single. At older ages, Black women are still the most likely to be single. Twelve percent of Black women between the ages of 35 and 44 have never been married. This is twice the proportion of single women for any other group. Hispanic women are the least likely to have never been married by the time they reach age 35, with only 3 percent still single. 7

Living Arrangements

A household, by definition, consists of all persons occupying a housing unit. Households are divided into two general groups: family households and non-family households. A "family" is defined as two or more persons related by birth, marriage or adoption. A "non-family" household consists of either a one-person household or two or more unrelated persons living together.

Of the 1,400,318 White households in Minnesota in 1980, 72 percent were family households and 28 percent were non-family households. White nonfamily households have increased substantially, up from 21 percent in 1970. Minority households in Minnesota follow a similar pattern -- 71 percent of minority households are family households and 29 percent are non-family households. Minority non-family households also increased since 1970, when they accounted for 25 percent of minority households.

Blacks have the highest percentage of non-family households, 35 percent, of any racial group in Minnesota. A combined group of American Indians and Asians* has the smallest percentage of non-family households, 22 percent.

Women comprise the majority of non-family households in Minnesota, with almost three of five non-family households being headed by women. For minorities the reverse is true, with almost three in five non-family

*The census does not provide this household data for American Indians and Asians separately, therefore, the combined group is used here. minority households being headed by men.

Half of non-family households in Minnesota are comprised of women living alone, while only 34 percent of minority non-family households are women living alone.

Family Households

In this publication, "husband-wife family" and "married-couple family" are used interchangeably. "Femaleheaded family" means a family headed by a woman with no husband present, and "male-headed family" means a family headed by a man with no wife present.

In 1980, 87 percent of families in Minnesota were maintained jointly by a husband and wife, making that the predominant family form. Another 13 percent of families were headed by women, while 3 percent were headed by men.

Family type varies by race. The majority of family households in each minority group are married-couple families. Asians have the highest percentage of minority husband-wife families', accounting for 83 percent of Asian families. Black marriedcouple families account for 52 percent of Black families, the smallest percentage for any minority group.

Minority families are more likely than other families to be headed by a single parent. Female-headed and male-headed families with children account for 28 percent of minority families, three times the proportion of single parent families for the population as a whole. Black femaleheaded families account for 41 percent of all Black families, the largest percentage of any minority group. White and Asian families are the least likely to be headed by women, with about 10 percent of each group in this category.

Relatively few families of any racial group are headed by men. The 7 percent of American Indian families headed by men is the highest percentage of any racial group. White families are the least likely to be headed by men, with only 3 percent being male-headed. For minority families, Hispanic families are the least likely to be male-headed, with 5 percent of Hispanic families in this category.

The majority of families in Minnesota have children under 18 years of age. Minority families are more likely to have children than White families. Just over half of White families have children, while more than two-thirds of all minority families have children. Sixty-two percent of female-headed families have children, making them the most likely family group to have children present. Black and American Indian female-headed families are the most likely to have children, with 83 percent of each having children under 18 living at home. Asians are the only group in which female-headed families are not the most likely family type to have children. Male-headed families are the family group least likely to have children under 18, with only 36 percent of these families having children present.

The labor force participation rates of women raising children alone vary by race and age of children. Black and American Indian female single parents are less likely than their married counterparts to be in the labor force, regardless of the age of their children. White single mothers are more likely than their married counterparts to be in the labor force, regardless of the age of their children.

Asian female single parents with children under six are more likely than their married counterparts to be in the labor force. Asian female single parents with children 6 to 17 years only are less likely than their married counterparts to be in the labor force. However, the reverse is true for Hispanic mothers.

Labor Force Participation

In the decade of the 70s, women continued the rapid influx into the labor force which began in the early 60s. More than three-quarters of a million Minnesotans who were employed or actively seeking employment in 1980 were women, representing 43 percent of the state's labor force. Of the 58,128 minority Minnesotans in the labor force, 44 percent are women.



Overall, 64 percent of women of the usual working age, 16 to 64, are now in the labor force. A slightly smaller proportion of minority women in Minnesota, 58 percent of women in this age group, are in the labor force. Labor force participation rates of minority women of usual working age vary by race from 52 percent for American Indian women to 62 percent of Black women.

Younger minority women are less likely than the female population as a whole to be in the labor force. Sixty-eight percent of women age 16 to 44 were employed. In contrast, 59 percent of minority women of this age group are in the labor force. Middle age minority women (45 to 64) are as likely to be in the work force as the female population as a whole, with more than half of both groups in the workforce. However, older minority women are more likely than their white counterparts to be employed. Eight percent of women 65 and over are in the labor force, while 10 percent of

minority women in this age group are in the labor force.

Seventy-two percent of Black women age 25 to 44 are in the work force, the highest labor force participation rate for any group of minority women. The only group of women with a higher labor force participation rate is White women 20 to 24, 76 percent of whom are in the work force.

Labor Force Participation by Part-Time/Full-Time

Labor force participation rates for women with children are higher than those for women without children. This does not hold true, however, for all racial groups. For minority women, slightly more married women without children are in the labor force than married women with children. Black and American Indian married women with children were more likely than those without children to be in the work force.



Unmarried minority women with children were less likely than their married counterparts with children to be in the labor force. This is true for all minority women except for Asian women.

Not surprisingly, the older the children the more likely the mother will be in the work force. In 1980, almost half of White mothers with children under 3, more than half of those with children age 3 to 5 and two-thirds of mothers with children 6 to 17 were in the labor force. Minority women with children under age 3 are less likely than their White counterparts to be in the labor force, with two-fifths in the labor force. Minority women with children over age 3 have similar labor force participation patterns to White women.

Black women with children of all ages have the highest labor force participation rate of all women. Almost half of Black women with children under 3, nearly two-thirds with children 3 to 5 and almost threefourths with children 6 to 17 were in the labor force.

Part-Time/Full-Time

Status of Workers

More than 571,000 employed Minnesotans work part-time, defined as less than 35 hours per week for all or part of the year. While women's labor force participation rates are changing to more closely approximate those of men, differences in hours of work remain. Forty percent of all women in the labor force, compared with 15 percent of all men in the labor force, have part-time employment.

More than one-third of women who work part-time work at least 50 weeks per year, demonstrating a significant attachment to the labor market.

Minority women are more likely than white women to be employed full-time, with 71 percent of employed minority women working full-time compared with 60 percent of White women. Black women are the most likely to be working full-time, at 74 percent. In all racial groups men are more likely than their female counterparts to be employed full-time.

Of women employed part-time, White women are the most likely to work part-time year-round, with more than one in three part-time White women workers in this category. American Indian part-time employed women are the least likely to work year-round, with only one in five being employed for 50 or more weeks per year.

Workers by Family Type

About 10 percent of Minnesota families have no earners. They are supported by other kinds of income, such as Social Security, public assistance or income from investments.

Approximately 14 percent of minority families have no earners. Of minority families, Asians have the highest percentage with no earners, 16 percent, while Hispanic families have the lowest proportion, 10 percent.

Female-headed families have the largest proportion of no-earner families, 17 percent. Twenty-nine percent of minority female-headed families have no employed family members.

The one-earner family is no longer the norm. Sixty-one percent of Minnesota families have two or more earners. For minority families 52 percent have two or more earners. This smaller proportion of two-earner minority families may be due in part to the high number of single parent minority families. Both husband and wife are employed in 58 percent of married-couple families. For minority married-couple families, 61 percent have both spouses in the work force.

The trend toward more earners is also apparent in other family types. Thirty-three percent of female-headed families and 22 percent of femaleheaded minority families have two or more earners. Forty-seven percent of male-headed families and 36 percent of minority male-headed families have two or more earners.

Occupation

The division of occupations into "male" jobs and "female" jobs continued unabated in the 1970s. Forty-nine percent of all persons in the state labor force in 1980 were in jobs which were either male dominated (80 percent or more men) or female dominated (80 percent or more women).

More than one-third of women in the state and nearly one-third of minority

women hold one of just five occupations: secretaries, stenographers and typists; miscellaneous administrative support occupations; health service occupations; bookkeepers, accounting, and auditing clerks; and health assessment and treating occupations.

Minority women are more likely than White women to be employed in precision production, craft and repairing occupations, with one in five employed minority women working in these fields. Almost one-fourth of employed Asian women work in these occupational groups, making them the most likely to have jobs in these fields. Women employed in this occupational grouping are most likely to work as machine operators, tenders, fabricators, assemblers and hand workers.

White women are more likely than minority women to be employed in sales occupations, with 11 percent of white women and 6 percent of minority women working in these fields.





Income

Census data on income of individuals and families are for the year prior to the census survey. That is, the 1980 census reports on 1979 income. Income figures tend to change more quickly than demographic patterns, and 1979 figures will seem low to the contemporary reader. Although the 1979 figures are not good indicators of 1986 incomes, they illustrate variations by sex which are known to persist. That is, although the median income for men in 1979 is considerably lower than the 1986 median, it is safe to assume that the relationship between median incomes of men and women have changed very little between 1979 and 1986.

Income level is associated with source of income, household type, marital status, presence of children and age. The most significant factor, however, is sex: women's incomes are consistently lower than men's incomes. This pattern persists when looking at income data by race.

Earnings are the most important source of income for both men and women. Since women are less likely to be employed and less likely to be employed full-time, their earnings are lower than men's. But even when controlling for those and other factors, the centuries old "earnings gap" remains.

Nationally in 1980, women full-time year-round workers earned, on average, 60 cents for every dollar earned by men. The national earnings gap has hovered at this level for thirty years, with a high point of 64 cents in 1955 and 1983 to a low point of 57 cents in 1973.

In Minnesota in 1979, women employed full-time year-round had a median income of \$10,580 compared with

\$18,365 for their male counterparts -- 58 cents, on average, for each dollar of men's income. This pattern persists when comparing income of women of each minority group to their male counterparts. Black women have the highest income compared to their male counterparts, 72 cents on the dollar.

Incomes of full-time year-round employed women vary by race. Asian women have the highest income with a median of \$11,395. Black women follow closely behind with a median of \$11,229. American Indian women have the lowest income with a median of \$9,387.

Almost three of five full-time employed American Indian women have an income of less than \$10,000 a year, the highest proportion of any group. Asians have the smallest proportion of full-time employed women with incomes under \$10,000, 37 percent.

Asian women have the highest proportion of women with incomes of \$25,000 or more annually, 6 percent. Only 1.1 percent of full-time employed Hispanic women have incomes that high.

Family Income

Black married-couple families with children 6 to 17 have the highest median family income, \$28,734, of any family group in Minnesota. Hispanic femaleheaded families with children under age six have the lowest median income for families in Minnesota, \$4,791.

Married-Couple Families

Married-couple families have the highest incomes of any



household type, in part because they have more earners. This is true for all races, regardless of whether a family has children or the age of the children.

American Indian married-couple families have the lowest median incomes, \$13.831 for those with children under 6, \$22,219 for families with children 6 to 17 and \$15,069 for husband-wife families without children. White married-couple and Black married-couple families have the highest family incomes. For families with children under age 6. White married couples have the highest median income, \$20,790. For families with children ages 6 to 17, Black husband-wife families have the highest median income, \$28,734. White husband-wife families have the highest income for married-couples without children. \$20.192.

Female-Headed Families

Lower income and earnings for individual women result in lower incomes for families headed by females. Female-headed families have the lowest incomes of all family types with one exception. Asian female-headed families with children have higher incomes than Asian male-headed families with children.

While incomes for all female-headed families are low, they are even lower for female-headed families with children. Women in these families have high labor force participation rates, but their earnings are low. More than three-quarters of all female-headed families with children under six and more than four-fifths of minority female-headed families with children under six had family incomes of under \$10,000. White female-headed families with children under six had the highest median income, \$6,132 and Hispanic families of this type had the lowest median income, \$4,791.

Age of children is strongly associated with income level of all family types, and in each case incomes are lower for those with preschool-age children. Income of female-headed families increases significantly when the youngest child reaches school age. Income for these families rose an average of 73 percent as children became of school age. Whites had the highest increase, 88 percent and Hispanic women had the lowest increase, 62 percent.

Poverty

Poverty rates -- the percentage of a particular group with income below the poverty level -- are higher for women than for men and they are higher for minority women and men than they are for White women and men.

More than 374,000 Minnesotans were living in poverty in 1979. This represents about 9 percent of the state's population. Of these, 41 percent were women, 33 percent were children and 26 percent were men.

A disproportionately large number of persons in poverty are minorities. Minority children account for six percent of Minnesota's children and 13 percent of Minnesota's children in poverty.

Almost 30 percent of minority children in Minnesota were living in poverty in 1979, while 9 percent of White children were in poverty. One in 4 minority women are poor, while 1 in 10 White women are in poverty. One in five minority men are in poverty, while 1 in 14 White men are poor.

American Indian women and children are the most likely group to be poor with more than 1 of 3 American Indian children in poverty and almost 1 of 3



American Indian women being poor. Minority children are more likely than minority women or men to be poor. Among Whites, women are most likely to be poor.

Poverty rates are highest for both women and men among those ages 18 to 21 and among those age 65 and over. This is true for Whites and minorities.

Poverty Rates by Family Type

People living in families are generally less likely than those in non-family households to be poor. Seven percent of White families were living in poverty in 1979 compared with 22 percent of White persons living in non-family households. Twenty-three percent of minority families were living in poverty compared with 36 percent of minority persons in non-family households.

Families with children have a higher poverty rate, at 9 percent, than those without children, at 5 percent. This is true for both White and minority families. White families with children have a poverty rate of eight percent, compared with 5 percent for White families without children. For minority families, the percent in poverty is 28 percent for families with children and 8 percent for families without children.

American Indian families with children are the most likely of all families to be in poverty, at 33 percent. Hispanic families with children are the least likely of minority families with children to be in poverty, with 20 percent of them in poverty.

Families maintained by women with no spouse present are the family group most vulnerable to poverty. Twentyone percent of White female-headed families live in poverty and 47 percent of minority female-headed families are poor.

Almost half of White female-headed families with children under age six and over three-fifths of minority female-headed families with children under six are living in poverty. Over 68 percent of American Indian female-headed families with children under age six were in poverty in 1979.

Black Women

Age: The median age of Black women in Minnesota is 23. Thirty-nine percent of Black women are under age 18 and 6 percent are 65 or older.

Education: Seventy percent of Black women 25 and older have completed high school. Fourteen percent of these women have completed four or more years of post-secondary education.

Marital Status: Black women 15 and older are most likely to be single, never married, 41 percent, and least likely to be separated, 7 percent.

Households and Families: Slightly more than one-third of Black households are non-family households. Thirty-nine percent of Black non-family households are comprised of a woman living alone or a woman head of household living with other unrelated individuals.

Fifty-two percent of Black families are married-couple families and 41 percent are female-headed families. Sixty-four percent of Black married-couple families and 83 percent of Black female-headed families have children under 18 living at home.

Labor Force Participation: Sixty-two percent of Black women ages 16 to 64 are in the labor force. Black women ages 35 to 44 are the most likely Black women to be in the labor force, 72 percent. Sixty-four percent of Black mothers with children under 18 and 54 percent of Black mothers with children under 6 are in the labor force.

Both the husband and wife are in the labor force in 67 percent of Black married-couple families.

Forty percent of Black women in the labor force are employed full-time yearround.

Occupation: Over one-third of employed Black women work in "Administrative Support, including Clerical" occupations. More than one in five is in a "Managerial and Professional Specialty" occupation.

Income: Black women employed full-time year-round had a 1979 median income of \$11,229, 72 percent of the median income of their male counterparts.

Black married-couple families with children ages 6 to 17 had the highest 1979 median Black family income, \$28,734. Female-headed Black families with at least one child under age 6 had the lowest Black median family income, \$5,078.

Poverty: Over one-third of Black children and more than one-fourth of Black women in Minnesota were living in poverty in 1979.

Twenty-four percent of Black families and 45 percent of Black female-headed families were in poverty in 1979. Twenty-nine percent of all Black families with children and 50 percent of Black female-headed families with children were in poverty.

American Indian Women

Age: The median age of American Indian women in Minnesota is 20.3. Forty-five percent of American Indian women are under age 18 and 4 percent are 65 or older.

Education: Fifty-six percent of American Indian women 25 and older have completed high school. Five percent have completed four or more years of post-secondary education.

Marital Status: American Indian women 15 and older are most likely to be married, 38 percent, and least likely to be separated, 5 percent.

Households and Families: More than one-fifth of households, in a combined group of American Indians and Asians, are non-family households. Forty-two percent of these households are comprised of a woman living alone or a woman head of household living with other unrelated individuals.

Fifty-seven percent of American Indian families are married-couple families and 36 percent are female-headed families. Sixty-nine percent of American Indian married-couple families and 83 percent of American Indian female-headed families have children under 18 living at home.

Labor Force Participation: Fifty-two percent of American Indian women ages 16 to 64 are in the labor force. American Indian women ages 35 to 54 are the most likely American Indian women to be in the labor force, 63 percent. Fifty-two percent of American Indian mothers with children under 18 and 38 percent of American Indian mothers with children under 6 are in the labor force.

Both the husband and wife are in the labor force in 58 percent of American Indian married-couple families.

Thirty-one percent of American Indian women in the labor force are employed full-time year-round.

Occupation: Twenty-nine percent of employed American Indian women work in "Administrative Support, including Clerical" occupations and 29 percent are employed in "Service" occupations.

Income: American Indian women employed full-time year-round had a 1979 median income of \$9,378, 64 percent of the median income of their male counterparts.

American Indian families with children ages 6 to 17 had the highest 1979 median American Indian familiy income, \$22,219. Female-headed American Indian families with at least one child under age 6 had the lowest American Indian median family income, \$5,065.

<u>Poverty</u>: Over one-third of American Indian children and almost one-third of American Indian women in Minnesota were living in poverty in 1979.

Twenty-eight percent of American Indian families and 52 percent of femaleheaded American Indian families were in poverty in 1979. Thirty-three percent of all American Indian families with children and 56 percent of female-headed American Indian families with children were in poverty.

Asian Women

Age: The median age of Asian women in Minnesota 1s 21.8. Forty-four percent of Asian women are under age 18 and 4 percent are 65 or older.

Education: Seventy percent of Asian women 25 and older have completed high school. Twenty-eight percent of these women have completed four or more years of post-secondary education.

Marital Status: Asian women 15 and older are most likely to be married, 64 percent, and least likely to be separated, 1 percent.

Households and Families: More than one-fifth of households, in a combined group of American Indians and Asians, are non-family households. Forty-two percent of these households are comprised of a woman living alone or a woman head of household living with other unrelated individuals.

Eighty-three percent of Asian families are married-couple families and 10 percent are female-headed families. Seventy-two percent of Asian marriedcouple families and 66 percent of Asian female-headed families have children under 18 living at home.

Labor Force Participation: Fifty-seven percent of Asian women ages 16 to 64 are in the labor force. Asian women ages 35 to 44 are the most likely Asian women to be in the labor force, 65 percent. Fifty-one percent of Asian mothers with children under 18 and 43 percent of Asian mothers with children under 6 are in the labor force.

Both the husband and wife are in the labor force in 55 percent of Asian married-couple families.

Thirty-nine percent of Asian women in the labor force are employed full-time year-round.

Occupation: Almost one in four employed Asian women work in "Managerial and Professional Specialty" occupations and almost an additional one in four work in "Precision Production, Craft and Repair" occupations.

Income: Asian women employed full-time year-round had a 1979 median income of \$11,395, 61 percent of the median income of their male counterparts.

Asian married-couple families with children ages 6 to 17 had the highest median income in 1979 for Asian families, \$27,352. Asian male-headed families with at least one child under age 6 had the lowest Asian median family income, \$4,844.

<u>Poverty</u>: Twenty-eight percent of Asian children and 22 percent of Asian women in Minnesota were living in poverty in 1979.

Twenty-three percent of Asian families and 33 percent of Asian female-headed families were in poverty in 1979. Twenty-eight percent of all Asian families with children and 40 percent of Asian female-headed families with children were in poverty.

Hispanic Women

Age: The median age of Hispanic women in Minnesota is 20.5. Forty-four percent of Hispanic women are under age 18 and 4 percent are 65 or older.

Education: Sixty-one percent of Hispanic women 25 and older have completed high school. Ten percent of these women have completed four or more years of post-secondary education.

Marital Status: Hispanic women 15 and older are most likely to be married, 51 percent, and least likely to be separated, 3 percent.

Households and Families: Twenty-eight percent of Hispanic households are non-family households. Forty-four percent of Hispanic non-family households are comprised of a woman living alone or a woman head of household living with other unrelated individuals.

Seventy-nine percent of Hispanic families are married-couple families and 16 percent are female-headed families. Sixty-seven percent of Hispanic married-couple families and 82 percent of Hispanic female-headed families have children under 18 living at home.

Labor Force Participation: Fifty-nine percent of Hispanic women ages 16 to 64 are in the labor force. Hispanic women 35 to 44 are the most likely Hispanic women to be in the labor force, 65 percent. Fifty-four percent of Hispanic mothers with children under 18 and 44 percent of Hispanic mothers with children under 6 are in the labor force.

Both the husband and wife are in the labor force in 62 percent of Hispanic married-couple families.

One-third of Hispanic women in the labor force are employed full-time yearround.

Occupation: Thirty percent of Hispanic women in the labor force work in "Administrative Support, Including Clerical" occupations and an additional 23 percent are employed in "Service" occupations.

Income: Hispanic women employed full-time year-round had a 1979 median income of \$9,877, 61 percent of the median income of their male counterparts. Hispanic married-couple families with children 6 to 17 had the highest 1979 Hispanic median family income, \$24,466. Female-headed Hispanic families with at least one child under age 6 had the lowest 1979 median family income for Hispanic families, \$4,791.

<u>Poverty</u>: Nineteen percent of Hispanic children and 19 percent of Hispanic women were living in poverty in 1979.

Sixteen percent of all Hispanic families and 48 percent of all female-headed Hispanic families were in poverty in 1979. Twenty percent of all Hispanic families with children and 53 percent of all Hispanic female-headed families with children were in poverty.

Definitions

Age

The age classification is the age of the person at the person's last birthday.

Educational Attainment

Data on educational attainment apply only to progress in "regular" schools. It includes elementary school and schooling which leads to a high school diploma or college degree. It does not include vocational school, unless the course would be accepted for credit at a regular elementary or high school or at college.

Enrollment

Data on post-secondary enrollments refer to a headcount of students on the tenth day of classes in the fall as reported to the Minnesota Higher Education Coordinating Board. Student enrollments are based on those enrolled in courses/programs creditable toward a degree diploma, certificate or other formal award. Not included are enrollments in interest courses, short courses, non-credit adult education courses and other community programs not creditable toward a degree diploma, certificate or other formal award.

Family

Two or more persons who are related by birth, marriage or adoption and who live together as one household. Families are classified by type according to the sex of the householder and presence of relatives.

Married-couple family. A family in which the householder and his/her spouse are counted as members of the same household. Male-headed family. A family with a male householder and no spouse of householder present.

Female-headed family. A family with a female householder and no spouse of householder present.

Household

The person or persons occupying a housing unit. Households are classified by type according to sex of the householder and the presence of relatives.

Family household. A household including a family. It may also include nonrelatives living with the family.

Nonfamily household. A household consisting of a person living alone or of a person living with other unrelated individuals.

Income

Individual income includes total money income received in calendar year 1979 by persons 15 years and over. Total income is the sum of amounts reported separately for income from: wages and salaries; farm and non-farm selfemployment; interest, dividends and net rentals; Social Security; public assistance; and all other sources. The figures represent the amount of income received before deductions.

Family income is total money income received in calendar year 1979 by all family members 15 years old and over. The lowest income group includes families that were classified as having no 1979 income. Median income figures are based on all families.

Labor Force Participation

Persons 16 years old and over were classified as to their status in the labor force. Included are members of the Armed Forces and the civilian labor force. The civilian labor force includes employed and unemployed civilians. Unemployed civilians are those who were looking for work during the 4 weeks prior to the census and available to accept a job and those waiting to be called back to a job from which they had been laid off.

1980 labor force data. These refer to the calendar week prior to the date on which respondents completed their questionnaires or were interviewed by census takers.

1979 labor force data. These refer to persons who were employed during calendar year 1979. Full-time participation includes persons 16 years and old and over who usually worked 35 or more hours per week worked. Parttime participation includes those who usually worked 1-34 hours per week.

Marital Status

Marital status was tabulated only for persons 15 years old and older.

Single. Persons who have never been married, including persons whose only marriage was annulled.

Married. Persons whose current marriage has not ended through widowhood, divorce or legal separation.

Separated. Persons legally separated or otherwise absent from their spouse because of marital discord. Widowed. Widows and widowers who have not remarried.

Divorced. Persons who are legally divorced and who have not remarried.

Occupation

The kind of work persons 16 years old and over were doing at a job or business during the week prior to completing the census questionnaire or being interviewed by a census taker. If not at work during that time, it is the most recent job or business if employed since 1975. Persons working at more than one job are counted only in the one at which they worked the most number of hours. Occupation is not determined for persons in the Armed Forces.

Parental Status

The presence at home of a child or children under 18, including stepchildren and adopted children. It excludes sons-in-law and daughters-in-law and foster children. Women and families with children are classified by age of youngest child, even though they may also have older children.

Poverty Status

Families and persons are classified as below the poverty level by comparing their total 1979 income to federal government definition of poverty which is calculated according to family size, number of children and age of family householder or individual. For example, the poverty level for a family of three -- a mother and her 2 children -- is \$5,844.

Race

The concept of race as used by the Census Bureau reflects self-identification; it does not denote any clear-cut scientific definition of biological stock. Since the 1980 census obtained information on race through self-identification, the data represents self-classification by people according to the race with which they identify themselves. For persons with parents of different races who could not provide a single response to the race question, the race of the person's mother was used. However, if a single response could not be provided for the person's mother, the first race reported by the person was used.

> White. Persons who indicated their race as White, as well as persons who did not classify themselves in one of the specific race categories listed on the questionnaire but entered a response such as Canadian, German or Italian.

> **Black.** Persons who indicated their race as Black or Negro, as well as persons who did not classify themselves in one of the specific race categories, but reported entries such as Black Puerto Rican, Haitian, Jamaican, Nigerian or West Indian.

American Indian, Eskimo and Aleut. American Indian persons who indicated their race as "Indian (American)" or who did not indicate a specific race category but reported the name of an Indian tribe. Persons who indicate their race as Eskimo and persons who indicate their race as Aleut.

Asian and Pacific Islander.-Persons who classified themselves as Japanese, Chinese, Filipino, Korean, Asian Indian, Vietnamese, Hawaiian, Guamanian, Samoan and Other Asian and Pacific Islander.

Hispanic. Hispanic is not a race. This report, however, uses persons of Hispanic Origin as a race because data is taken from detailed tables which divide persons into two categories Persons of Hispanic Origin and Persons not of Hispanic Origin. These categories are then divided further by race.

Persons of Hispanic Origin are self-identified as persons marking any one of the four "Hispanic" categories, i.e., Mexican, Puerto Rican, Cuban or other Spanish, and are collectively referred to as "persons of Hispanic Origin".

Sub-Family

A subfamily is a married couple (husband and wife who are members of the same household) with or without children, or one parent with one or more never-married children under 18 years of age living in a household and related to either the householder or the householder's spouse. Members of a subfamily are also included among the members of a family. The number of subfamilies, therefore is not included in the number of families.
