EXTENDED JURISDICTION JUVENILE (EJJ) CASES DISPOSITION STATUS-TO-DATE

EJJ Designation Criteria

M.S. 260.126, subd. 1 provides the three ways in which a juvenile can be designated an EJJ:

- Clause 1 - 14 to 17 years old, an adult certification hearing was held and the court designated EJJ;
- Clause 2 - 16 or 17 years old, alleged to have committed a presumptive commit to prison offense (if had been an adult) or have committed any felony allegedly with a firearm; prosecutor designates EJJ on petition; or
- Clause 3 - 14 to 17 years old, prosecutor requests EJJ designation and court grants.

EJJ Sentencing

If an EJJ prosecution results in a guilty plea or finding of guilt, the court shall impose one or more juvenile dispositions; and impose an adult criminal sentence. The execution of the adult sentence shall be stayed on the condition that the offender not violate the provisions of the disposition order and not commit a new offense.

Imposition of Adult Sentence

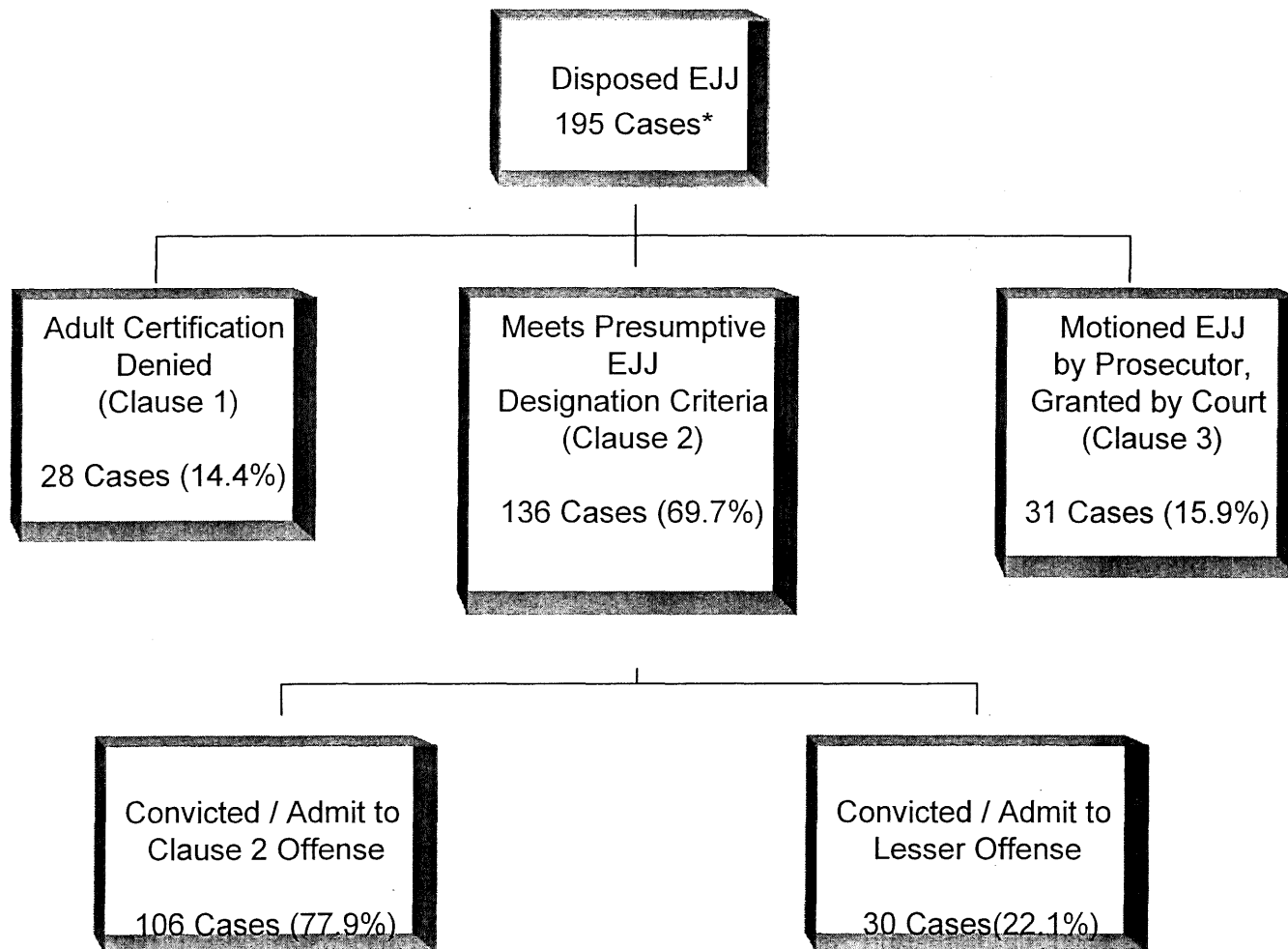
If a court revokes the stay of execution of the adult sentence (child violates the conditions of the stayed sentence or commits a new offense), the court shall order any of the adult sanctions authorized by M.S. 609.14, subd. 3, e.g. continue the stay of execution and place defendant on probation, or order intermediate sanctions, or order execution of the stayed adult sentence.

If the offender was convicted of an offense described in M.S. 260.126, subd. 1, clause 2, and the court revokes the stay of execution, the court must order execution of the previously imposed sentence unless the court makes written findings regarding the mitigating factors that justify continuing the stay.

Disposition Status-to-Date

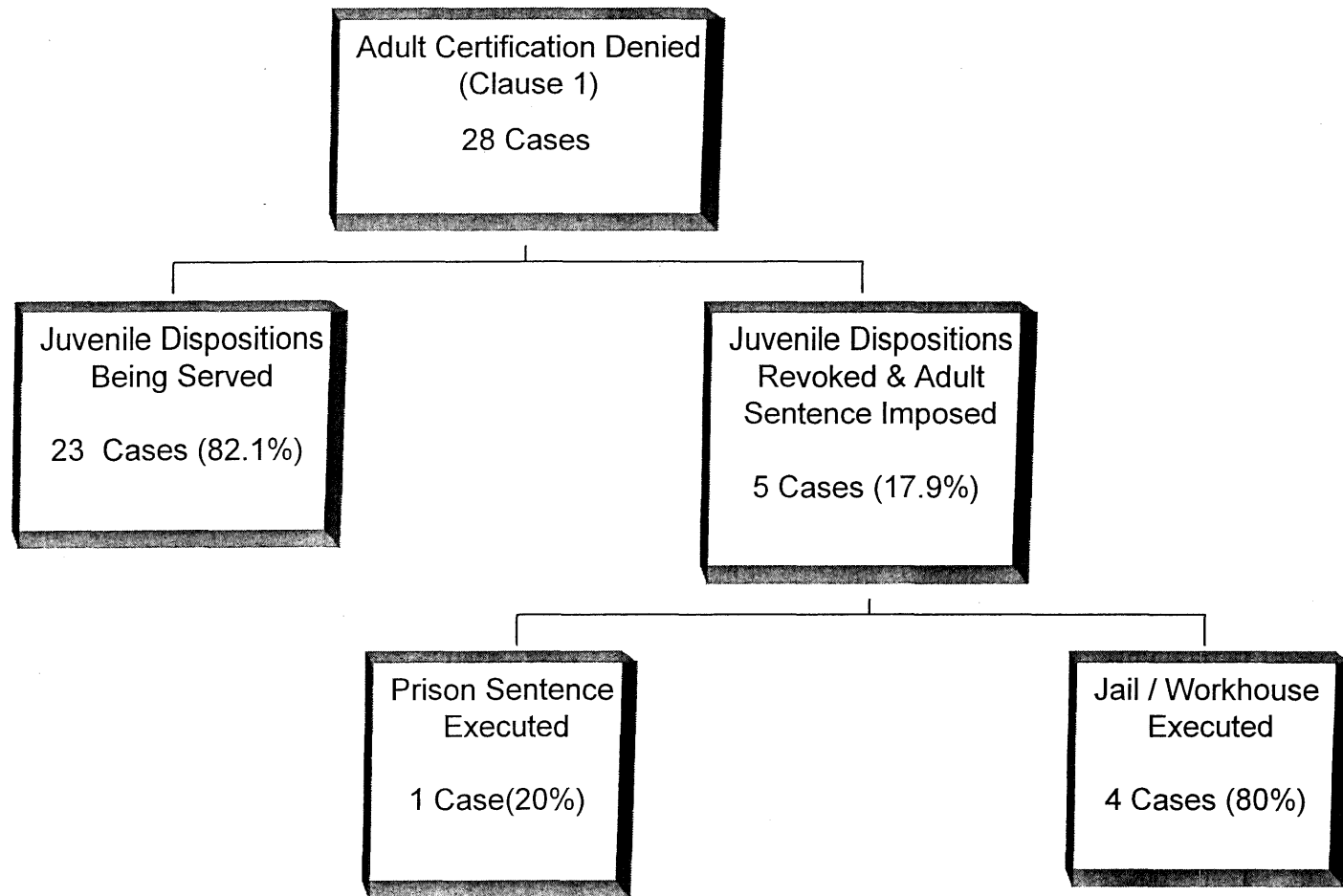

Statewide Disposed 1996 EJJ

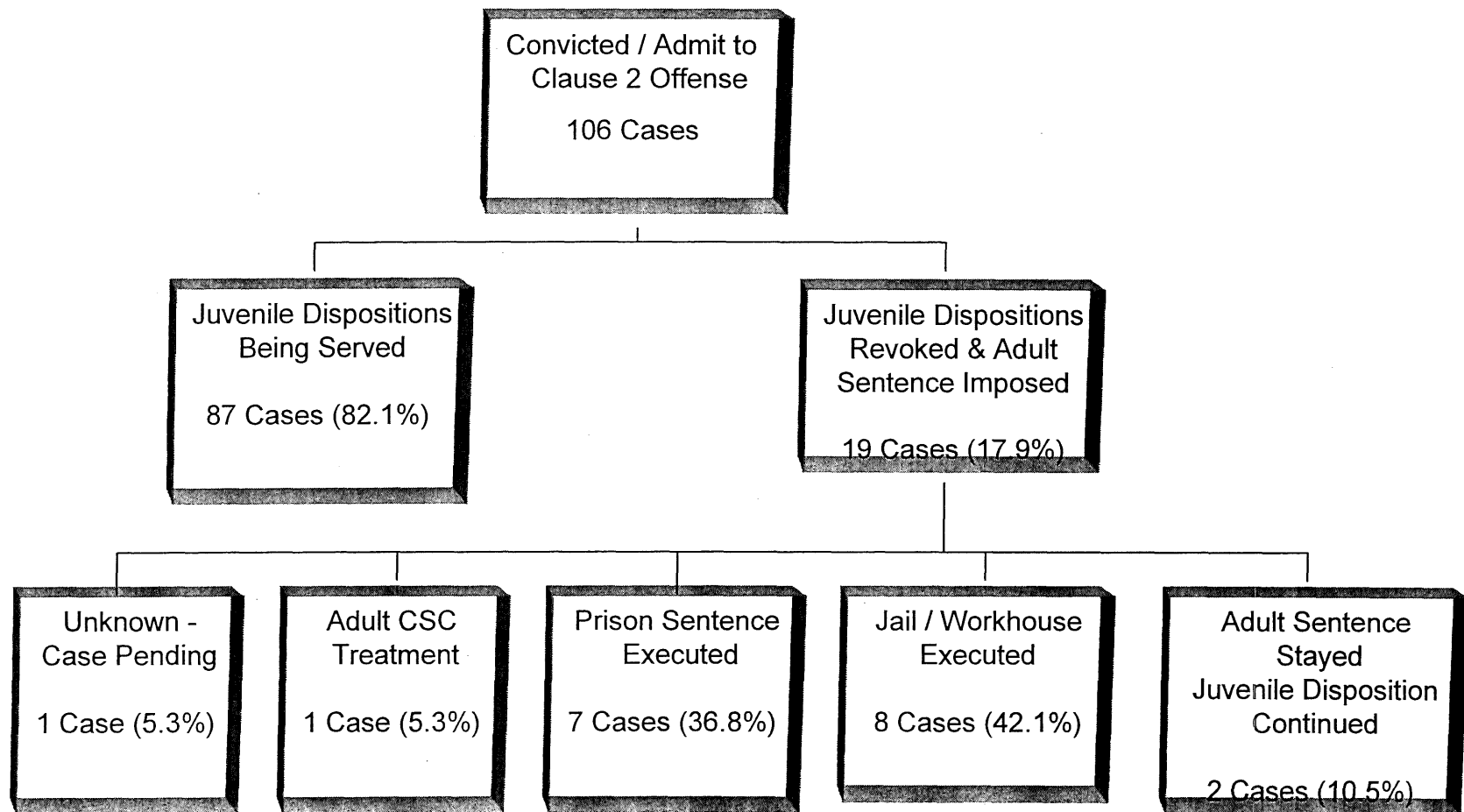

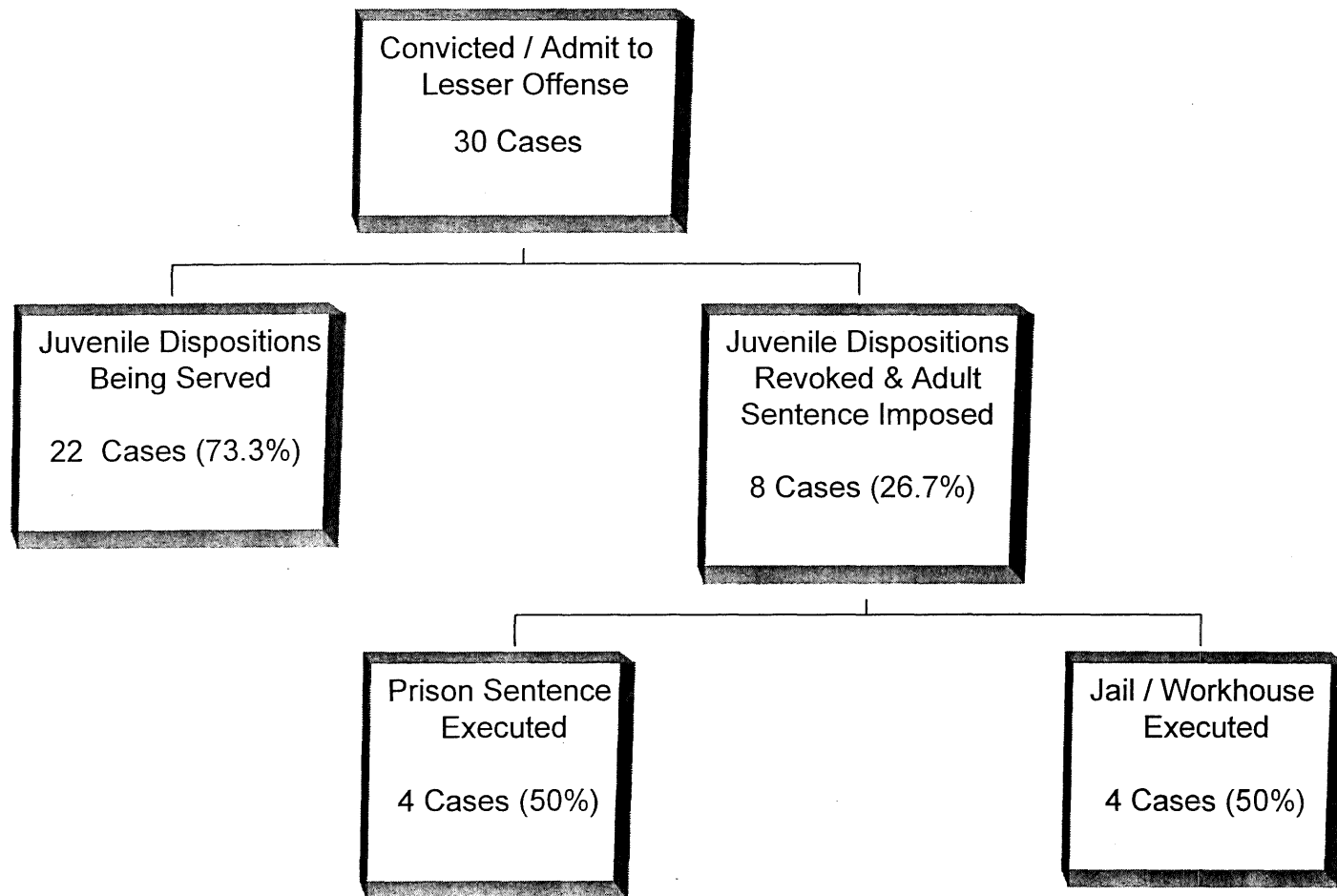
Statewide Disposition Status of Clause 1 EJJ's



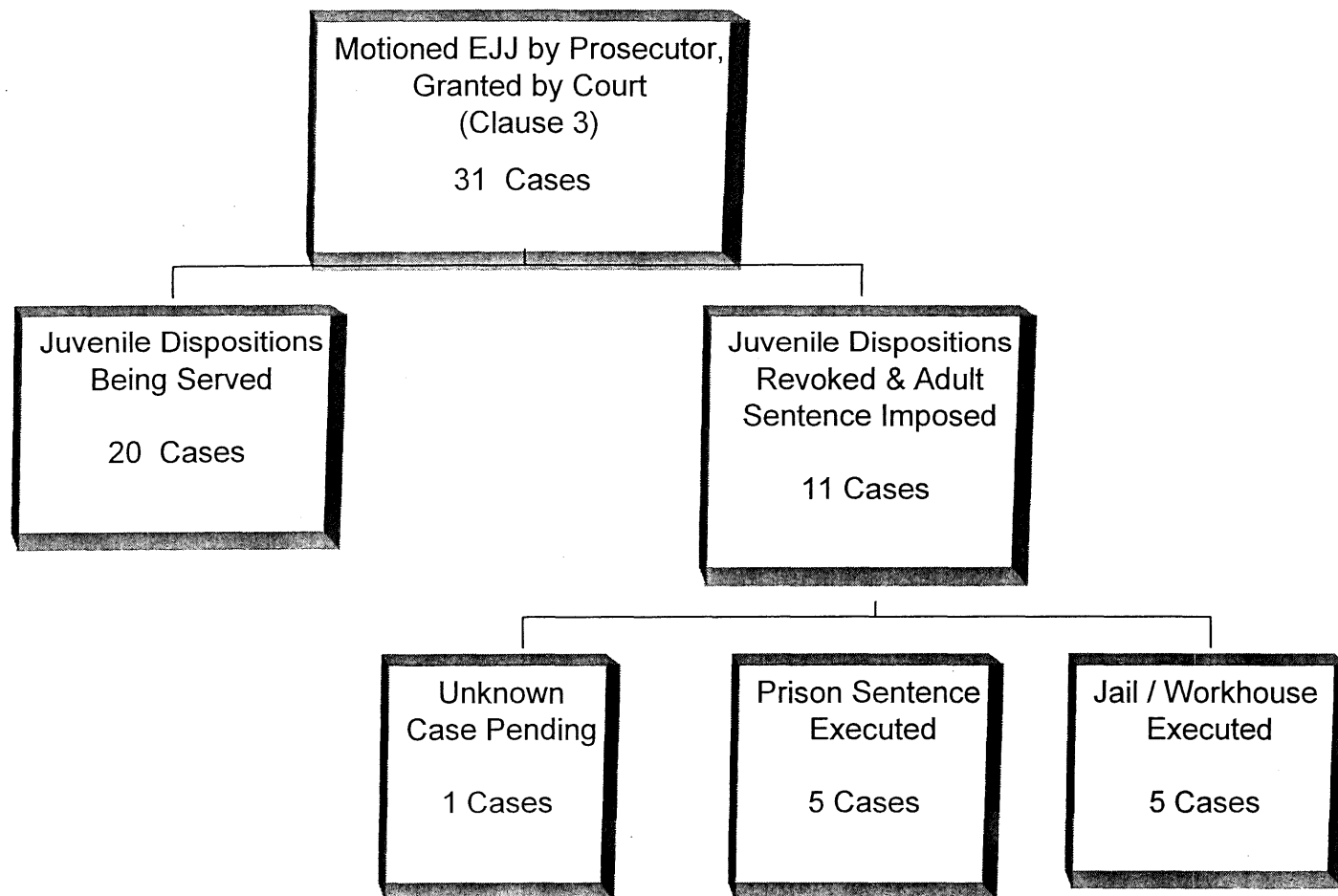
Statewide EJJ Disposition Status of Clause 2 Offense Convictions



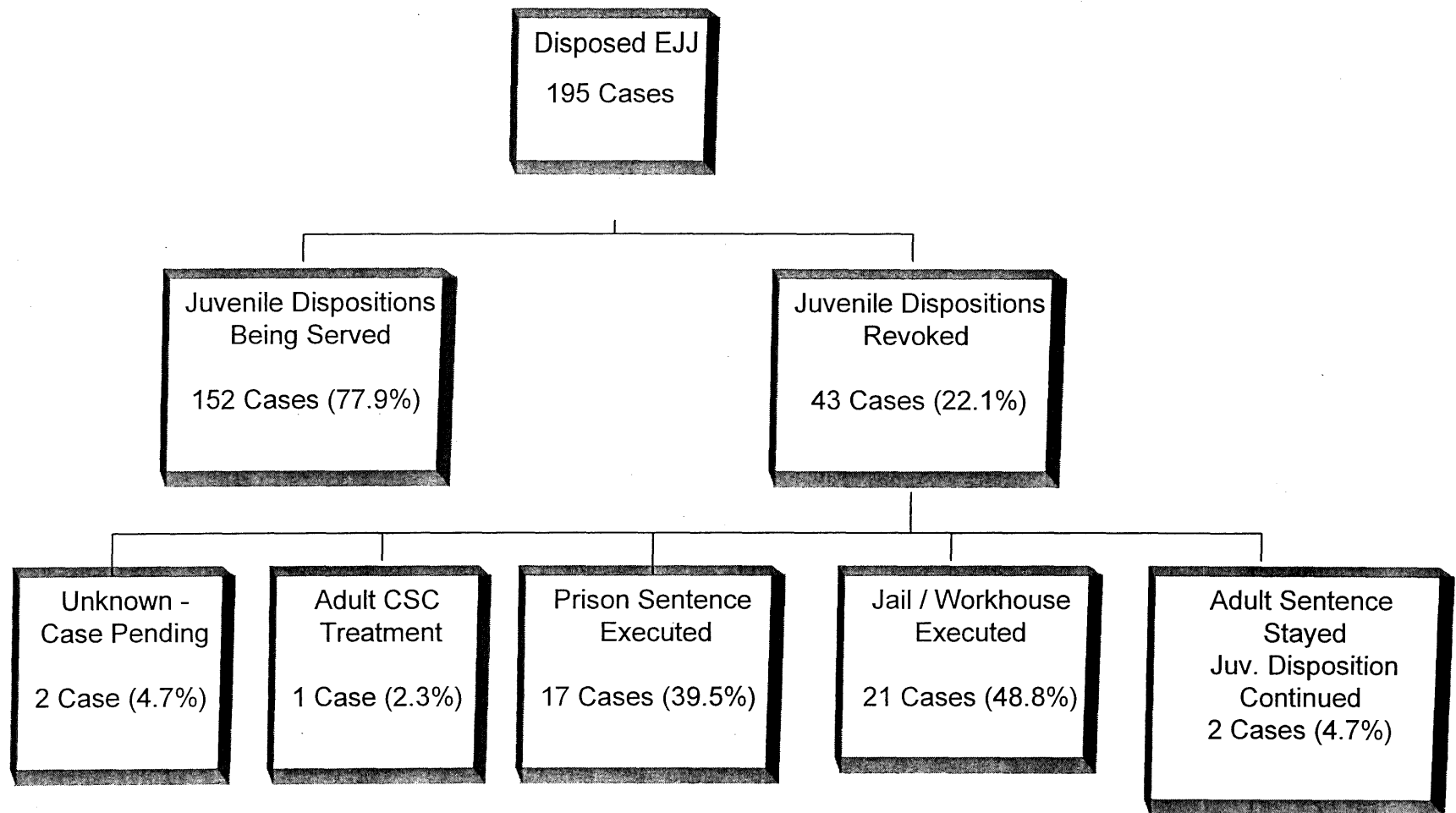
Statewide Disposition Status of Clause 2 EJJ's w/ Lesser Convictions



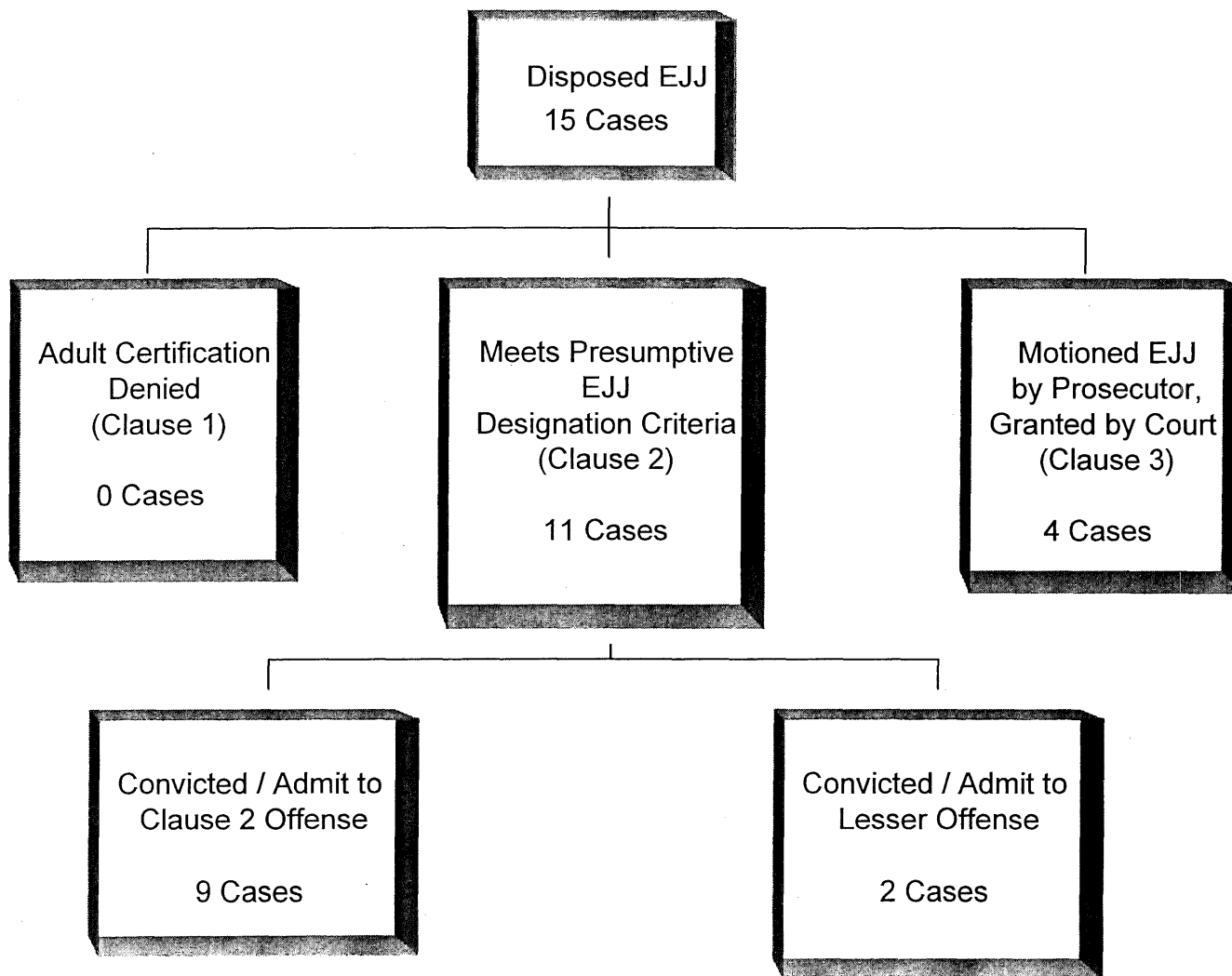
Statewide Disposition Status of Clause 3 EJJ's



Statewide Disposition Status of All 1996 EJJ's

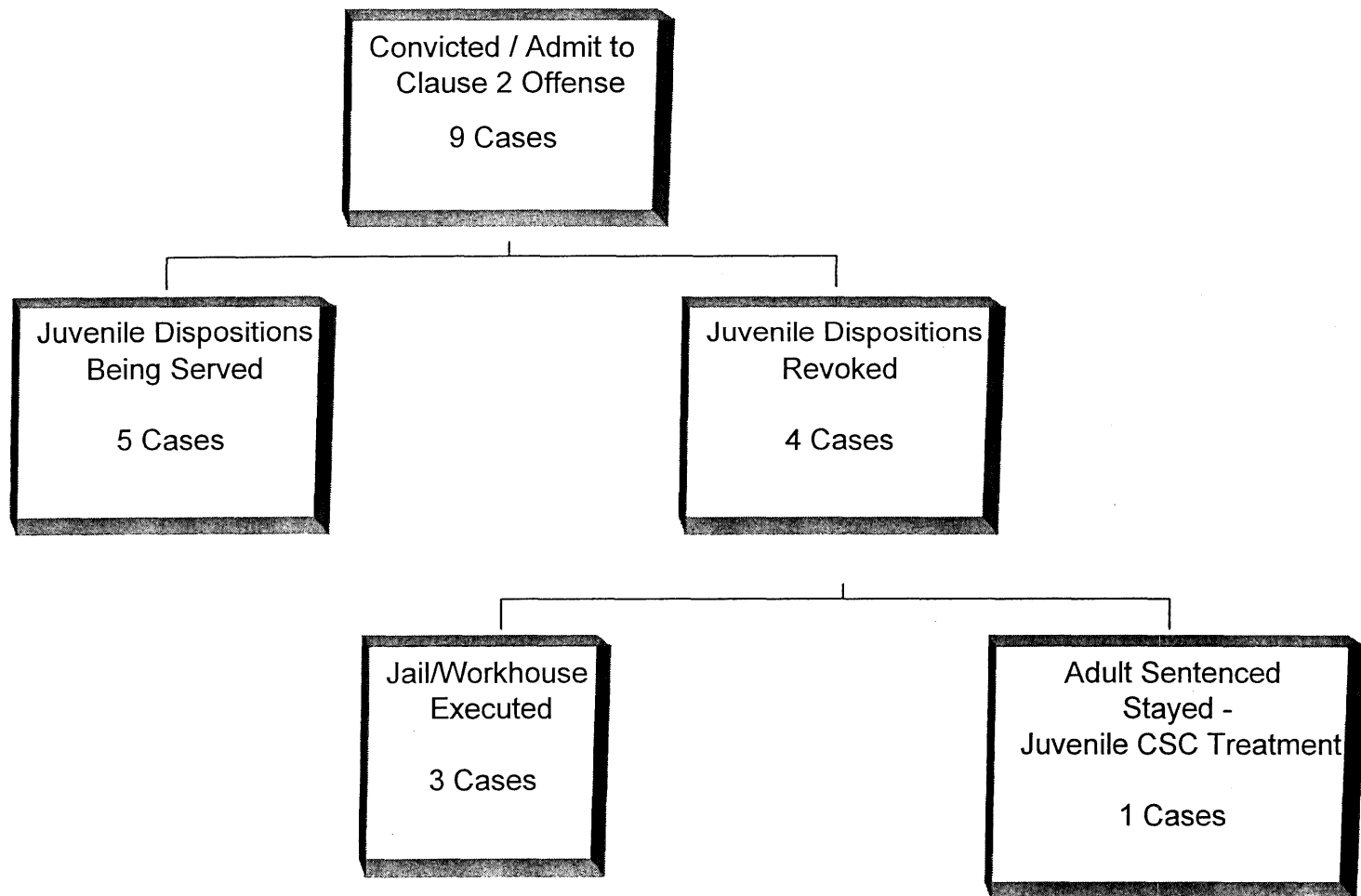

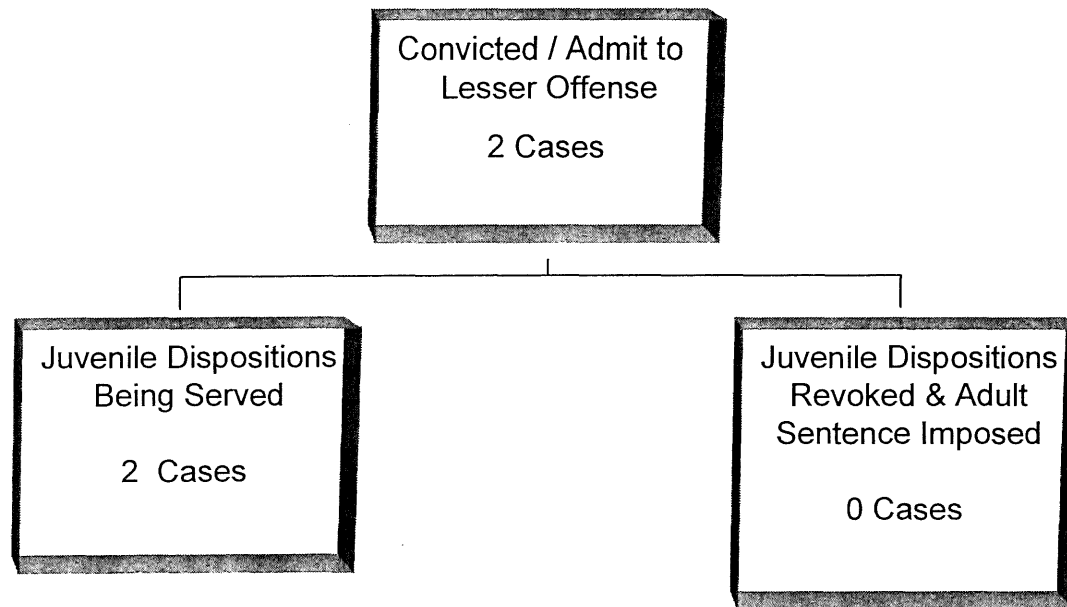

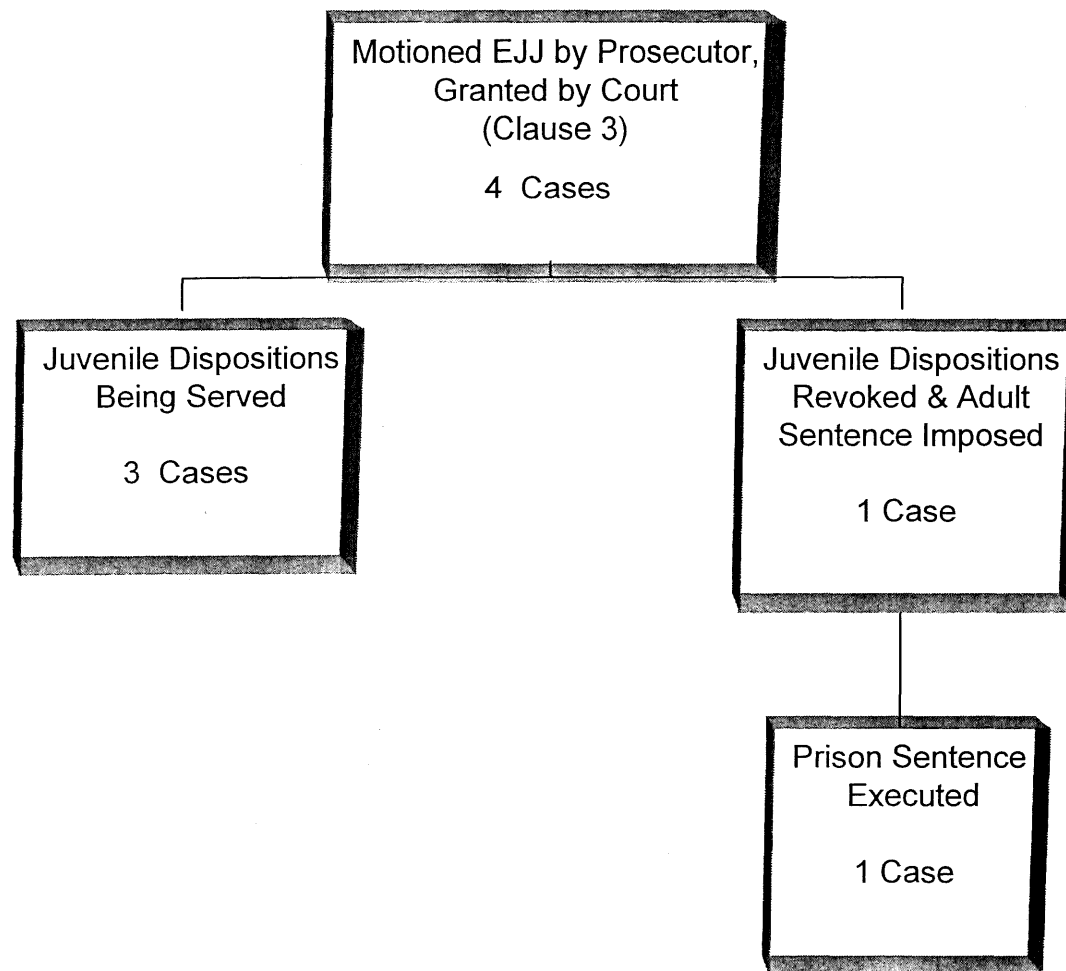
EJJ Disposition Status of Clause 2 Offense Convictions



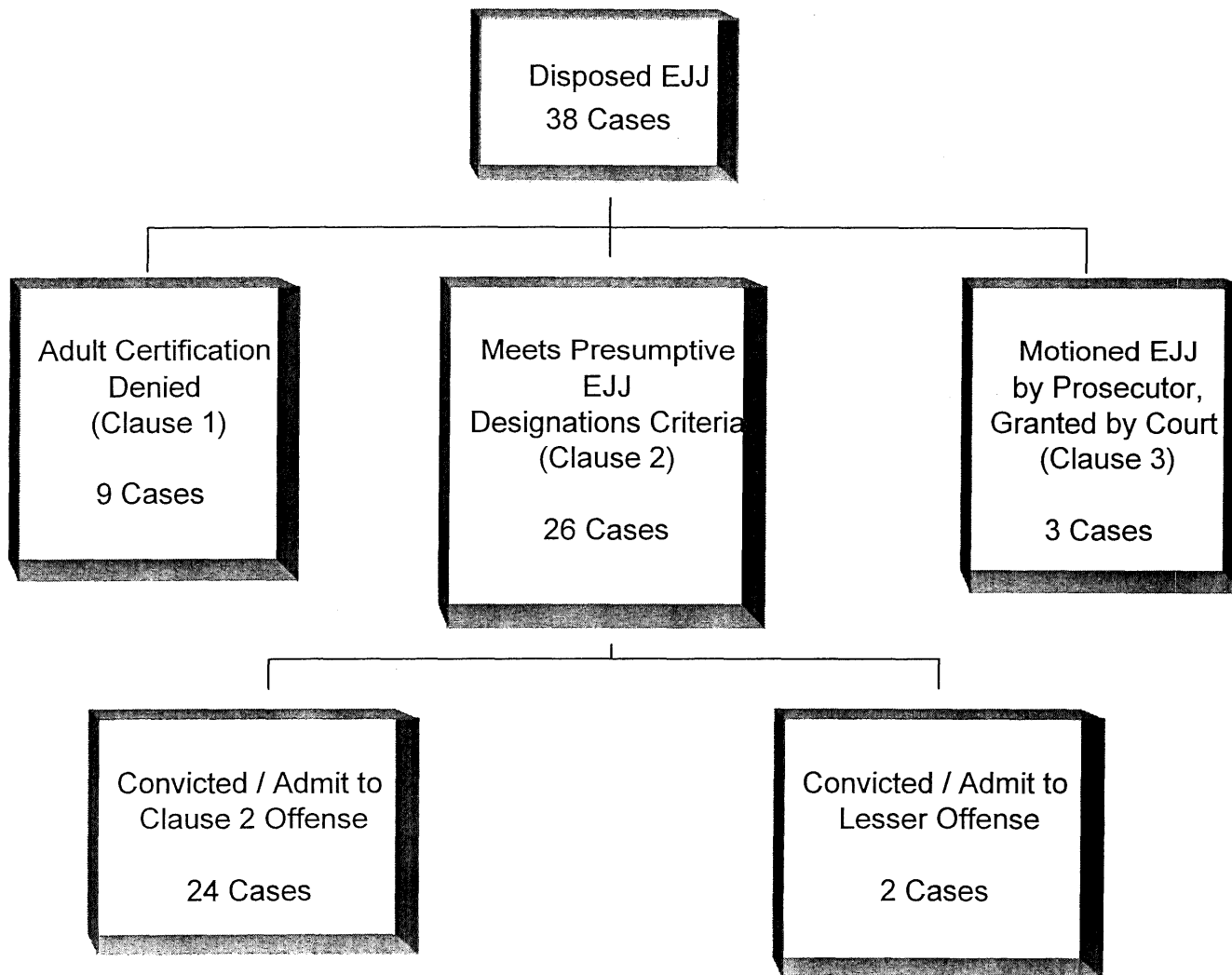
1st Judicial District Disposition Status of Clause 2 EJJ's w/ Lesser Convictions

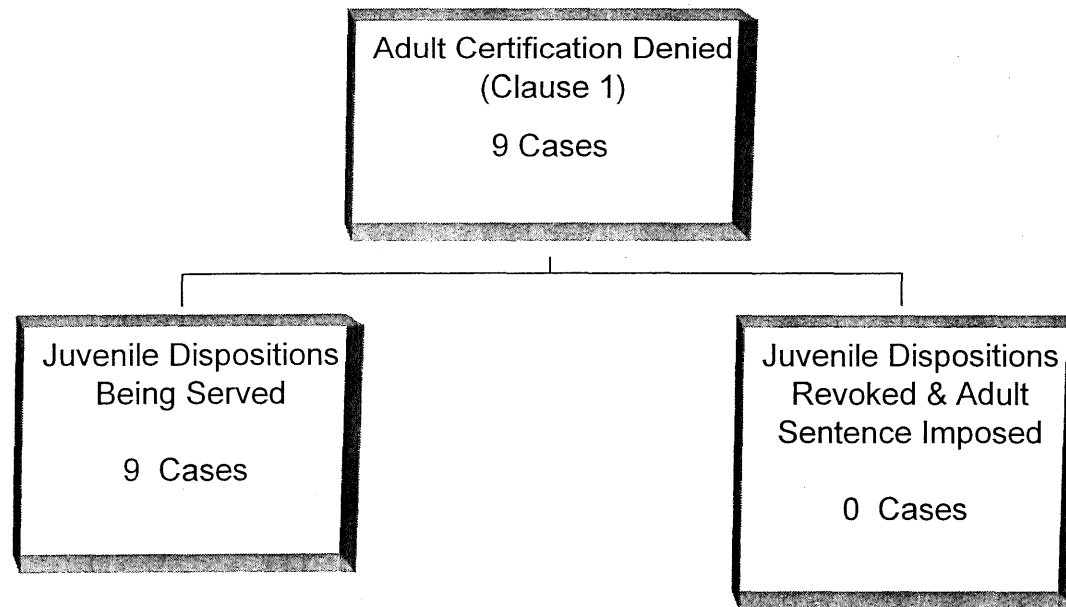


2nd Judicial District Disposed EJJ 1996



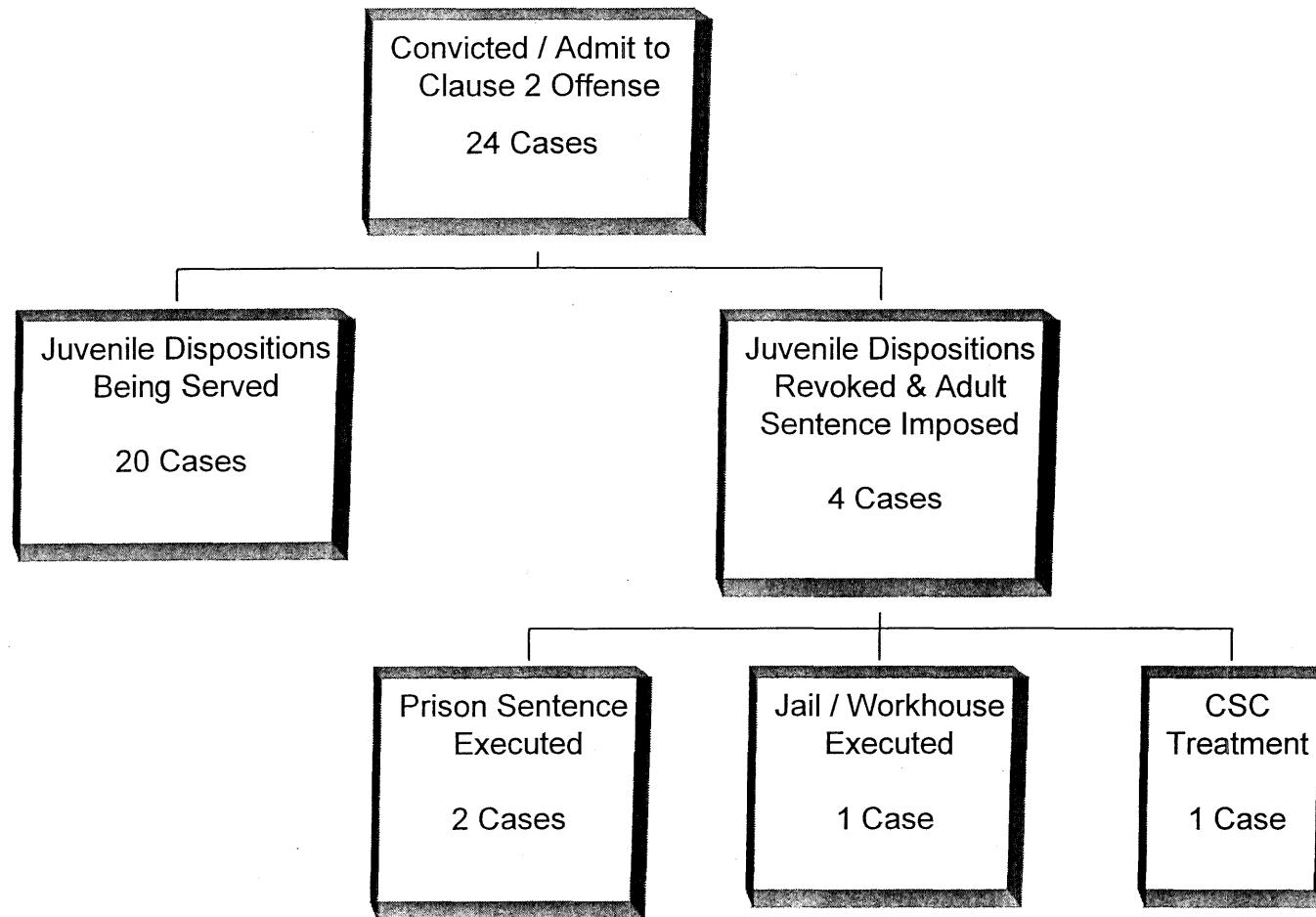

2nd Judicial District Disposition Status of Clause 1 EJJ's



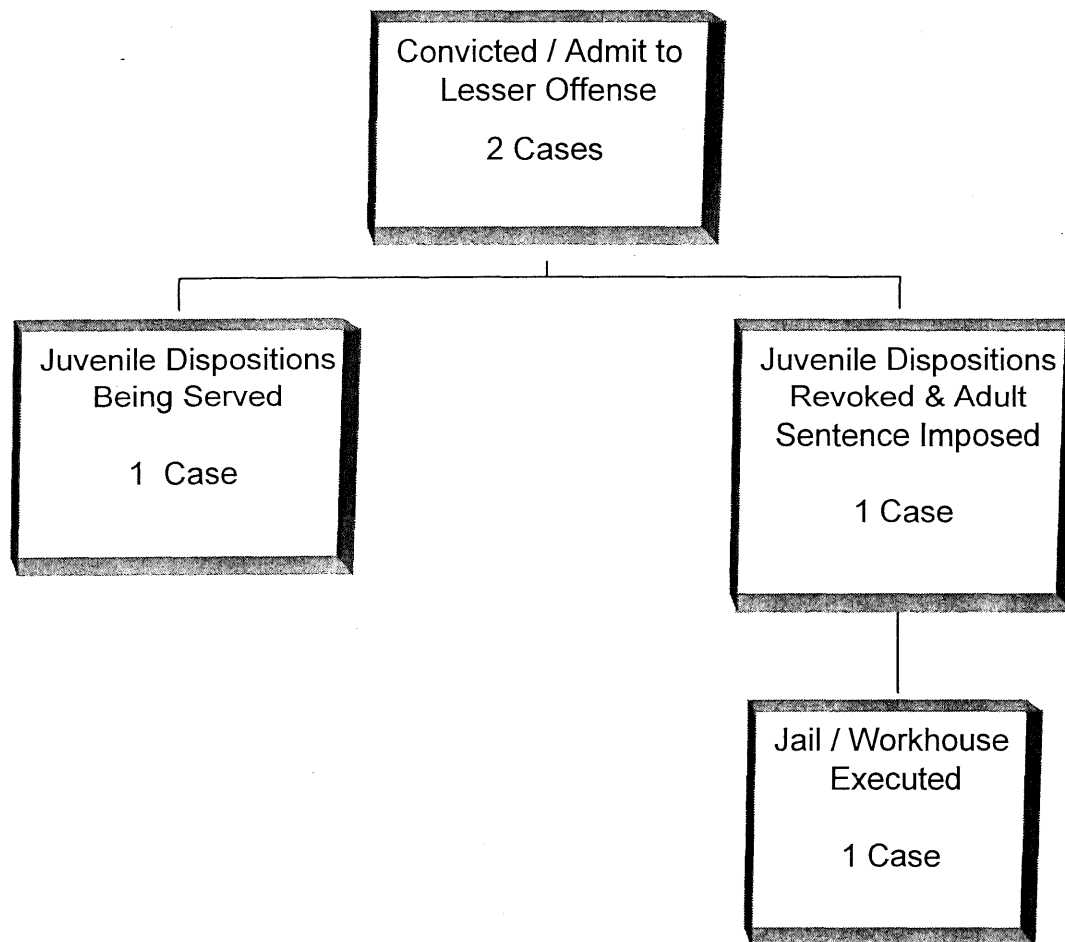

EJJ Disposition Status of Clause 2 Offense Convictions

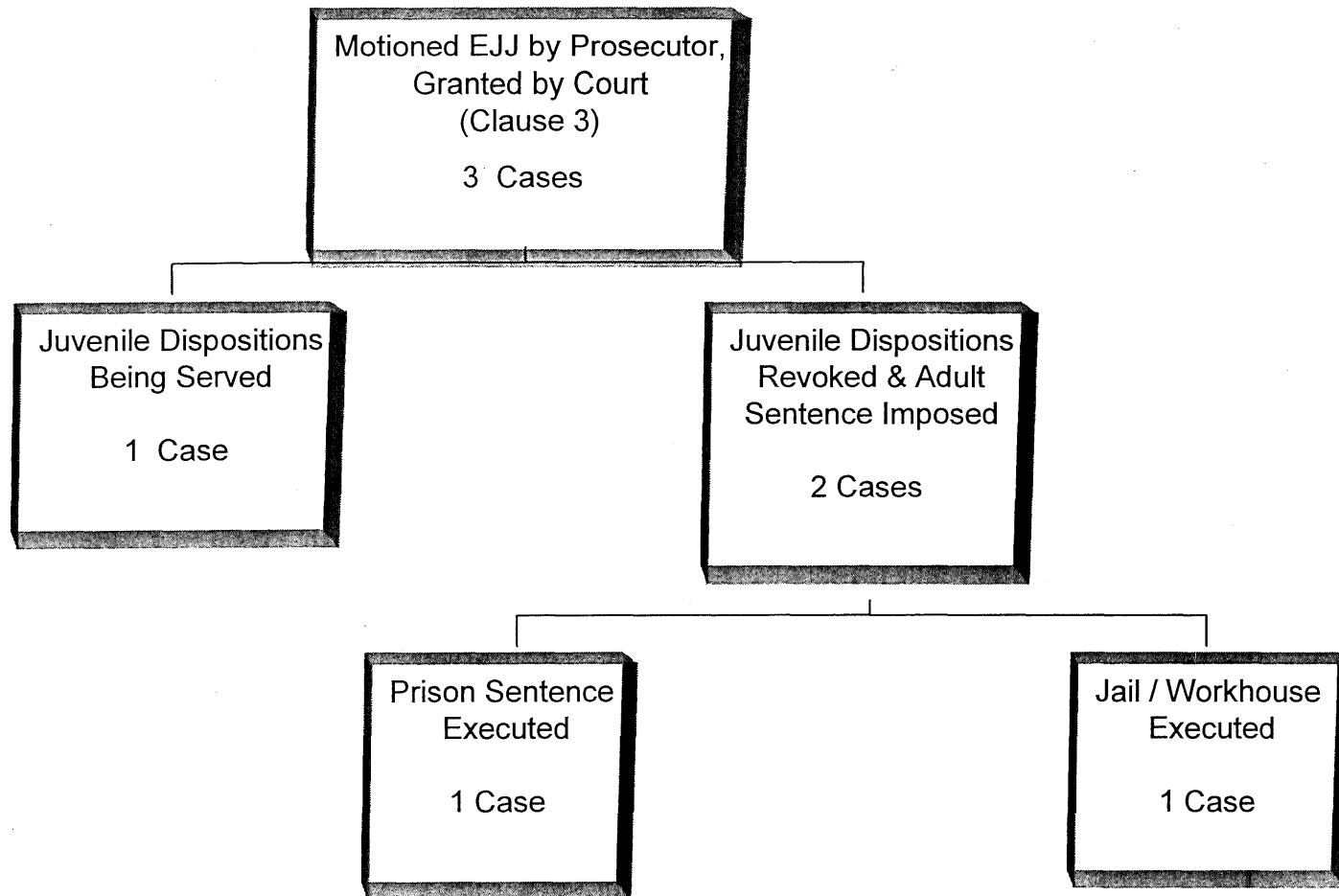

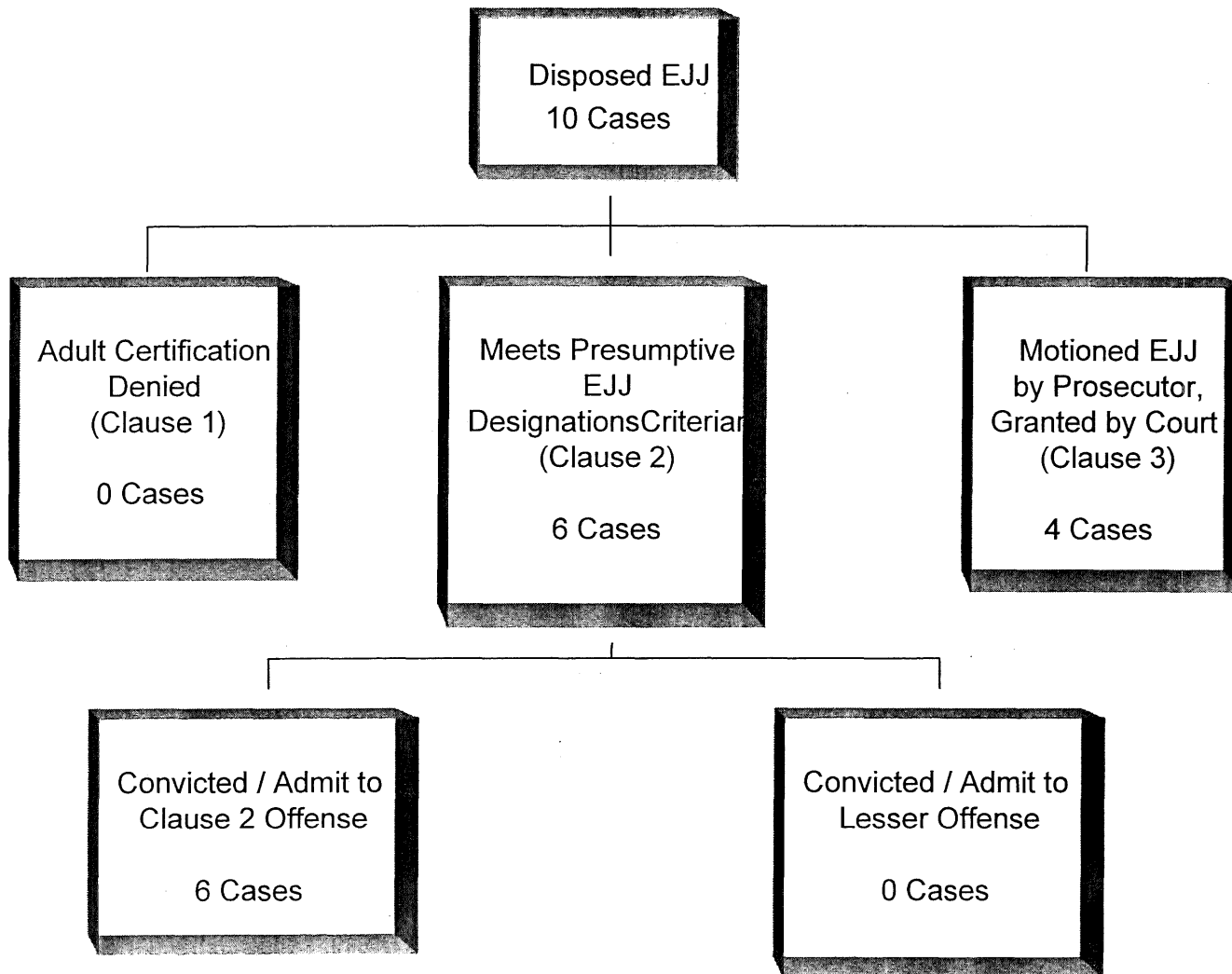
2nd Judicial District Disposition Status of Clause 2 EJJ's w/ Lesser Convictions



2nd Judicial District Disposition Status of Clause 3 EJJ's

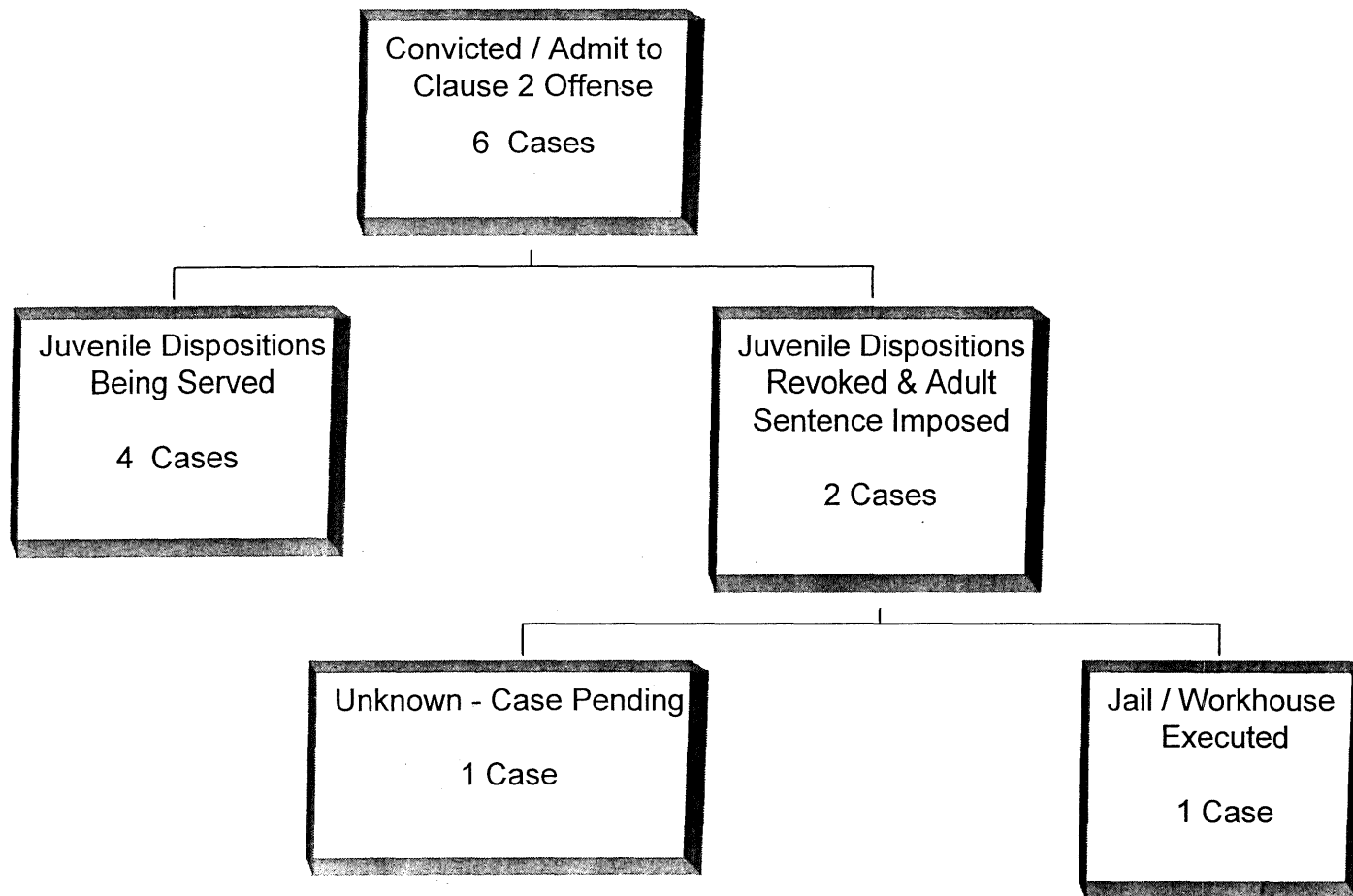


3rd Judicial District Disposed EJJ 1996

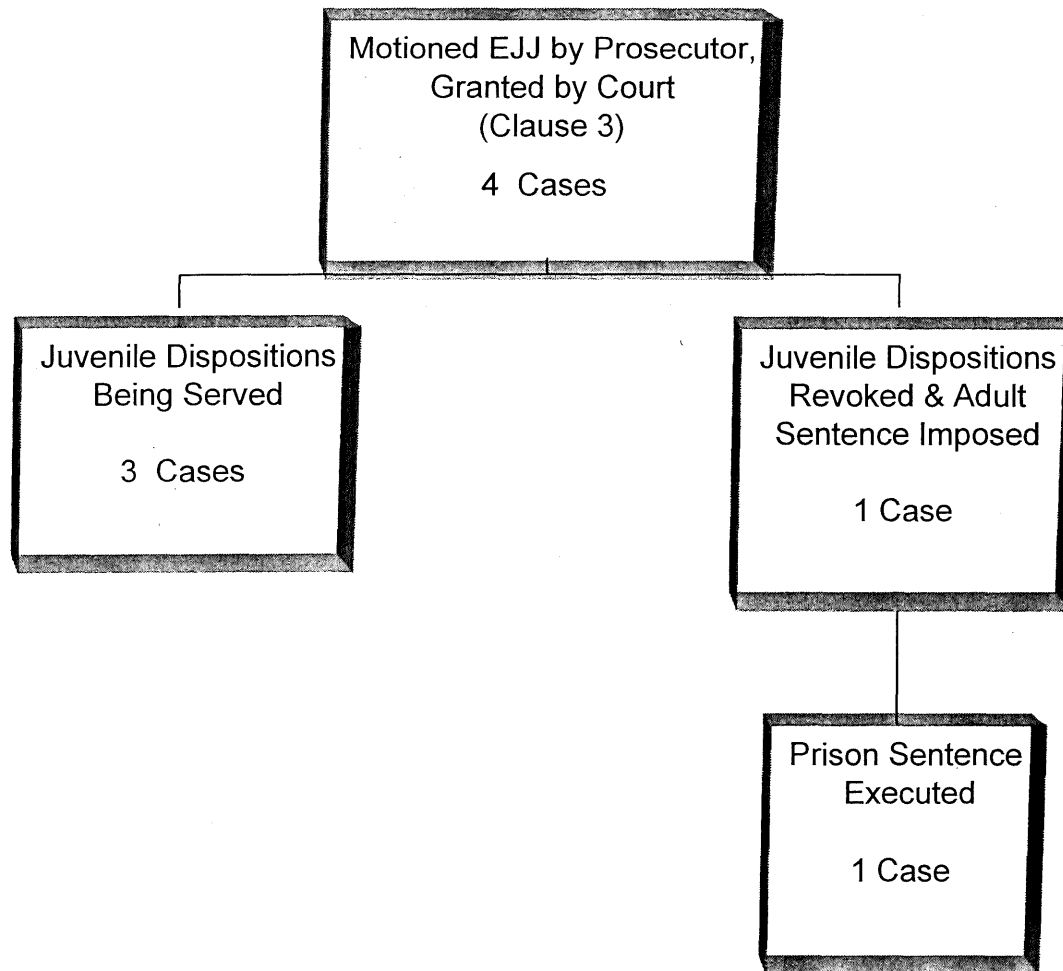

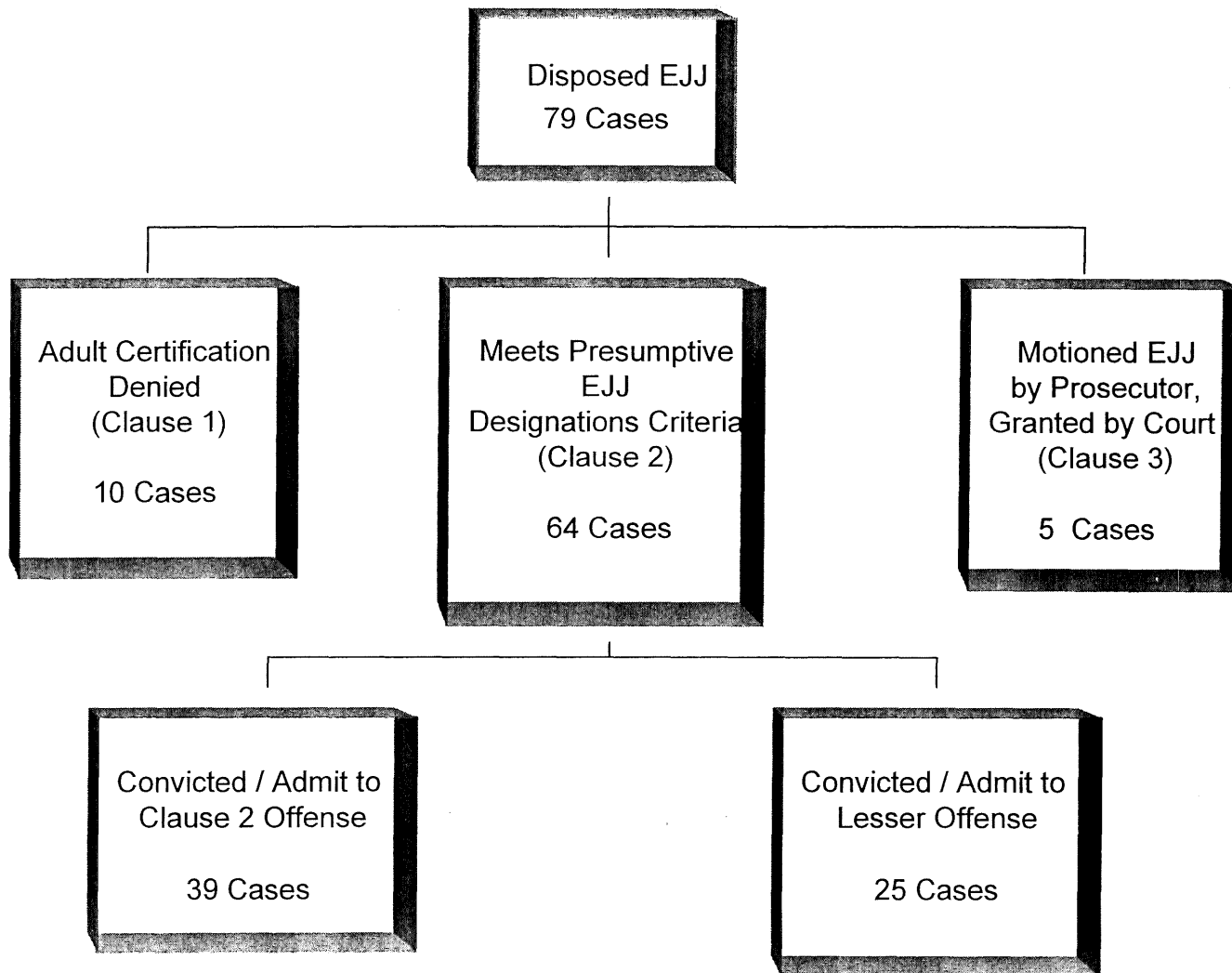
EJJ Disposition Status of Clause 2 Offense Convictions



3rd Judicial District Disposition Status of Clause 3 EJJ's

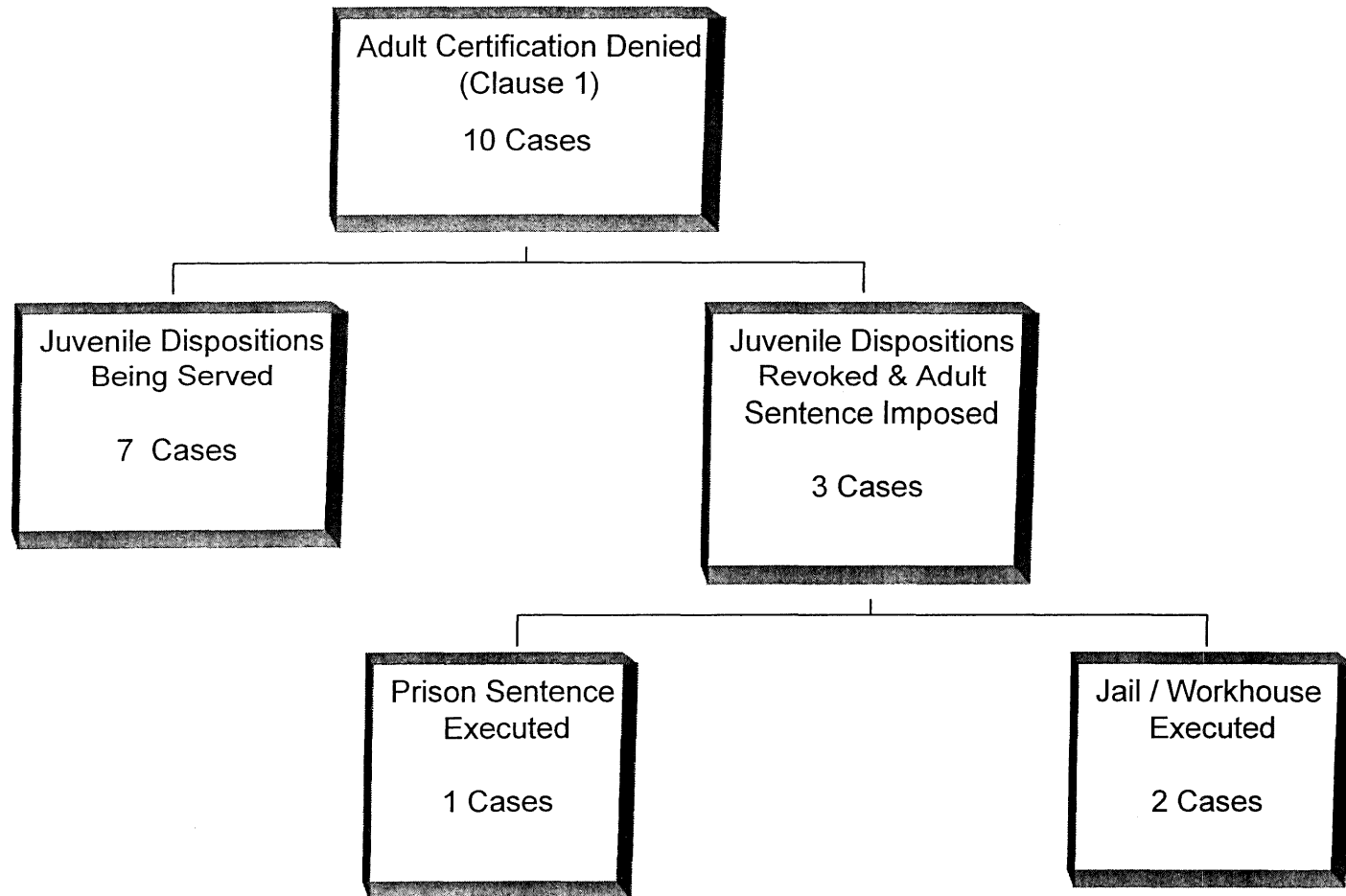


4th Judicial District Disposed EJJ 1996



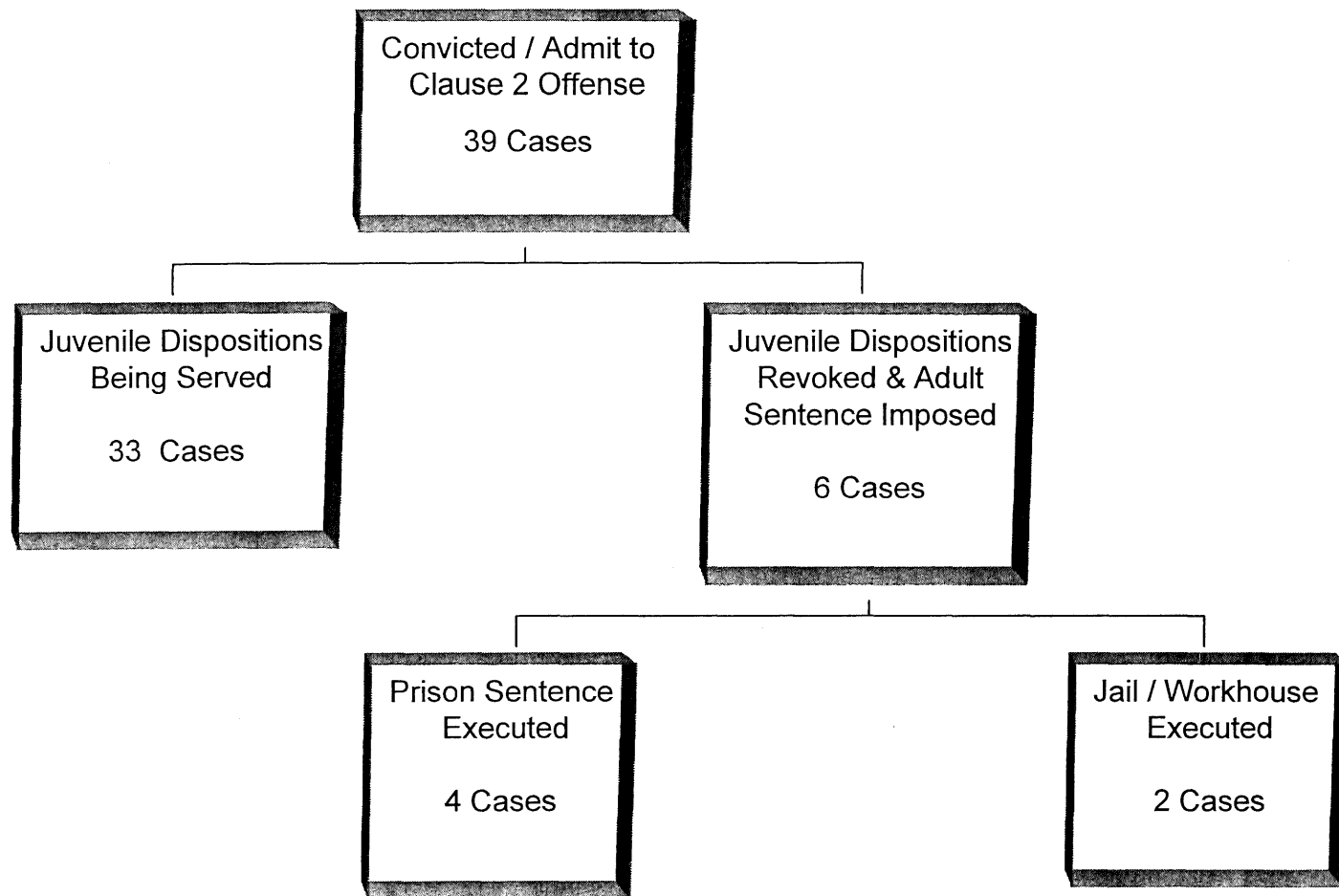

4th Judicial District Disposition Status of Clause 1 EJJ's



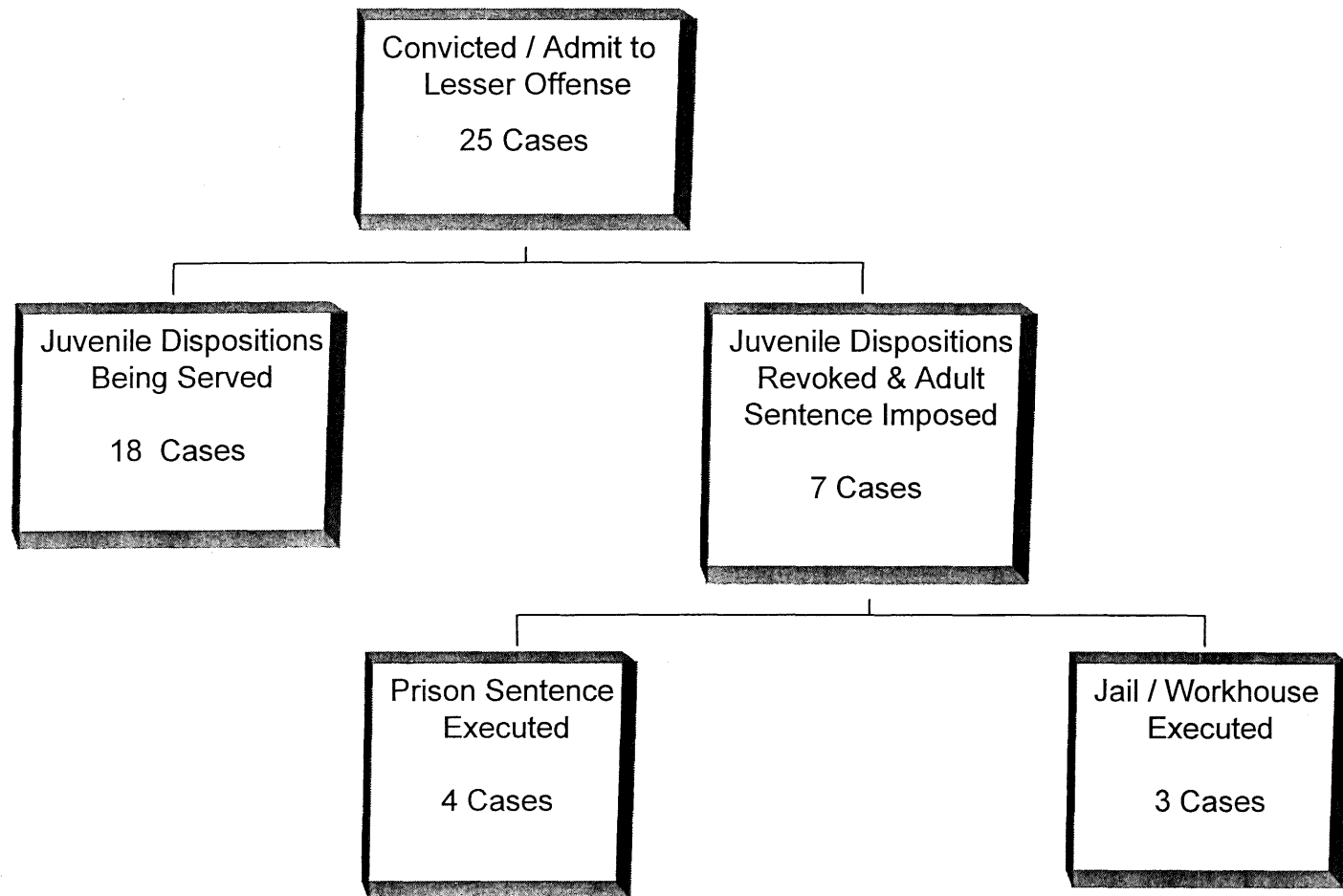

EJJ Disposition Status of Clause 2 Offense Convictions

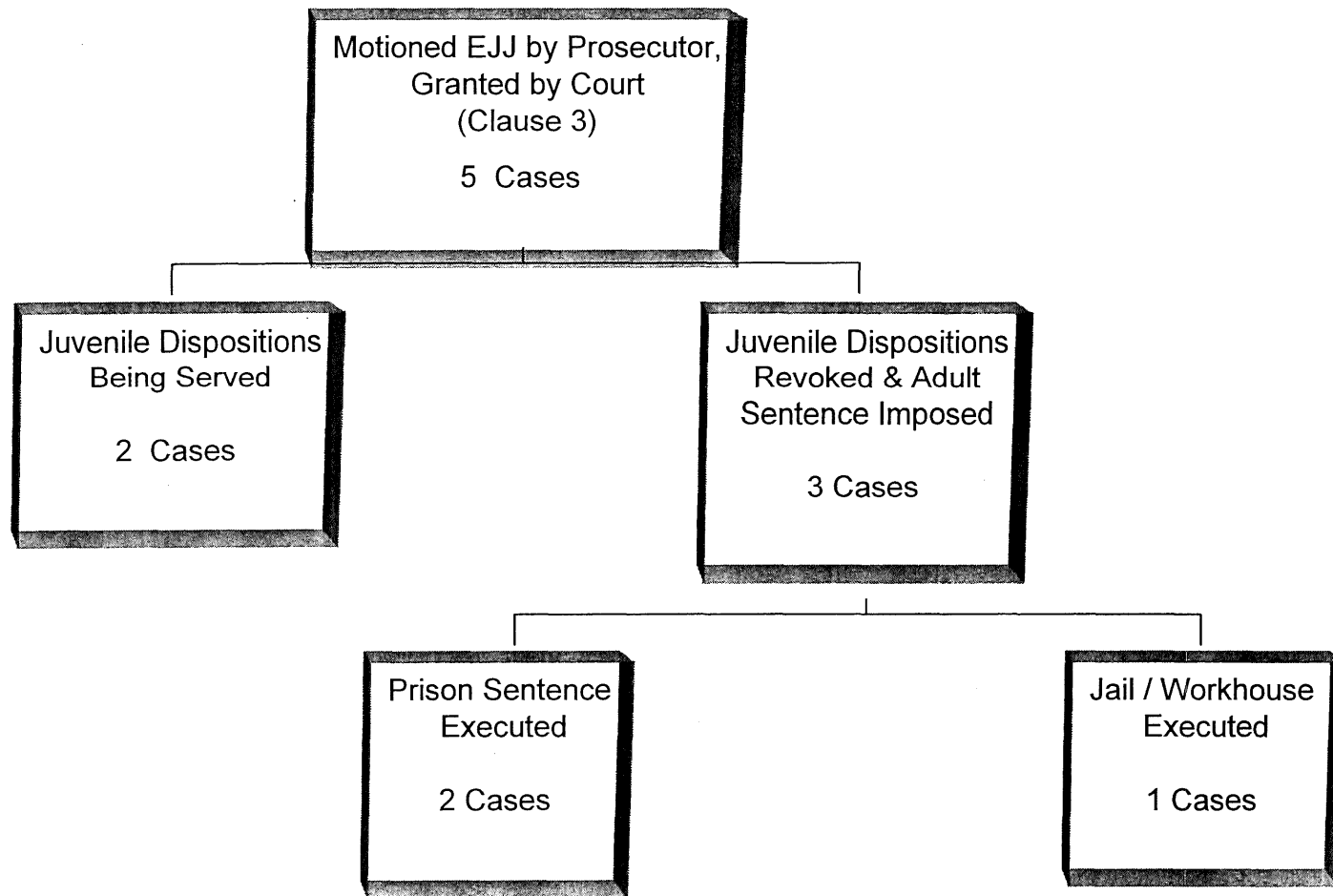

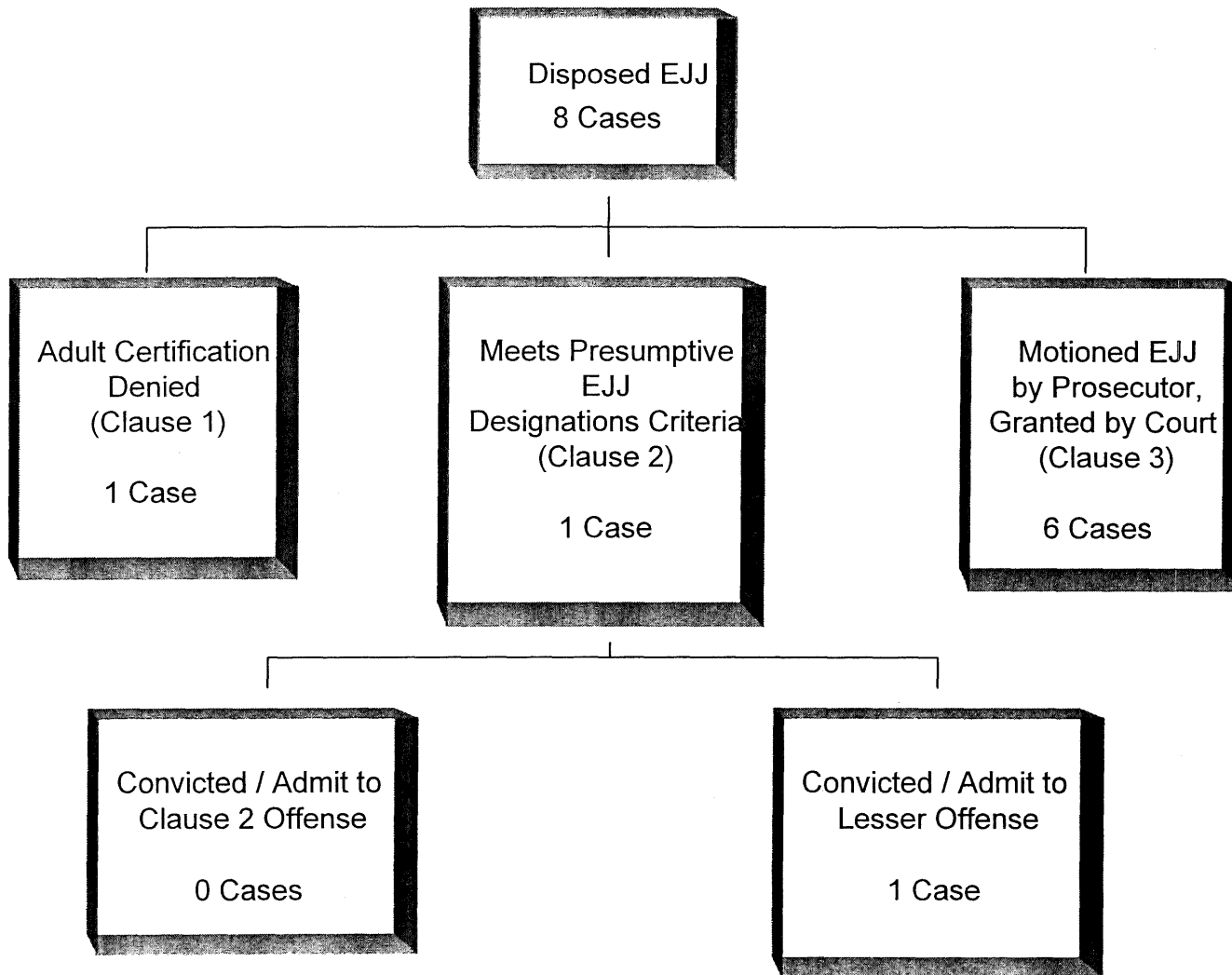
4th Judicial District Disposition Status of Clause 2 EJJ's w/ Lesser Convictions



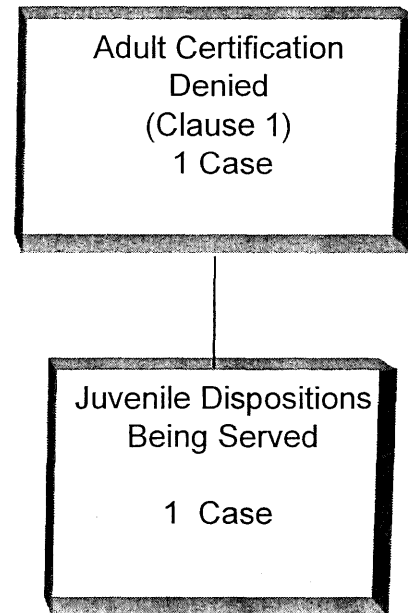
4th Judicial District Disposition Status of Clause 3 EJJ's



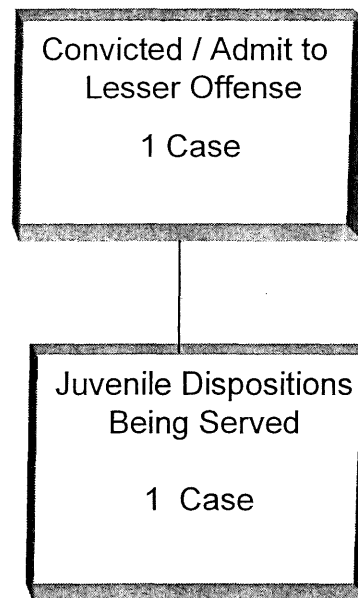
5th Judicial District Disposed EJJ 1996



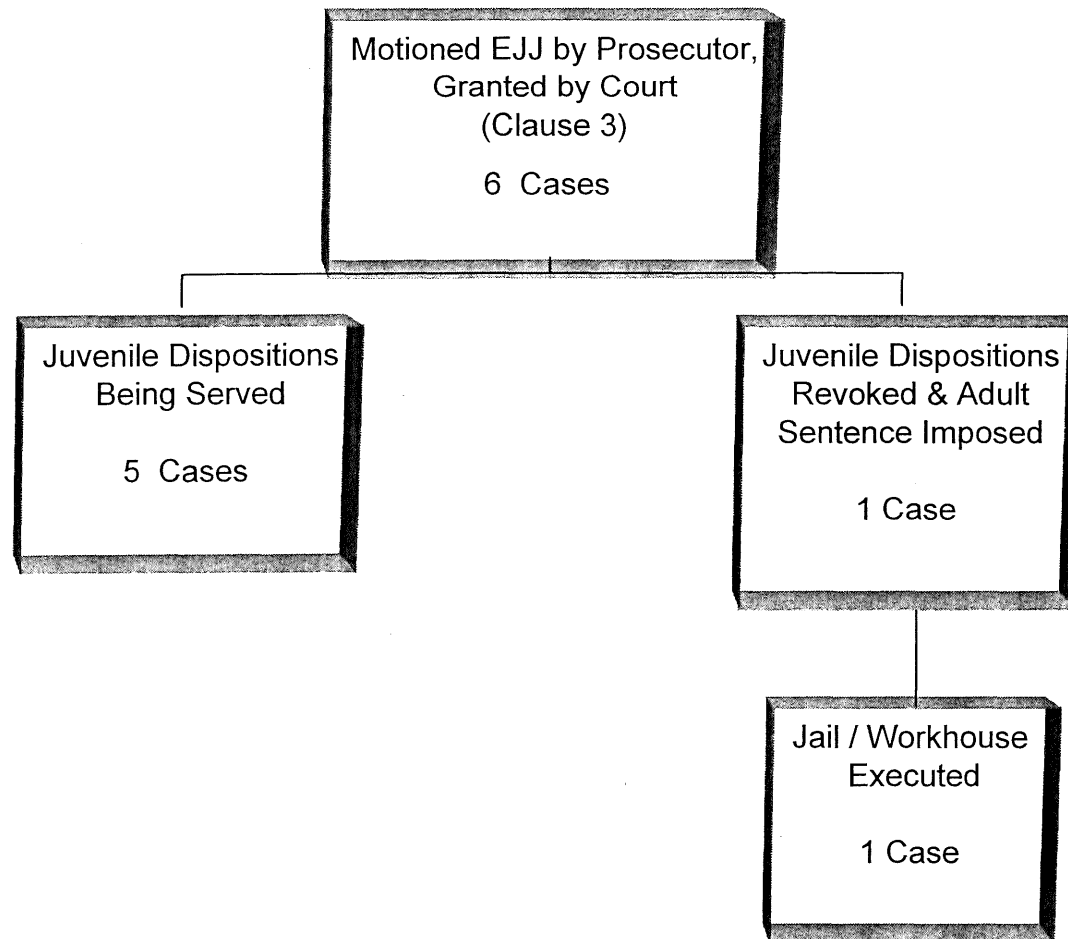
5th Judicial District Disposition Status of Clause 1 EJJ's



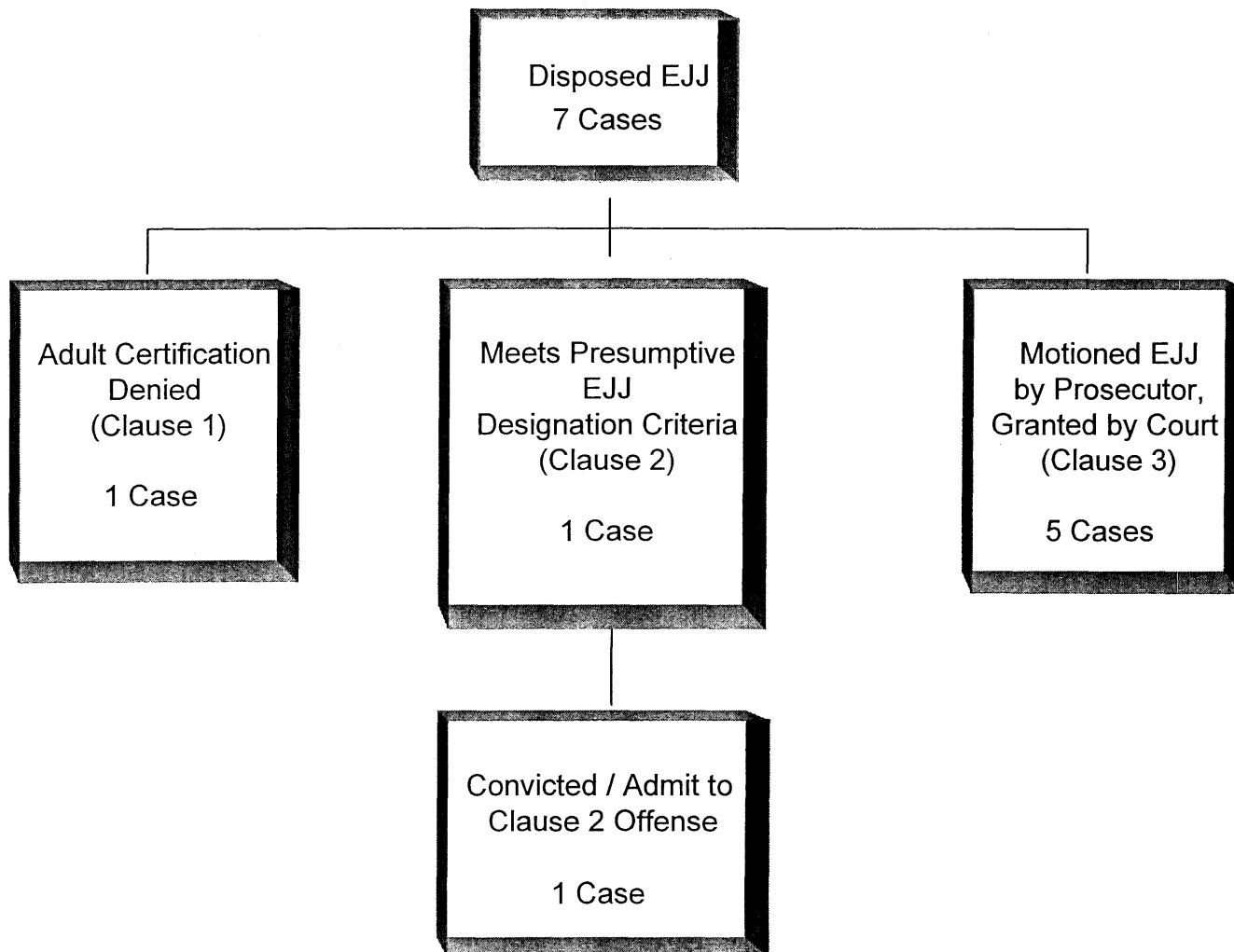
5th Judicial District Disposition Status of Clause 2 EJJ's w/ Lesser Convictions

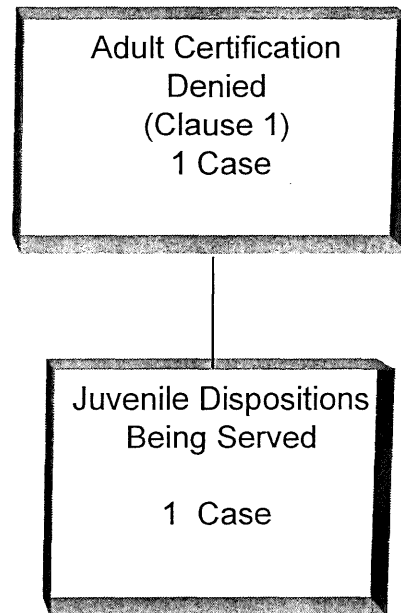


6th Judicial District Disposed EJJ 1996



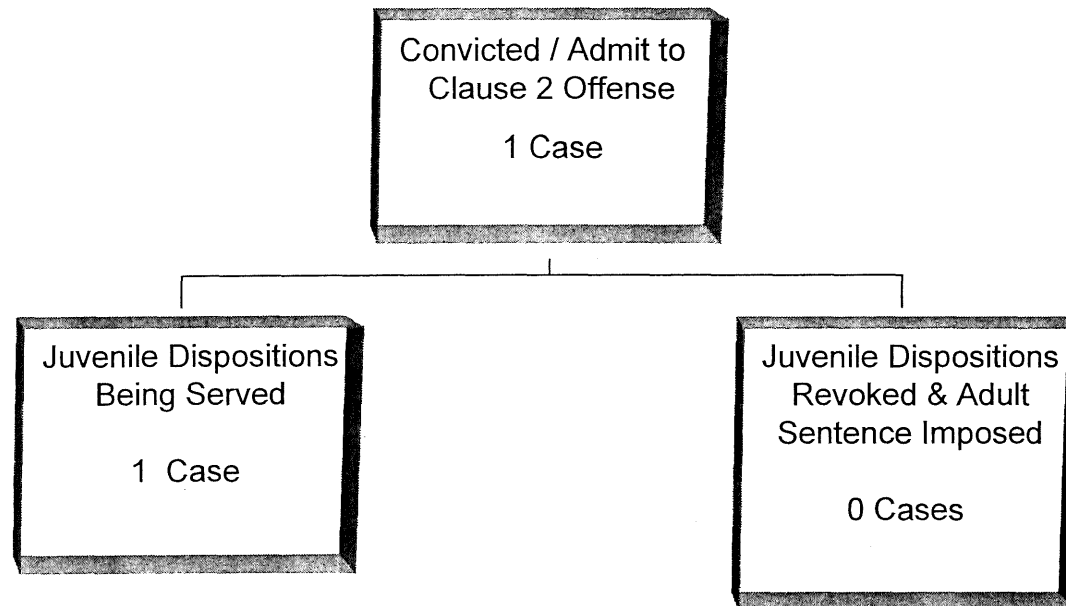

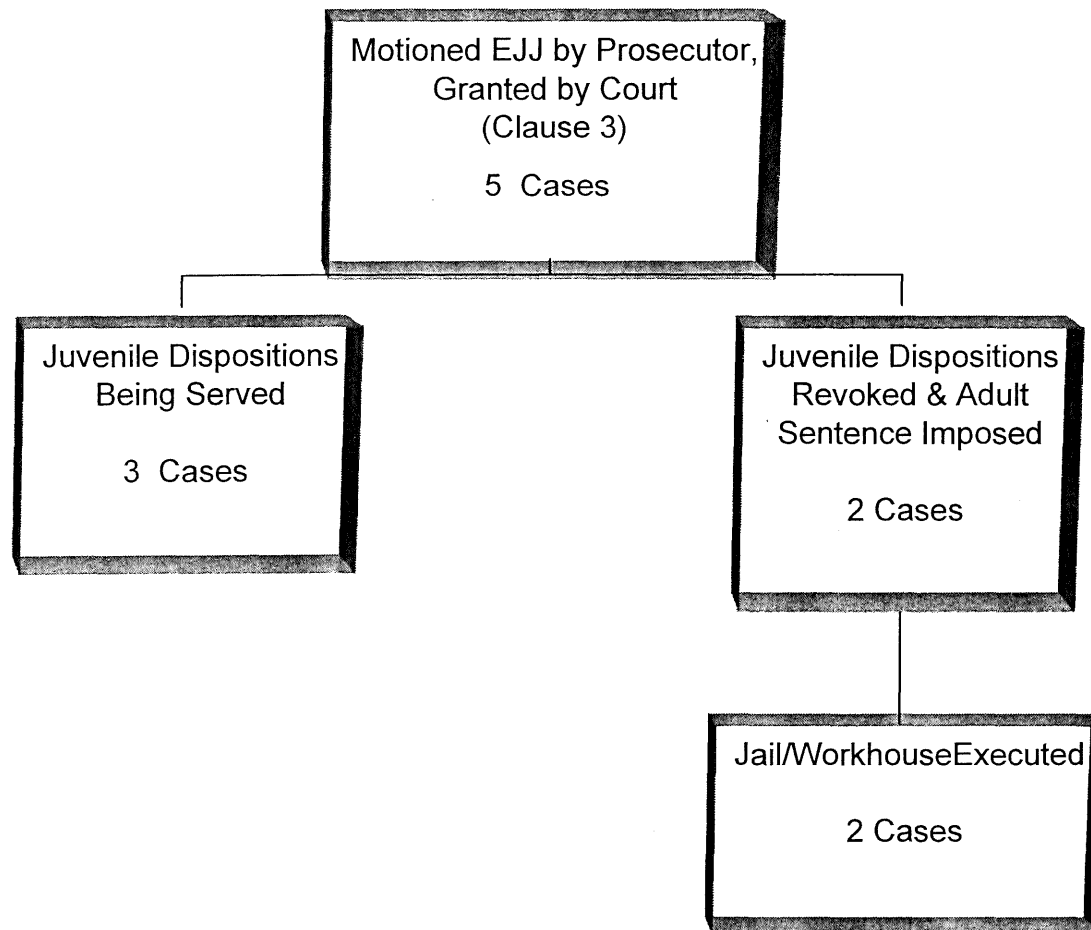

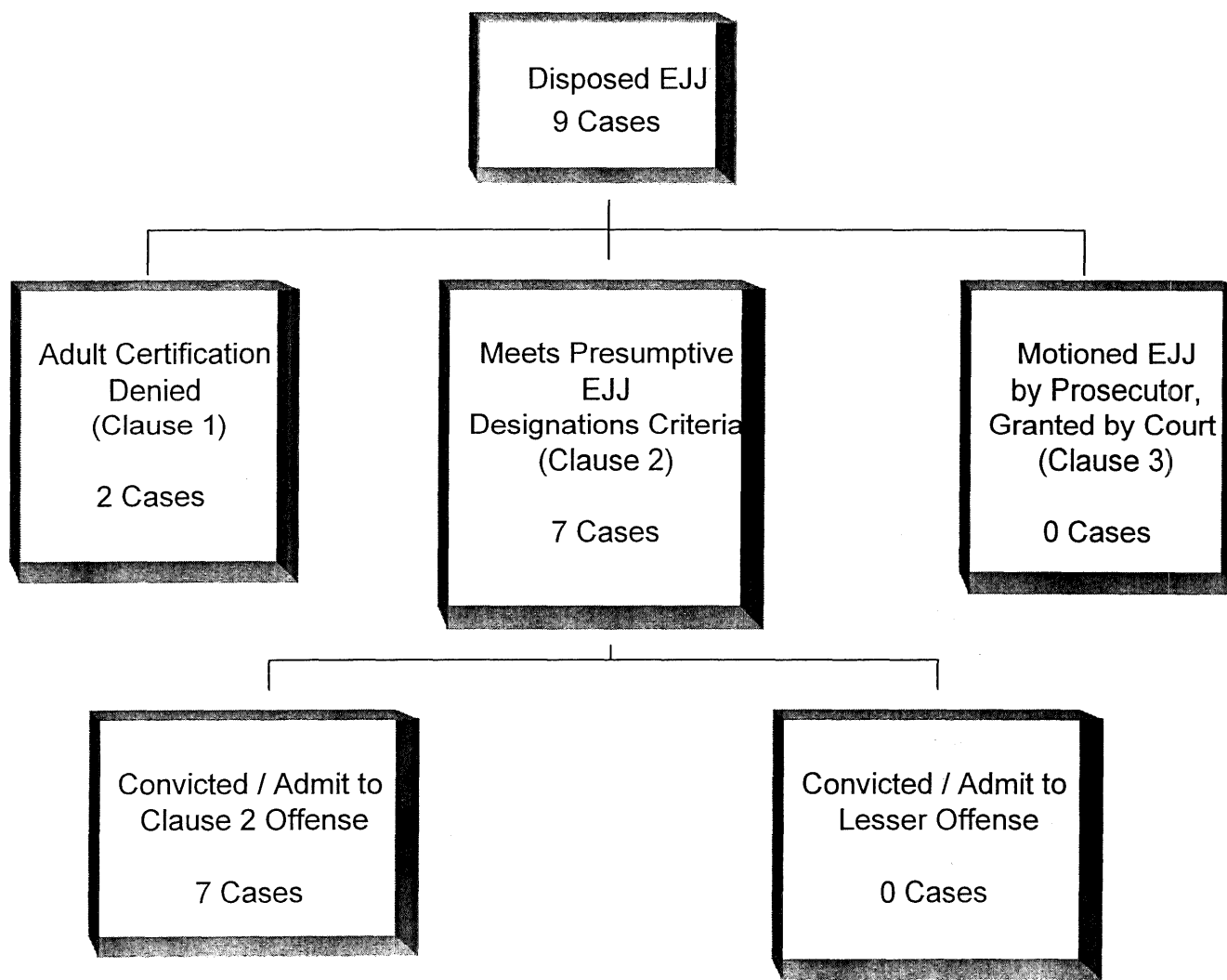
EJJ Disposition Status of Clause 2 Offense Convictions



6th Judicial District Disposition Status of Clause 3 EJJ's

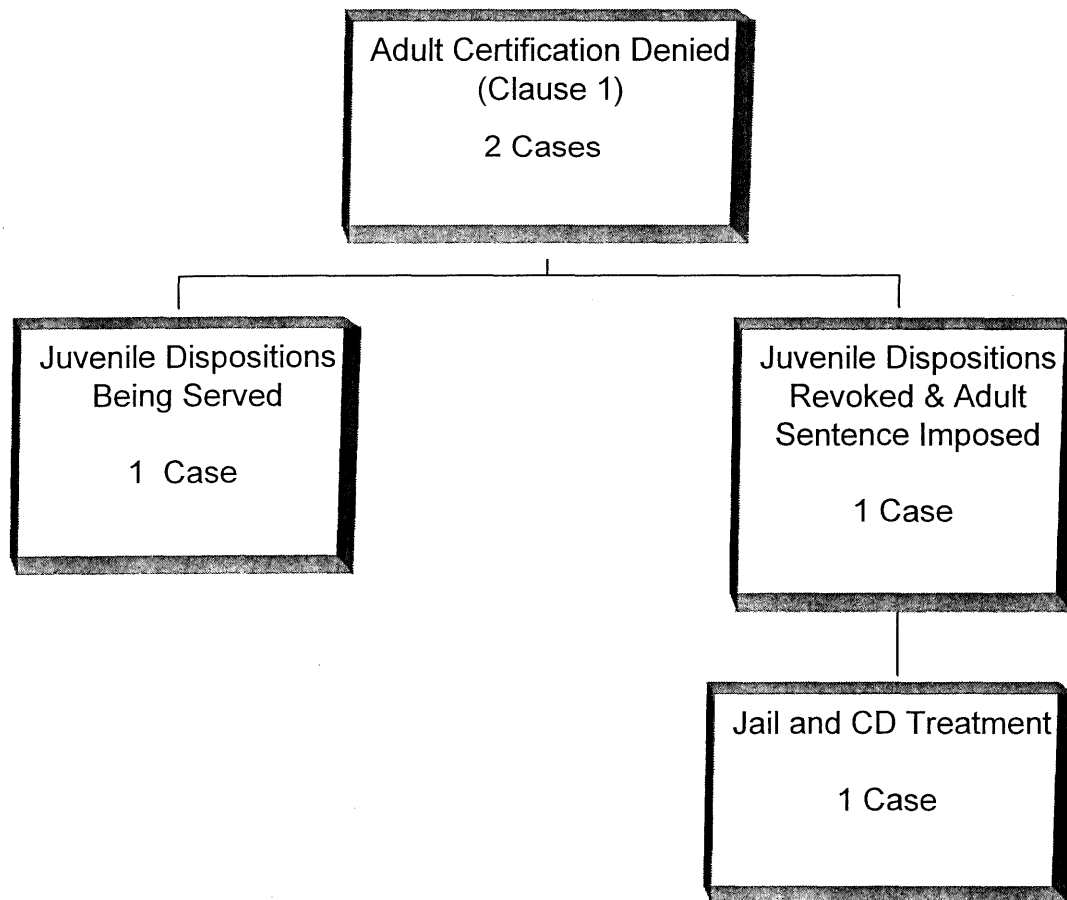


7th Judicial District Disposed EJJ 1996



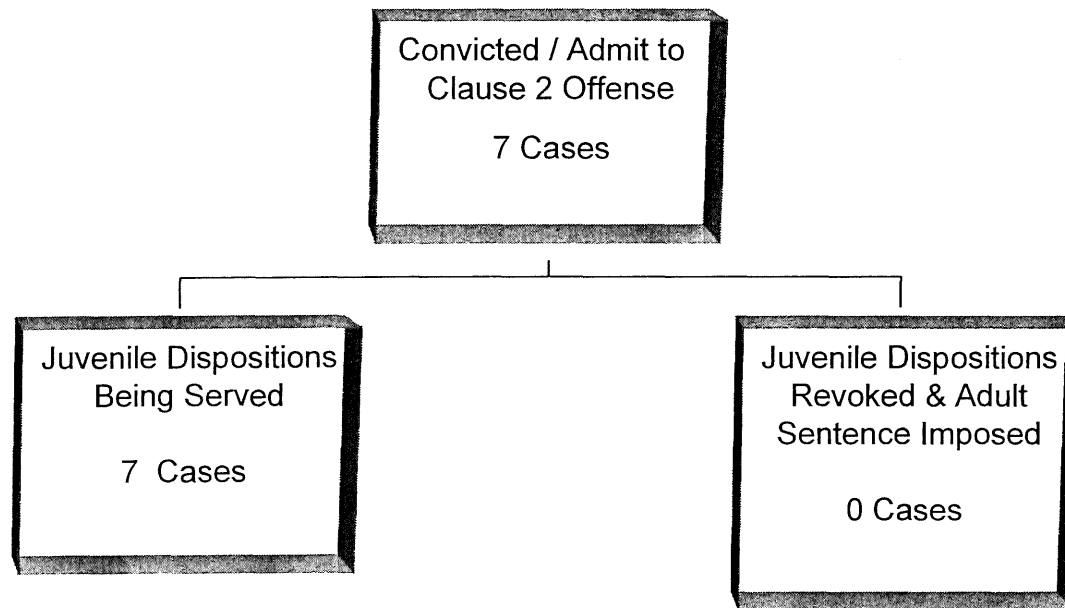

7th Judicial District Disposition Status of Clause 1 EJJ's

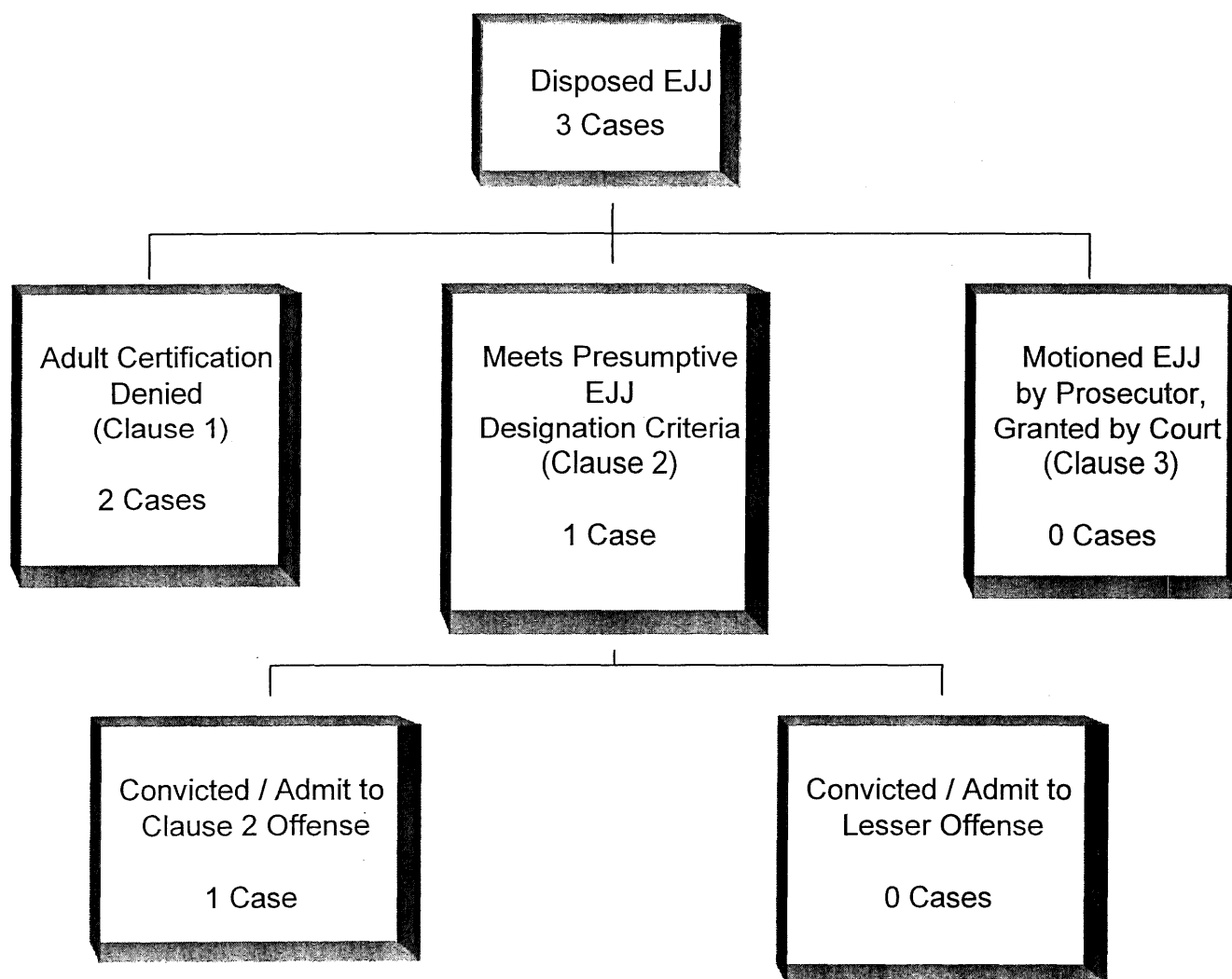

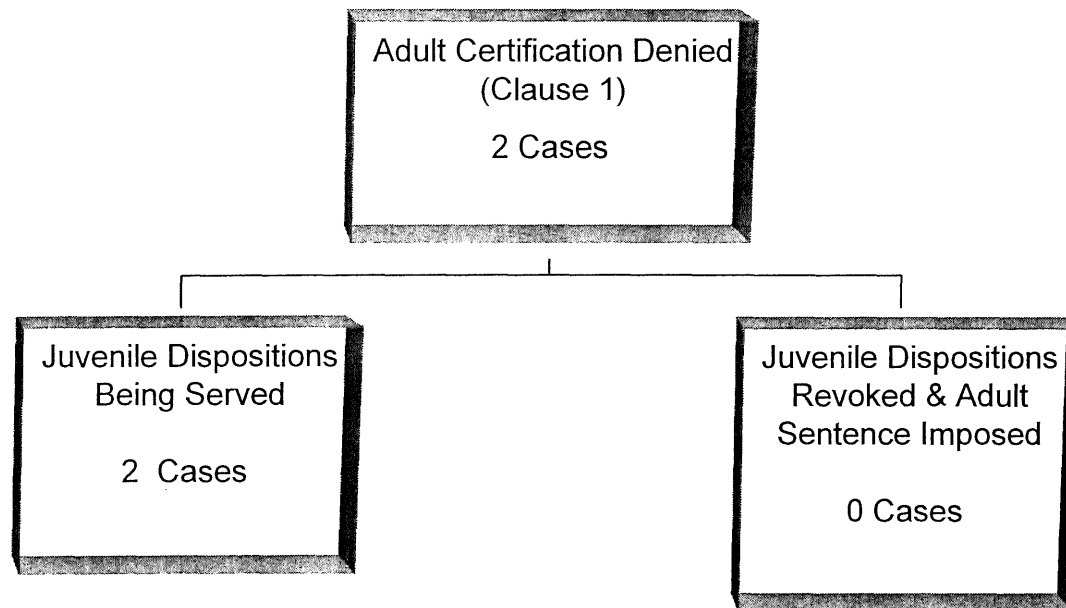
EJJ Disposition Status of Clause 2 Offense Convictions

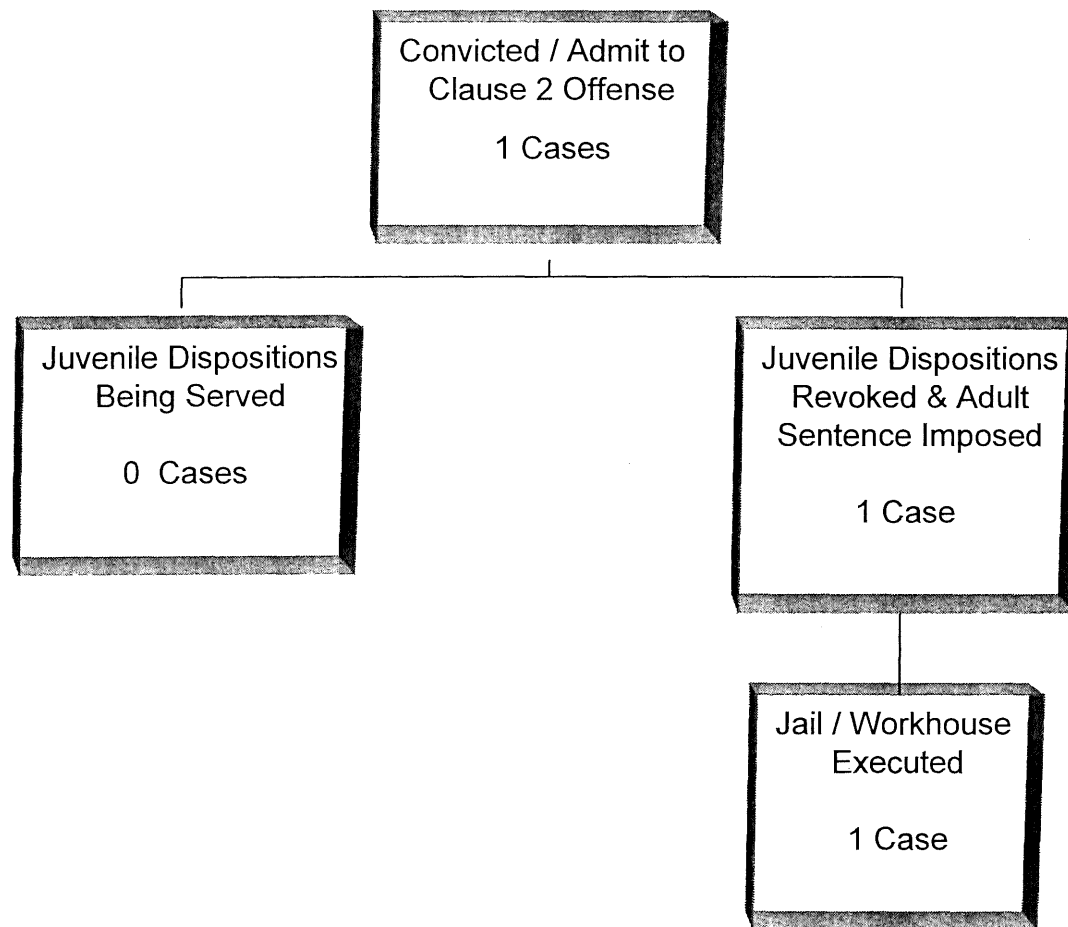


8th Judicial District Disposition Status of Clause 1 EJJ's

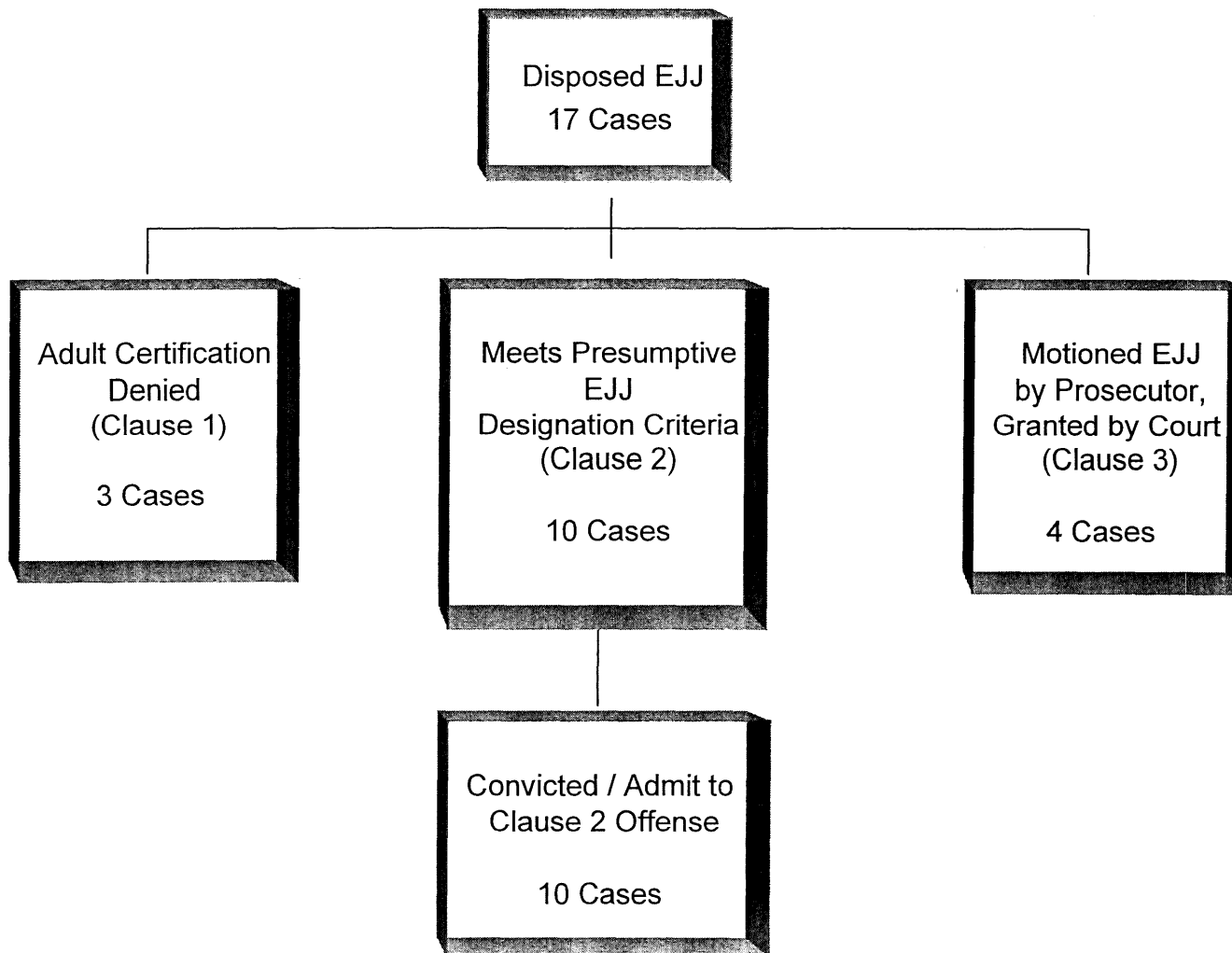

EJJ Disposition Status of Clause 2 Offense Convictions

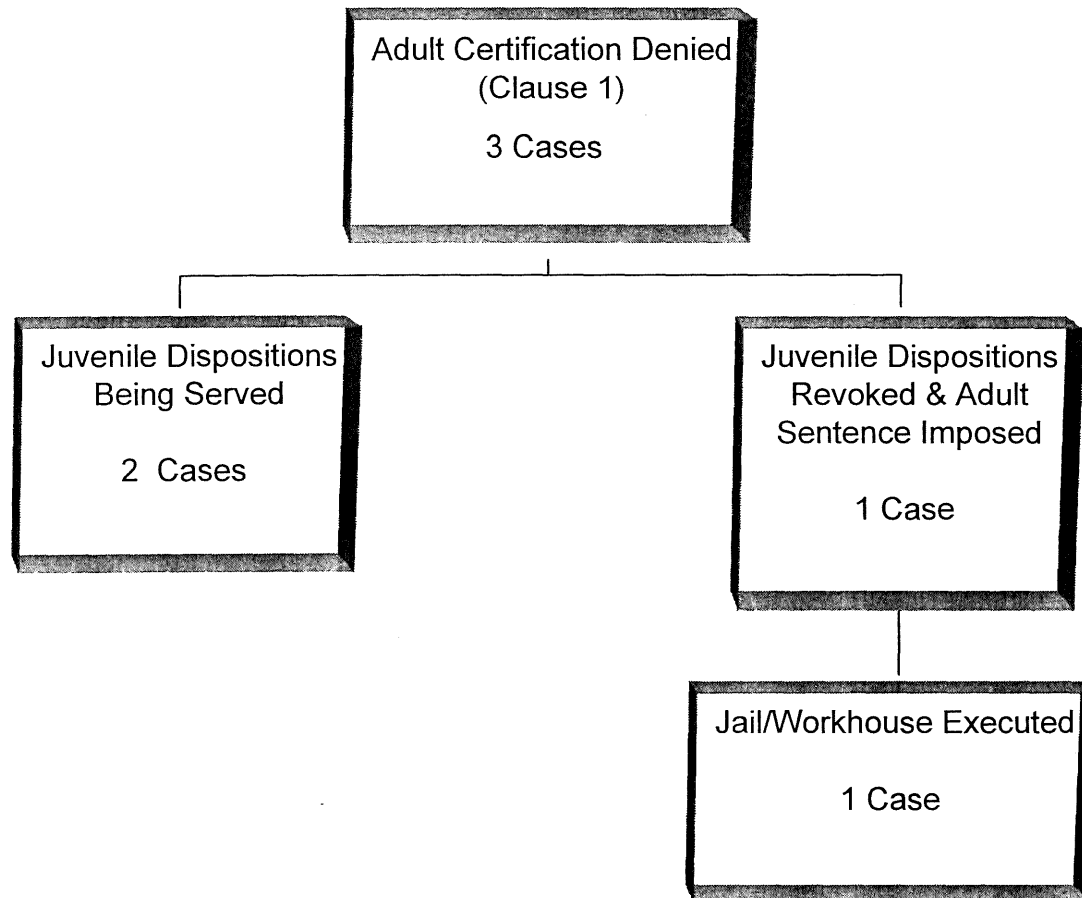


9th Judicial District Disposed EJJ 1996



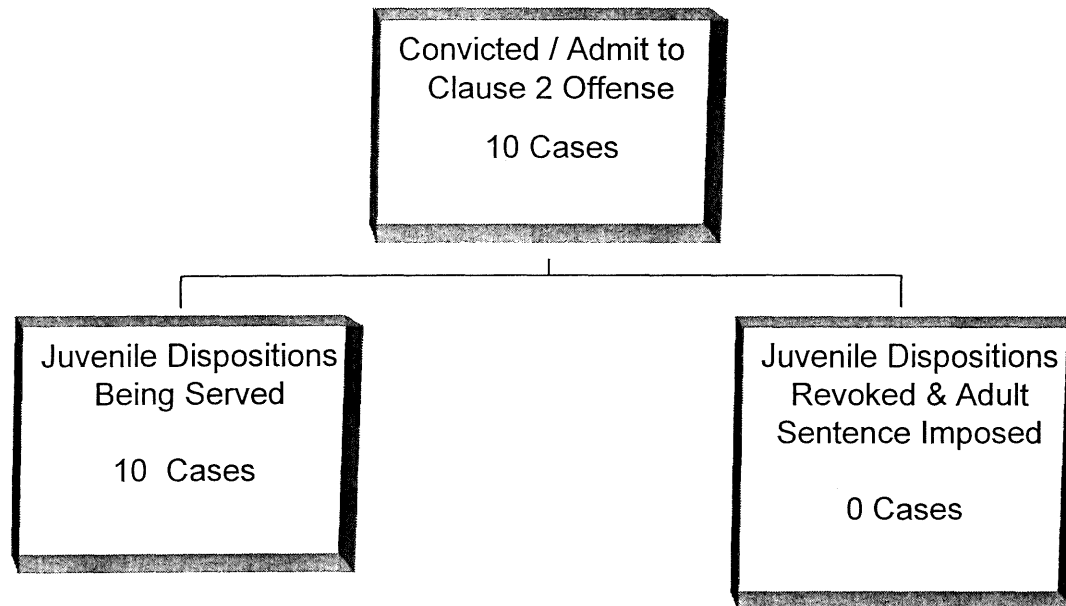

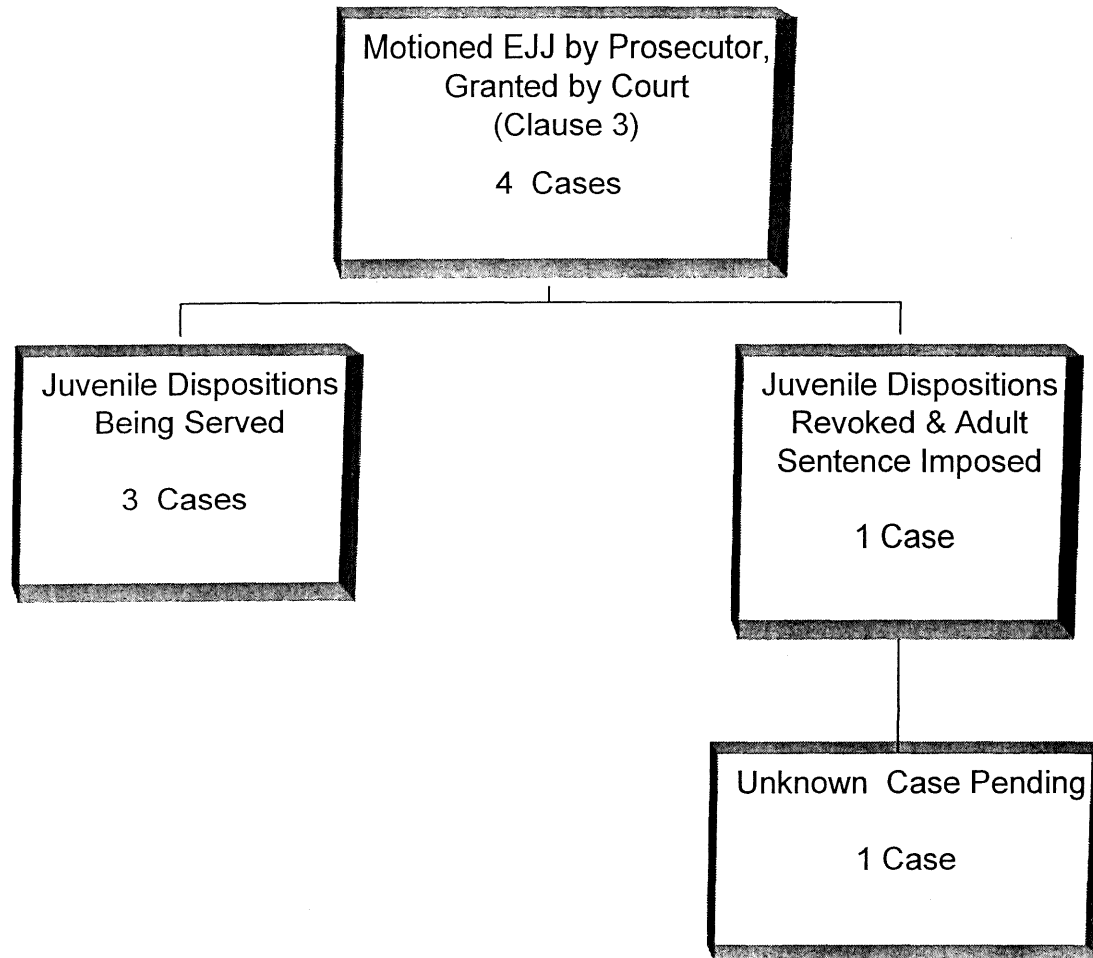

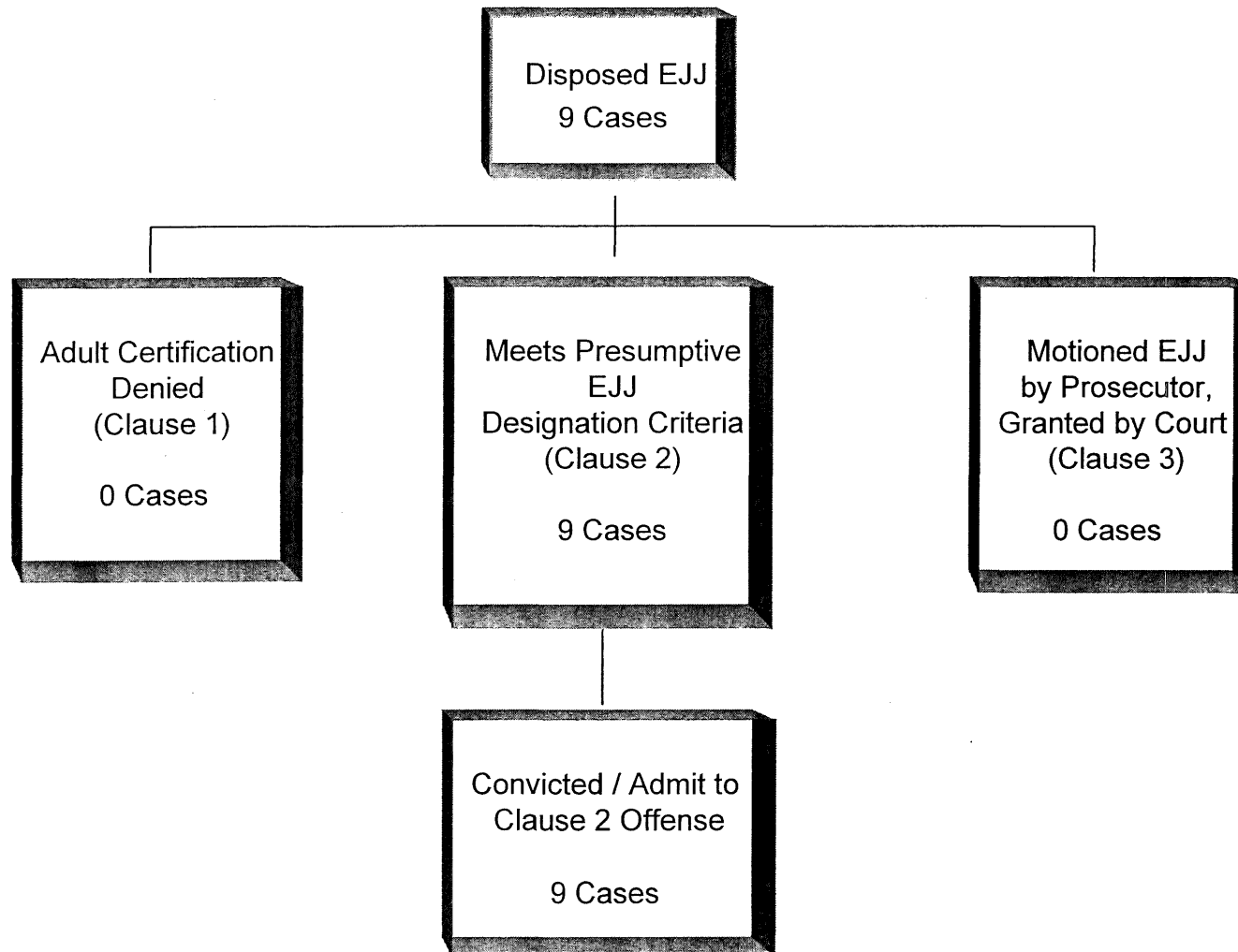
EJJ Disposition Status of Clause 2 Offense Convictions
