## **Meeting Minutes:**

Meeting Began: 6:09 PM

#### Welcome/Housekeeping Items

Chair Eric Magnuson made introductory remarks and addressed housekeeping items – announcements, schedule, agenda, etc.

#### **Legislative Updates**

Chair Magnuson and Vice Chair Rosenbaum updated the Task Force on meetings they had with key legislators earlier that day regarding Task Force work. Sen. Lourey said that the Chair and Vice Chair had accurately described what had transpired. Rep. Liebling said she appreciated the

way in which the Chair and Vice Chair had laid out the issues. Chair Magnuson referenced the upcoming deadlines for bills to pass through policy committees (March 15 and March 22).

Chair Magnuson asked Robin Vue-Benson of the Department of Human Services (DHS) to review the purpose of two "agency bills" that came from DHS and were approved by the Governor's office and are moving through the legislative process (the two bills are SF 490/HF 947, and SF612/HF 948). The first recodifies the commitment statutes so that the provisions dealing with sex offender civil commitment are moved to their own chapter, and thus would no longer be mixed with the provisions dealing with commitment for those who are either chemically dependent, or mentally ill and dangerous. The second deals with procedures for sex offender civil commitment special review boards, judicial appeal panels, provisional discharge and victim notification.

Presentation from Task Force member Dr. Michael Thompson on sex offender risk assessment (definition/measurement/management)

Chair Magnuson discussed the timing for the next meeting with Task Force members. It was decided that it would be on Monday, March 11, from 6:00 to 9:00 p.m. The Chair and Vice-Chair hope to have specific interim recommendations for the members to consider.

#### **Public Comment:**

- Thomas Koepke said that he recently went to Moose Lake for an annual review impressed with the program the person he is mentoring has matured from age 19 to 27.
- Al Kretsinger referenced nuclear power plants, and discussed a body-soul-spirit concept. Contended that a greater emphasis on religion would be beneficial.
- Tammy Annen referenced interviews regarding the Task Force said that now might be a good time to do them, given the recent story on KSTP, which she said did not paint MSOP in a good light. Appreciates Opheim comments about evaluation. Thank you all for your work.
- Russ Lovaasen Thanked the task force for its work. Discussed process for having people exiting the system. Said that the original creators did not expect it to be a life sentence. Recommended funding be changed so it is easier for counties to do the job.
