# **Meeting Minutes:**

Meeting Began: 6:10 PM

## **Introduction (Overview and Housekeeping Items)**

Chair Eric Magnuson made introductory remarks and addressed housekeeping items.

## **Update on Presentation to Legislators**

Chair Magnuson updated the group regarding his presentation on January 25 at William Mitchell School of Law to a group of legislators and legislative staff. He provided a number of materials to the legislators. Both William Mitchell Dean Eric Janus and Chair Magnuson presented.

### Review / Discussion of Procedural & Substantive Issues

Chair Magnuson commented regarding where the group left off at last week's meeting and opened the floor for discussion among Task Force members regarding issues such as a centralized panel, standards and process for commitment, burden of proof, etc.

Task Force members speaking on these issues included Rep. Jim Abeler, Sen. Chair Magnuson asked Kelly Mitchell and Ryan Magnus to work together to develop language and a proposal for the next meeting on qualifications for defense counsel.

Chair Magnuson opened discussion among Task Force members regarding issues such as burden of proof and commitment standards. Task force members speaking on these issues included Roberta Opheim, Judge Gearin, Judge Nelson, County Attorney Ostrem, Vice Chair Rosenbaum, Chair Magnuson, Ryan Magnus, Dean Janus, and Commissioner Roy.

Chair Magnuson asked Dean Janus to summarize his report regarding the sex offender civil commitment statute and case law, which he did. Commissioner Roy and Ryan Magnus commented. Chair Magnuson asked Assistant Hennepin County Attorney John Kirwin to explain his interpretation of the statute and corresponding case law, which he did.
