Meeting Began: 6:15PM

Welcome/Housekeeping Items/Updates from Task Force Chair and Vice Chair

Chair Eric Magnuson welcomed the members and addressed housekeeping items.

Continued discussion of draft recommendations

Chair Magnuson explained the situation – this meeting is the last scheduled meeting at this time, the Task Force Report will be coming out soon, so language decisions have to be wrapped up.

The Task Force moved into a discussion of draft recommendations, including language on violence prevention. Members joining in this discussion included Donna Dunn, Comm. Roy, Gerald Kaplan, Judge Smith, and Chair Magnuson.

- Russ Lovaasen questioned the difference between SDP and SPP
- Thomas Koepke said this was the first time he was ever involved with the legislative process and that state employees do a marvelous job
