Senate Concurrent Resolution No. 3: A Senate concurrent resolution approving and ratifying grant of the Minnesota Centennial Commission to the Twin City Area Educational Television Corporation for the erection of a building.

Whereas, on December 18, 1958, the Minnesota Centennial Commission unanimously passed a motion granting \$100,000 to Twin City Area Educational Television Corporation, which operates KTCA-TV, Channel 2, for erection of a building to be known as the Minnesota Statehood Centennial Memorial Building for Educational Broadcasting, the grant to be conditioned upon complete building financing by the corporation by July 1, 1959, and further conditioned upon approval and ratification by the legislative Session of 1959; and

Whereas, the erection of the proposed Minnesota Statehood Centennial Memorial Building for Educational Broadcasting will constitute a great and lasting benefit to the people of the State of Minnesota, will promote the cause of education and will constitute a fitting and permanent memorial of the centennial of the State of Minnesota;

Now, Therefore, Be It Resolved, by the Senate of the State of Minnesota, the House of Representatives concurring, that the grant made by the Minnesota Centennial Commission of \$100,000 to the Twin City Area Educational Television Corporation for the erection of a building to be known as the Minnesota Statehood Centennial Memorial Building for Educational Broadcasting, conditioned upon complete building financing by the corporation by July 1, 1959, is hereby in all respects approved and ratified;

Be It Further Resolved, that the Secretary of the Senate transmit copies of this resolution to the Executive Director of the Minnesota Statehood Centennial Commission and to the President of Twin City Area Educational Television Corporation.

Which resolution was referred to the Committee on Education.
