Janine Mattson addressed the members regarding amendments to the Senate Roster... Senator Ashbach explained the reasons for the minority personnel changes. (See attached) Senator Hanson moved the amendments to the Senate Roster. The motion carried.


The Senate resolution relating to mileage and per diem expenses was brought before the committee. It was pointed out that in-district mileage was only allowed during the interim. Senator Olhoft raised the question of the possibility of in-district mileage during the session also - especially for weekends. Senator Moe suggested we take this up as a separate issue at a later date.

The per diem expenses in the resolution were as follows: From \$27 to \$36 for those who change place of residence during session; and from \$17 to \$23 for those who do not change place of residence.


Pat Flahaven explained that savings in the budget for the Senate would help compensate the increase in per diem.

4 BE IT RESOLVED, by the Senate:

5 Each member who has moved from his usual place of lodging
6 during a substantial part of the sessions of the 72nd
7 Legislature shall receive mileage for necessary travel in going
8 to and returning from the place of meeting to his place of
9 residence in the amount of 19 cents per mile, or any greater
10 amount authorized by the commissioner of employee relations for
11 state employees, for each trip during the 72nd Legislature.

12 Each member who has moved from his usual place of lodging
13 during a substantial part of the sessions of the 72nd
14 Legislature shall be paid per diem living expenses in the amount
15 of \$36 for each calendar day during the sessions of the 72nd
16 Legislature.

17 Each member of the Senate who has not changed his place of
18 lodging for a substantial part of the sessions of the 72nd
19 Legislature shall be paid per diem living expenses in the amount
20 of \$23 for each calendar day during the sessions of the 72nd
21 Legislature.

22 Each member of the Senate shall certify in writing to the
23 Secretary of the Senate prior to the issuance of the first of
24 the warrants for each of the sessions of the 72nd Legislature
