
Notable State Documents 2008



It is intended to demonstrate the breadth of topics covered by government documents and to alert librarians to titles of value to citizens and researchers.

Agriculture

Until now, according to this report, there has only been anecdotal information about organic farm performance and profitability. The Organic Farm Business Management (FBM) Project changed all that by summarizing Minnesota organic farm performance data from 2006 and 2007.





Crime and Drugs

While the criminal justice system makes distinctions between types of crime and threat to society, criminal background check systems often don't. A person with a single misdemeanor conviction may face the same employment sanctions as someone with serious felony convictions. Even a minor criminal record can make it difficult for someone to rent an apartment, obtain a job, or get a required occupational license. Without a home or job, they are likelier to commit new crimes. This report offers policy recommendations for helping people reclaim their lives after minor brushes with the law.

This report examines the effects of Minnesota's law on those seeking employment in occupations licensed by the Minnesota Department of Human Services. It concludes that though well-intentioned, these changes may have had negative unintended consequences that have unfairly damaged good, qualified workers.

Environmental Health

Three recent reports give valuable background on hazardous materials in the news. Required by the Legislature, they outline the issues related to the dangers of these toxic chemicals and may lead to policy changes.


Education

Rising energy costs and the weakened economy are renewing interest in energy conservation. These two reports created by Minnesota government agencies provide information on this important topic.


